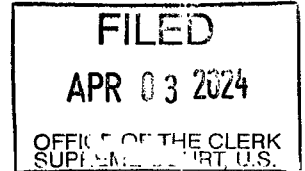

AFFIDAVIT IN SUPPORT OF MOTION FOR
LEAVE TO PROCEED IN FORMA PAUPERIS

I, Orin Kristich, am the petitioner in the above-entitled case. In support of my motion to proceed in forma pauperis, I state that because of my poverty I am unable to pay the costs of this case or to give security therefore; and I believe I am entitled to redress. The only major change regarding my income in the last 12 months is the loss of employment with food service due to being transfered because of programing. Further, I have had to pay a prisoner paralegal and typist for services in connection with this case, including the completion of this form. I have also had to pay for certified mail each time a motion did not reach the courts or I got a late reply from the court doubling the costs that I have to pay a typist, and making redress to the courts unconstitutional. In short the total expense with regards to this case around \$1000.00. I do have a plot of land and it's value is \$5000,00. I, have an average monthly expense of around \$150.00 for food, clothing, and hygiene. I, am bleesed to have a family that is willing to gift me the needed money to care for myself, as the B.O.P. does not care for the persons in it's custody. The B.O.P. has been given a general police power with out Due Process of law that has no penological interest other than to rise the costs of my right to redress, and block any form of relief in the appeal's process with regards to Mr.Kristich and his access to the courts.
