In January 2024, my wife's job ended as part of a company-wide reduction in force. As of April 2024 she still has not secured employment and is receiving only unemployment benefits for compensation. She is making effort to obtain employment, but has not yet been successful.

I have been on short term contracts off and on over the past few years. When I am under contract the pay is typically good, but my most recent full-time contract ended unexpectedly at the beginning of April 2024. This left both myself and my wife without full-time work. I am currently working a short-term, lower-wage contract for just 5-10 hours a week to help pay our monthly expenses until I can secure a full-time contract.

Our family of four is currently living off of the minimal amount we are able to receive from this part time work and unemployment benefits, as well as our quickly diminishing savings. We both do hope to secure full-time jobs in the coming months, however as we have yet to be successful and our deadline for filing this writ is quickly approaching we are unable to make the investment in filing, printing, and binding fees at this time.
