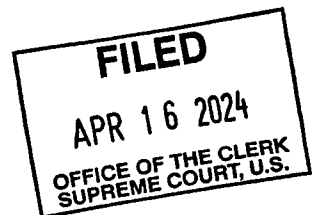

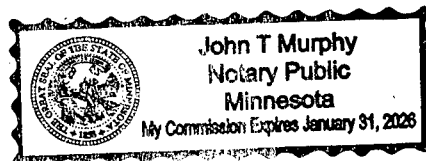

I know my body, and I also strongly believe that something was done to me by the last old man that slept in bed 1. His last day in bed 1 was 4-16-2024.

And they just put another old guy in bed 1. I have red mercury coming through my cough, and a headache out of the world.

This is one of the reasons that they want me in this shelter they pay the other homeless people to attack me in my sleep. I'd mailed out

the 1st 3 envelopes on 4-16-24, I believe I was over charged just so that I could not get all my document out.

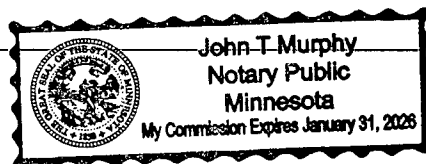
