9. ATTACHED

This writ, if granted will entitle petitioner to over \$125,322.87 plus interest. Due to Leon County Circuit court's failure to ensure petitioner's substantial due process right afforded by the Fourteenth Amendment. Providing Petitioner reasonable notice of final hearing.

Petitioner will gladly pay this Court's fees out of the money forfeited due to the Circuit Court's failure to acknowledge petitioner's due process protections. Petitioner was only afforded 16-hours notice when 30-days notice is required by Florida statutes and court rules.

Petitioners prison could not verify or have time to schedule video conference, and Leon County Circuit Court would not accept petitioner's pre-paid phone calls.

Leon County Circuit Court applied Florida statutes to Michigan's penal order awarding Respondent Ulmer \$262,225.55, where the total garnishment is \$226,661.65 (Attachment E).

\$101,338.78 is total restitution is owed, see MCL 780.766 and Michigan's sentencing order Attachment F does not include an award for interest. Michigan's criminal restitution is not a substitute for civil damage awards.

Florida Statutes treat criminal restitution orders as civil judgments. U.S.C.S. Const. Art IV §1 confer no new jurisdiction on courts of any state, and does not authorize them to take jurisdiction of suit or prosecution of such penal nature. Michigan Criminal Court orders cannot be changed by Florida's court rules or statutes.


