


The Court, after reviewing Judgment Creditor's Amended Motion for Final Judgment of Garnishment and Other Relief, based on the answer of Florida Department of Financial Services ("Garnishee") admitting indebtedness to the judgment debtor in the amount of \$226,661.65, and after hearing on this matter after proper notice having been given to all parties, and having reviewed and read the arguments of the judgment debtor and the judgment creditor, finds that:

IT IS HEREBY ADJUDGED:

Pursuant to the final judgment in this case, \$102,505.92 was adjudged against the judgment debtor as of July 31, 2001 in the State of Michigan, and began accruing interest under Michigan law. The Michigan judgment was domesticated in Florida on November 17, 2022. The domesticated judgment has an amount outstanding of \$262,225.55 as of January 31, 2023.

This Final Judgment of Garnishment is entered for the judgment creditor against the Garnishee in the amount of \$226,661.65. From that amount, the Garnishee is directed to pay itself \$700.00 and pay the remaining amount to Julian Ulmer, c/o Michael J. Farrar, P.A., 3508 NW 114th Ave. Suite 201, Doral FL 33178.


