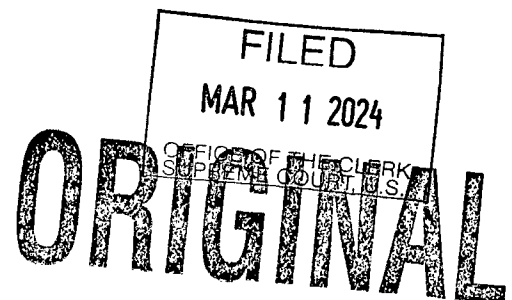

Questions Presented

- 1) Did the U.S. Appeals court abuse their discretion in it's delay and subsequent denial of Mandamus relief to Mr. Randall?
- 2) Does the newly decided precedence of this Court's Counterman v. Colorado, 600 U.S. 66 (2023) case, (in which this petitioner requested to be supplemented into his § 2241 Writ of Habeas Corpus) as a claim for relief, thru a motion to incorporate his parole appeal claim's PRIOR to ~~his~~ the U.S. Appeals ruling hold weight sufficient ~~to have~~ enough, that it should have urged the U.S. Appeals to act/respond FASTER and view the matter with more scrutiny against its holding for merit garnering Mr. Randall Habeas relief in his favor?
- 3) Does the Counterman v. Colorado, 600 U.S. 66 (2023) decision hold any retroactivity; further more, does it's First Amendment protection(s) cover/stretch to state administrative determinations for punishment such as a Pennsylvania Parole Board technical violation?

I, the petitioner, respectfully requests that this Court invoke its jurisdiction and authority under the United States Constitution and Human Bill of Rights entitlement to the Writ of Habeas Corpus thru the First Amendment's Freedom to petition onto the courts for redress of governmental grievance; as well as, the statutory invocation of jurisdiction under 28 U.S.C. § 1651 The All Writs Act; and also, 28 U.S.C. § 2254(b)(1)(B)(i) and 28 U.S.C. § 2254(b)(1)(B)(ii) due to EXTRAORDINARY CIRCUMSTANCES.

STATEMENT OF THE CASE (First person narrative)

I am Ramsey Randall aka Unique Danielz ~~z~~ (not listed alias) a self named CEO and multi-hyphenated entertainer of 25 plus years of musical performance experiences from the raising/upbringings in the city of Reading, Pennsylvania in Berks County. I created my own independent music label/musical production company named Hood Productions Music & Entertainment in 2003; and have used both stage name and company title on various media platforms up to today's date ranging from; MYSPACE & MYSPACEMUSIC in 2003 era of music, into 2023 two decades later, on Instagram and BandLab amongst the many I've chosen to use. See @uniquedanielz - Yet, I'm NO public celeb.

Unfortunately, I write to this Court as an incarcerated technical parole violator, being held in the custody of SCI-Greene of the Pennsylvania Department of Corrections for what the parole board determined to be "assaultive behavior using verbal threats of harm;" which ~~violate they~~ violated my conditions of parole; on a criminal conviction sentence of a cumulative term of (some form of) state supervision/custody for (6) sixteen years starting from the date of its arrest on May 15th, 2015; set to expire approximately July 28th, 2031. See Randall v. Comm., BCCCP CR-3823-2015 J. BARRETT

I have also since my arrest date, been in constant fear for my life, safety & well-being -- that of my close and immediate family's -- and numerous Hood Productions Members, affiliated artists, and business associates -- my loyal fans and supporters -- and the general public at large; because on that date I was nationally; and worse more...

Falsely labeled and depicted ~~in~~ the 2015 'OPERATION GUCCI' newscast and article stated to be; one of:

"...38 members of the group calls itself the Sixth Ward/ Northside Gang (who) wears the same tattoos, and spray-paints graffiti in their neighborhoods."

* NO suggestive terms were used such as: "alleged", "accused to be", "potentially known to", "possibly affiliated", etc. in the Prosecutor and News/Media company/ies' labeling statements in which I was included.

Aired on television on Fox News/ Channel 69 -- Rebecca Solomon
Article statement above printed in the Reading Eagle Newspaper's reporter Dan Kelly from direct iteration of DA John Adams Press Conference of the indictment. May 15th, 2015
searchable on Facebook and GOOGLE as of ~~Feb~~ February 5th, 2023.

And since that May 15th, 2015 national defamation of me; I've been the subject of: fights; and other physical and verbal assaults by inmates and prison/correctional guards and staff; verbally and physically harassed by inmates and prison/correctional guards and staff, threatened by ~~the~~ many of the actual GANGS at some point [that ~~is~~ a member of one of the "sets"/"flats" put me on notice that my life is and/or will be taken; OR I get the occasional invitation to join, many times over BOTH inside and outside of incarceration]. visited and questioned various times by Government Agents of the State's GANG TASK FORCE; and also, I get consistently told by institutional staff/administration and security officers as recently as February of 2024; that they have "no reason(s) to believe that being falsely labeled as a GANG MEMBER, places my personal safety and LIFE in danger or at risk inside or outside of prison." Albert, with a past officer of somewhat authoritative rank playing on my mental health diagnosis(es) told me I'm "delusional and schizo-paranoid" if I believe inmates will call/write home to have my case's sentence and arrest records looked up to verify my "status"... ALL of which has continually taken place in result of me defending myself and position of "Neutral"/no gang membership. (please SEAL bracketed point for my safety)

Please excuse my passionate rant just now... So, before I get too far ahead of ourselves, may I please take y'all back "down memory lane"; then, I'll catch us up, like a bottle of Heinz?

Thank you. Allow us to proceed.

In 2014, while incarcerated at Berks County Jail System (BCJS), I filed a §1983 Civil Rights Action in the U.S. District Court for Eastern PA citing claims of unconstitutional policies, and rules that I believed fell below the standards for conditions of confinement for pretrial detainees. See Randall v. Berk Co., et al; 14-5091 (EDPA) Within that filing, I had a jotted note/thought on a supporting exhibit, that investigatively on a criminal perspective, connected the §1983 respondents (BCJS, Berks Co. (township), Berks County Public Defenders and others) as an 'ORGANIZE CRIME' scheme. I think, I wrote the words "Corrupt Organization" at the top of the §1983 exhibit which I referred to.

After being released from that incarceration in November of 2014; I went to Berks County City Hall requesting witness protective custody, due to the belief I had acquired from the §1983 Action; that the city/county's police department (which employs a few BCJS guards) would "Michael Brown" me with a

retaliatory cover-up to silence my petition/§1983 from becoming public knowledge. The city hall staff denied my request; and from November 2014 to February of 2015 I began "couch surfing" to give ourselves a semblance of hiding from the city authority/lies, while remaining in okay standing on parole.

In February of 2015, I had my §1983 Motion to Dismiss hearing before Honorable Judge Stomsky in Phila, PA. At that hearing, no determination or decision on the merits of my claims was rendered.

On May 15th, 2015 I was arrested, via Grand Jury indictment by Berks County District Attorney John Adams; whom ^{at one time} was ~~once~~ my private attorney in 2003. In his indicting news press release, he made defamatory remarks, which were publicized in the national and local news media outlets. On that same date of my arrest, I was transported and placed into the custody of my §1983 respondents, BCJS. See Randall v. Comm of PA; CR-3823-2015

From approximately May 15th to May 28th the §1983 respondents BCJS subjected me to a number of, what I believe were retaliatory acts such as stealing legal notes related to both my civil case against them; and my

legal notes that I planned to file in a Petition of Habeas Corpus to attempt a ~~dismissal~~ dismissal of the criminal indictment, through suppressing the alleged statements I made to the affiant on the affidavit of probable cause, amongst other claims. This theft of my legal strategies was said to be, "from the District Attorney," yet, no search warrant nor Federal Court indemnity document was provided during said seizure.

I did file the appropriate inmate grievances, as well as, included claims in my Writ of Habeas Corpus with exhibits, that I subsequently submitted before my Preliminary Hearing requesting relief due to First Amendment violations under Due Process of the Fourteenth Amendment.

Between my arrest in May of 2015, up to the dismissal of my § 1983 Action against the Municipalities subordinate agencies and agents) respondents in August of 2015, I was subjected to a laundry list of what I call occurrences/events of "sabotage," relating to, and directly affecting my Preliminary and Petrial Proceedings, as well as, my rights as a Petitioner. The events range from numerous

instances of my legal mail and/or my access to use the law library being hindered, time restricted, or flat out denied; to my Preliminary Hearing and ~~at~~ my filed motions before it being unexplainably delayed, not docketed, and not appropriately given any judicial consideration^{ALL} without my consent; along with other questionable "unconstitutional" (read as oppressively and covertly), "sabotage." Meanwhile, throughout this time period, I did my best in filing letters, motions, and documentary evidences in support of my claims, that I was being subjected to; "foul play" types of retaliations at the hands of the §1983 respondents -- to the point of even petitioning multiple times for DEFAULT judgment due to the §1983's Due Process integrity being compromised. I plead my First Amendment right.

All those filings, motions, and pleadings on both state and federal levels were DENIED or never heard. I also, gave my best efforts in appealing the Federal Court denials. Those were DENIED by U.S. Appeals as well. (case history not cited from U.S. Appeals)

On December 22, 2015 at my Pretrial Hearing the Commonwealth prosecution of my criminal case dropped/ withdrew the leading indictment charges of 'corrupt Organization', 'dealing in illegal enterprise' and two

other charges, which were the correlating factors of the Commonwealth's indicting news release of my "GANG" MEMBERSHIP. Although those charges were part of my Pre-trial Writ of Habeas Corpus to be used as unsubstantiated garnering dismissal of the entire case; the Hearing proceeded with us being Pro Se; with a result of DENIAL of my case being dismissed ~~and~~ ^{for} multiple factors of Judge Barrett's opinion.

At no point in time did the Commonwealth's Prosecution nor Judge Barrett address the defamatory news release's content/context in consideration to my in-court claims to the Bench or my Habeas Corpus; offering no remedial options, name clearing hearing, nor press released recontation of the reputational damage ~~and~~ ^{to the} subsequent future harm(s) I would suffer.

Somewhere in time between the Aug/Sept. 2015 §1983 Federal denial; and the Dec. 22nd, 2015 State Pre-trial Hearing relief denial; I took my last Federal appellate attempt to this United States Supreme Court. Unsure of the type of filing needed, format, or rules, I submitted -- (if I remember correctly) a 142 page attempt at a Certiorari/Writ of Habeas Corpus; which was not given a formal hearing of review. See In Re: Ramsey Randall; No. 15-8558 (U.S. S.Ct.) rehearing denied 3.

In June of 2016, I was found guilty in my state court Criminal ~~trial~~ Bench Trial before Judge Barrett; in spite of my Pre-Trial and in-court pleading for dismissal of the case due to violations of my First Amendment since day one of my Criminal prosecution.

In between September 2016 to December 2016, I; in the midst of my direct appeal found 'newly discovered' evidence in the form of; the Issuing Authority District Magisterial Justice Timothy Dougherty was indicted and subsequently convicted for, improprieties in his judicial position; during the timeline he also consented to the issuance, and signed off on my arrest warrant affidavit of probable cause from the 'OPERATION GUCCI' indictment.

Somewhere also between September 2016 to December 2016 I was engaged in multiple self defense conflicts maintaining my neutrality against, [two; flag] gangs, individuals from Berks County, and numerous guards of [SCI-Grotonford]. [One in specific constantly addressed me as "GUCCI BITCH" or "GUCCI SNITCH" at his every passing opportunity;] ~~threatening~~ threatening my ability to exist in general population without added concerns. I was found to be in possession of a 'lock-in-a-sack' [After a behind-door-between-his-and-I confrontation, where he said to me, "he was going to go get my door popped, so we can handle this."] I spent over 80 days in the RHU. (please seal and non-disclose bracketed for my protection)

During my RHO time at SCI-Grotonford my Access to the Law resources to perfect my state appeal to the best of my ability was crippled; and subsequently led to its denial by the Superior Court of PA for "inartfully composed", with grammatical errors and not following document presentation formatting rules of the court.

I admit during that time frame, I was also intentionally on/off my psychotropic medication in resort to being mistreated by institutional staff and denied the ability to "fight my case" preventing my loss of appeal rights. And being off my medication, without any kind of treatment or therapeutic release; my intermittent explosive disorder bled into my court petition filings and I presented an unwelcomed "disrespectful" ranting; and not a court comprehensible appeal.

From 2017 to 2018, my case ~~is~~ history is dotted with me filing various Federal §1983 actions to be given fair review and relief to recount the defamatory news release of 'OPERATION GUCCI'. Those were denied and made to opinion that I held no merit, claim(s), grounds for relief etc.

In the beginning of 2018, I discovered Writ of Habeas Corpus statute §2254(b)(1)(B) finding its qualifications to be filed, exactly what my belief of my case history held.

REVERSE SIDE

Reading into many court decisions; yet, not finding a definitive U.S. Supreme Court precedent that describes with some specific detail(s) and/or historical case decision(s) as to; "what the LAW states is a qualifying "EXTRAORDINARY CIRCUMSTANCE(s)" which excuses state exhaustion;" and allows a petitioner to file their Writ to the available Federal Court of jurisdiction for prompt review; -- I filed My §2254 to the U.S. District Court for Eastern PA. (18-961 J. Hey); See attached R&R dated 12/8/23

Also, in 2018 I filed a Writ of Habeas Corpus to this Court, which was denied review. See In Re: Ramsey Randall; 18-2381 (U.S. S. Ct.); however, it could be a 2019 filing.

My §2254 Writ of Habeas Corpus' (18-961 (EDPA)) at this time period is as follows:

- §2254 filed by me
- §2254 responded to by respondent state (DA John Adams)
- §2254 USMJ Hey renders a STAY of Federal proceeding
- I appeal the stay to U.S. Appeals 3rd Cir. and get appointed counsel Federal Defender Joel Mandelman
- I discover this court's Lozman v. City of Riviera Beach (2018) decision and request counsel use Dombrowski Doctrine plus Lozman to submit challenge to U.S.M.J. Hey's STAY at US Appeals
- Federal Defender denies my requests and files his own argument which gets denied by U.S. Appeals
- U.S. Appeals orders remand to U.S. District for me to remand to State to file PCRA.

2019; COVID traumatized the world and stalls all court!

Between 2019 to late 2020; my state PCRA was derailed amongst extremely CDC laden legal mail, library and law library computer use access restrictions; my ability to phone call my Federal Defender for his feedback, aid, and advice on my case strategies were greatly minimized and time crippled; to my recollection I was unsuccessful in appealing my PCRA to the Superior Courts; I informed USMA Hey of my completed mandate ordered by the U.S. Appeals to attempt ~~all~~ allow the state an opportunity to correct the constitutional harms I claimed; and I was granted parole.

In March of 2021, I was released on parole under an Interstate Compact Contract to reside in North Carolina with my (sister/dunt) **Derona Tarr**. I made this decision to IMMEDIATELY leave Pennsylvania out of fear for my safety, life, and future; ~~as well as~~ in hopes to sustain a level of safety and protection, by being in a new area; bypassing the overwhelming concerns of returning to Berks County while I'm still falsely defamed in the news. And most importantly, I know that in order to protect the integrity/lives of my closest family, "friends", and business associates' lives; intentional exile and estrangement was going to be. **THEE** principled lifestyle that I will need to endure, to give myself the most assured controllable safeguards from any potential collateral mishaps/issues. This principle

isn't for JUST Bens County or Pecos/Lovato. It started out as ONLY in America. It's now a fear of my career as an entertainer touching different sectors of the world. An entertainer that's said to be a "GANG MEMBER" and a model of my hometown, which is galaxies from the truth.

My 82254 Habeas Corpus 18-961 was still pending upon my release at liberty on parole.

Where do WE start?

I'm not askin' y'all. That's what y'all been asking me. Well, more like-- me askin' myself, seven times over; since I've got in the car wit' Auntie; on March 10th, 2021; after doin' 6½ years of what I I I I iiii truly believe is, a Pennsylvania Governmental retaliatory "SHUT THE F-UP!" Mr. Randall." I mean; I'm just being released from my PA DOB State Institution Mahanoy.

And honestly, that's the crux of my multiple-personality disorder. Especially, in times like now; where I've binged OFF my Zoloft for the past week prior to gettin' out. My seven sides of me, are in an emotional bumper car crowd, givin' me a HUNDRED MILLION thoughts -- EACH... ALL AT ONCE.

Meanwhile, physically, I'm soaking up the fact that I've made it out ALIVE! Wit' all my faculties in tact, for the most part... excluding my mind; listening to her tell me her thoughts and expectations of me; me responding in kind; while staring at people driving w/ and w/o COVID masks; and altering clothes to get comfortable. Yet, and still, adjusting my posture, every 5 or 10 miles to allow me to see off Auntie's truck mirrors; assuring myself that we weren't being tailed by the same vehicle for too long. Was I being OVERLY paranoid after what I had been through in prison?

My collective intuitions say, "F*** NO!"

Freaky's, ready to unleash all the pent up libido on the first woman he sees. Krazy, is running around screaming FREE!; jonesin' for a cigarette and some REAL food; while following Freaky's EVERY visual path.

ANGRY, is silently stewing over being ready to snap out at a moment's notice on every and anyone... muttering that it's "All the Government's fault he's mad." Bunut-Out, is crying his eyes to bloodshot pleading for us to have ZERO participation with the general public of the world over; petrified out of his whits that someone's going to recognize him from the news and attack us UN-awares.

HOOD, has been relaxed; yet, highly frustrated he can't light a blunt and throw on the music to calm every body down so we can think straight; or at the least, more quietly, while he's rehearsing music and song lyrics.

Same, is simply sitting at the Head of the conference table, (on this particular day; cuz, he doesn't always lead the meetings), sipping a cup of coffee; ~~so~~ smoking a cigarette; observing the madness; and deducing it to the most appropriate, accurate, and prevelant thoughts).

This day, it was... "Where do I start?"

Ya see folks... the little bit of 'know how' I picked up from my mental health treatment groups plus some self-work helped me be better ~~equipped~~ to deal with myself; contrary to what PADOC staff might say. ^{?equipped?}

The PADOC; however, did a HORRENDOUS disservice in preparing me; or moreso, providing me with enough insight or resource information in my POST-COVID re-entry into society. Especially, since a large portion of the administrative/administration staff's tools and network is focused primarily ONLY on Pennsylvania; I would quickly find out that Criminal Justice Reform, Criminally Convicted Recidivism and Convicted Felon Re-Entry is NOWHERE CLOSE to being nationally programmatic. North Carolina and Pennsylvania are very, very unequal in the Re-Entering Felon Department.

"For crying out loud!" As some folks would exclaim while in frustration.

I've got MULTIPLE "TO DO" lists; split under two primary "TO DO" lists. We've got the "TOO MUCH TO DO" and "NOT ENOUGH TO DO" main lists. Then, those two have five separate "DO" lists: "MUST DO", "NEED TO DO", "SHOULD DO", "COULD DO", and "WANT TO DO." Not only is this a semi-organized, yet, helpful mindset ~~apart~~ by itself to stay focused on prioritizing my life's tasks... it also ~~is~~ pretty much been my principle thought pattern since I was diagnosed with 'Grave's Disease' in 2014 at BCJS while I being denied all my Pre-trial rights, stuck in an infirmary cell. Since the date I was informed that I had an incurable disease that raised my risk for potentially fatal medical surprises; like heart attacks or seizures to occur; albeit, randomly without warning -- also shortening my life expectancy due to it being an auto-immune disorder; an undeniable and ~~in~~ infallible 24/7 maximum effort intensity/level of urgency was instilled in me; driving me to possess a "kamikazee" subconscious in order ~~to do~~ "TO DO" whatever may be necessary to repair, cement, and protect my life's legacy; and accomplish all that it encompasses to give my nieces & nephews a source of generational wealth ^{from} and a name of good reputational standing... Not having any children of my own; and not being burdened with that responsibility; also, gives me "open road" to go to any part of the world to pursue all my desired endeavors with the same urgency.

Like Curtis "50 Cent" Jackson's famous motto said to the industry about his journey: I've got an altered version for my own...

I'm gonna; "GET VINDICATED AND ACHIEVE MY DREAMS OR DIE TRYING."

Real talk. #TRUTH

Driving past the "Welcome to North Carolina" sign, we were finally able to take a breathe of partial relief; because "GET OUT OF PA," was able to be crossed off all ten lists of things for me "TO DO"... RIGHT Behind the top goal.

Listen, I am unable to speak on another person's true feelings, only my own. So, when it comes to me being ANYWHERE in Pennsylvania; home or not; I've been subjected to, and have witnessed enough overtly oppressive experiences at the hands of their Government's corrupt abuses of power and usurpation of federal law. I am LITERALLY petrified of just the thought of being there. For the sake of visiting family, I'm gonna figure out HOW I can, without having to alert ANY PA authority I'll be crossing back into the state for however long.

I was literally LOSING, then FINDING my mind.

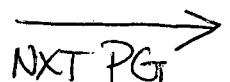
Thank you Aunt, for being an unreplaceable tour guide on my first two days out.

My plans were F.U.B.A.B.

I agreed to be outta the room, in my own apartment, with a lil' preowned whip, and building a new relationship with a female with more in common; while rebuilding my career. Things don't always go according to plan. And ours FELL APART. LITERALLY/like the '03 Mini Cooper I got for \$1K off Facebook Marketplace; that didn't even drive long enough to cross me back over the state line of Danville, WV -- into NC. Which, hammered in to the \$1500⁰⁰ outta the back pay Social Security gave me as an advance -- which cost me \$400⁰⁰ to tow. And that was WITH basic liability w/o roadside assistance.

I somehow ended up with Instagram (Facebook's sister company) suspending one of the usages I was permitted on the App. To date, I'm NOT 100% certain WHICH reel incited it; however, I'd bet the fact that either one/two/or all of them would IMMEDIATELY be tagged as R-rated commercials, (Still shots ONLY) was the -- THE REASON.

A FREE CONCERT by Urz Truly. TWICE. I had made the decision internally and after speaking with my love interest I would pursue figuring out how I could get a lawyer and skip the gifts.

I needed IMMEDIATE Access to File FOR EMERGENCY REVIEW/RELIEF. Feb 7th

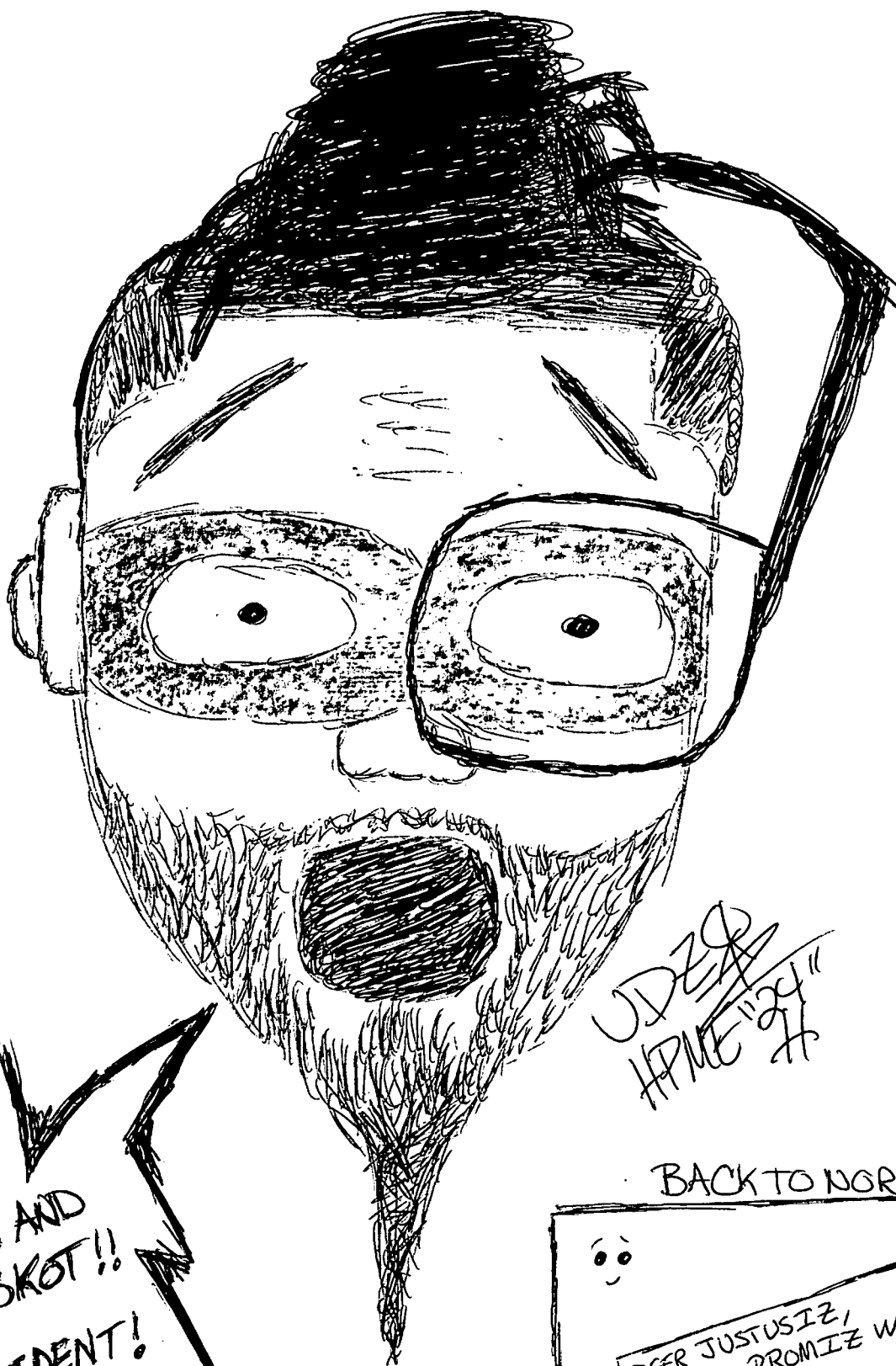

STATEMENT OF CASE AFTER THE ARREST (first person grammar)

I am currently a PADOA prisoner ~~currently~~ incarcerated at State Correctional Institution GREENE. In April 2023 I filed a petition for Writ of Habeas Corpus §2241 in the EASTERN District Court of PA (23-1389 USM JHE) claiming that my Due Process Rights were violated by the PA Board of Probation & Parole's (PBPP) failure to follow and abide by Morrissey v. Brewer; as well as PA Code 37 § 71.1, § 71.2. See RR SS 1-8.

I was given an untimely Preliminary Hearing, after being incarcerated (27) twenty seven days (approx.) without being served with any notification of charge(s) as to why I was arrested. Said Preliminary Hearing resulted in the aforementioned §2241 Writ of Habeas Corpus being filed by me. Arrested Feb 9th; hearing March 17th of 2023.

Between the filing of Habeas Corpus (23-1389) to May 9th 10th, 2023; I had been involved in a incident w/ correctional officers in which I was; assaulted multiple times, given a fabricated misconduct, and then subsequently convicted of it/sentenced to (90)

~~days~~ ninety days Disciplinary Confinement time on the Level-5 Restrictive Housing Unit (RHU) on May 12th, 2023. Out of fear for my life, and the assaulting guards I have remained on the Level-5 RHU; albeit, pleading to the Administrative staff of my fears and getting punished with misconducts for refusing to go to general population. (Grievance # 1036267 - Excessive Force Substantiated)

Please see attached exhibits R-1 & R-2. Note: The CORRECT amount of Level-5 Housing time IS from the R-2 2/29/24 Report.

I have in my attempts to receive aid from the FBI/DOJ, sent approximately (10) ten separate documents from my RHU Level-5 custody the various misconducts. 8/8/23 - 12/1/23

On May 26th, 2023 PBPP held my parole-revocation Hearing in which I was represented by Harry Cancellini, Jr. Esq. of Greene Co. Public Defenders as counsel. On June 6th, 2023 PBPP determined I violated my conditions 5C for assaultive behavior (verbal threats) and rescinded my SBA 422 automatic 6 month re-parole date. Then on June 14th, 2023 PBPP issued a second

Separate and subsequent violation sentence of (9) ~~NINE~~ months consecutive for the assaultive misconduct conviction resulting in DC/RHU confinement. Accordingly, I am currently scheduled to be seen by the Board May 2024.

On June 23, 2023 this United States Supreme Court rendered the Countermon v. Colorado, 600 U.S. 66, (2023) decision stating that, "the First Amendment precludes punishment, whether civil or criminal, unless the speaker's words were intended (not just likely) to produce imminent disorder."

On July 6th, 2023 Parole violation counsel Mr. Concelmi, Esq. filed two appropriate appeals to the Board; one contesting the parole revocation, the other, putting forth the claim that the second parole violation for the misconduct violated Due Process and was unfairly violated retroactively against me. He cited Countermon as a supporting case. See (10) ten page attached exhibits Esq. 1-10.

I submitted a motion requesting to supplement attorney Cancelmi's Administrative Appeals and brief as supporting my claim to USMJ Hey in the District Court (23-1389 EDPA); while also requesting immediate injunctive review for want of emergency relief; and, potential immediate release from incarceration due to a vacating of the parole violation. Said motion was filed to the District court approximately July 17th, 2023; with another requesting that she also review the misconduct itself for Due Process defect(s) in accordance to Wolff v. McDonnell, 418 U.S. 539 (1974) from this court. No hearing held.

In October of 2023, I filed a Writ of Mandamus to the U.S. Appeals court requesting they compel USMJ Hey in the District to take action on the various motions I filed that were stagnant. One of which was the aforementioned request to supplement and incorporate attorney Cancelmi's Administrative Appeal issues of Counter man combined with my own for injunctive relief. PBPP Denied Appeals on Aug 2023.

No court action was taken by the District or Appeals venues regarding the matter at hand from the date it was filed, to the courts up to date. Any notation or docket event(s) occurred without me ever getting any court order or decision to give me an opportunity to pursue an interlocutory appeal to this court. Actions took place Feb 8th & Feb 26th.

Anything contrary would be ^{an} action of defrauding the courts; thus, stripping me of my Due Process rights to contest respective court determinations using interlocutory appeals, certiorari, or habeas corpus.

Therefore, I bring forth this current ^{petition} ~~appeal~~ in light of the Appeals court's recent decision; as well as U.S.M.J. submitting her respective Report & Recommendations which are interwoven and inter-related in the case in point. Please refer to 18-961 (EDPA) and 23-1389 (EDPA).

I wholly contest all (3) three of ^{the} ~~these~~ recent rulings and believe that each one respectively exhibit abu-

Wherefore, I request this Writ of Habeas Corpus be granted for EMERGENCY INJUNCTIVE REVIEW within (48) ~~hours~~ forty-eight hours of receipt due to EXTRAORDINARY CIRCUMSTANCES surrounding ~~the~~ me and new controlling precedence set by Counterman v. Colorado which will benefit the future of the First Amendment's protection for its use by Judges, Attorney's or litigants on ~~at~~ Federal, State, Administrative, or other levels like a possible employment termination dispute over statement(s) made.

Clarification of the precedence under First Amendment protection(s) attributed were not mentioned in the application to a PAROLE VIOLATION specifically; therefore, this will expand NEW LAW and create new law/legislation/statutory language for individual state governments as well.

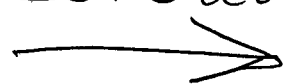
