ORDER

This matter came before the Court on Defendants Hanania Automotive, Jack Hanania, Sr., Cheryl Holyfield, Iron City Ford and Ralph Bohanan's Motion to Stay Action and Compel Arbitration. Defendant Ford Motor Company filed a Joinder to the Motion to Stay Action and Compel Arbitration.
