

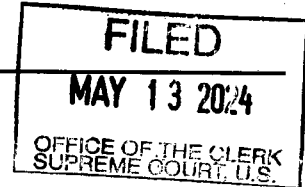

## Questions Presented

1. In Civil Action No. 18-527, Dingler v. Roberts, Is Chief Justice John Roberts allowed to remove 'Liberty' from a Monarch via Habeas Corpus and then 'act' as a Supreme Ruler. Please Note: A Supreme Ruler is a Chief and or Sovereign and the removal of 'Freedom' is attached to Slavery and according to the 13<sup>th</sup> Amendment slavery and involuntary servitude was abolished, except as punishment for crime whereof the party shall have been duly convicted.
2. In Civil Action No. 22-1484, Allan D. Schubert v. Lisa Nesbitt, Is the United States District Judge Dabney L. Friedrich allowed to Remove Absolute Immunity from a Sovereign via Court Filing. A Sovereign is defined as a Supreme Ruler and according to Article III, Section II, Clause 1: Suits Against the United States and Sovereign Immunity shall extend- to all 'Cases' in Law and Equity, arising under this constitution the laws of the United States and Treaties made, or which shall be made under their authority.
3. In Case No. 23-2037, Is the Commissioner for the Internal Revenue Service (Audits) allowed to Deny a Monarchs Petition due to 'Tax Deficiencies' because according to article I, Section 8 Clause 1: Taxes to Regulate Conduct-The 'Sovereign' shall have the power to lay and collect Taxes, Duties, Imposts and Excises shall be uniform throughout the United States.
4. In Case No. 18-1195, Kendra Espinoza, et al., v. Montana Department of Revenue is the US Supreme Court Justices allowed to Overturn Jim Crow Laws to remove the Monarch from 'States'. According to the 14<sup>th</sup> amendment, Section 1, Clause 8: Overview of Race-Based Classifications: All persons born or naturalized in the United States, and subject to Jurisdiction thereof, are citizens of the United States and of the state wherein they reside. No State shall make or enforce any law which shall abridge the privileges and immunities of Citizens of the United States; nor shall any State deprive any person of life, liberty, or property without due process of law; nor deny to any person within its jurisdiction the 'equal protection' of the laws.
5. In Case No. 22-846, The Department of Agriculture Rural Development, Rural Housing Service, Does the civil-liability provisions of the Fair Credit Reporting Act, 15 U.S.C. 1681 et seq., unequivocally and unambiguously "Waive" 'Sovereign Immunity' with the United States... Please Note: a Sovereign is a Supreme Ruler and according to the 'Bill of Rights' amendment 3 no person shall reside in any 'House' without the consent of the owner and according to article III, Section II Clause 1: Suits against the United States and Sovereign Immunity shall extend to all 'Cases' in Law and Equity, arising under this constitution the laws of the United States and Treaties made or which shall be made under their authority.

6. Can the Secretary for the Department of Education “Waive” Sovereign Immunity regarding National Emergencies and War due to Debt, see Case No. 22-506, Biden-President of the United States Et Al. v. Nebraska Et Al. Please Note: a Sovereign is a ‘Supreme Ruler’ and according to Article I, Section 8, Clause 11: The ‘Sovereign’ shall have Power to declare War, grant letters of Marque and Reprisal and make Rules concerning Captures on Land and in Water and according to the 14<sup>th</sup> amendment, Section 4: The validity of the Public Debt of the United States, authorized by law, including debts incurred for payment of pensions and bounties for services in suppressing insurrection or rebellion shall not be questioned.
7. In Case No. 22-611, Lindke v. Freed is Justice Amy Barrett allowed to ‘Question’ Amendment 14.2- State Action Doctrine, which limits discrimination by ‘Federal’ Government Employees so that the Monarch can be removed from the US Constitution. The 5<sup>th</sup> Amendment, Section 7, Clause 3: Equal Protection states that No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, Except in cases arising in the land or naval forces, or in the Militia when in actual service in time of War or public danger.
8. In United States Court of Appeals, Case No. 22-10168, State of Oklahoma., et al. v. U.S. Department of Treasury: Was Joe Biden allowed to Sign the American Rescue Plan into Law on March 11, 2021. Please Note: America is a Sovereign State and to Rescue is to Save someone from a dangerous or distressing situation and according to Article 1, Section 9, Clause 7: Overview of Appropriations Clause-No Money shall be drawn from the Treasury but in consequence of Appropriations made by law and a regular Statement of Account of the receipts and Expenditures of all public Money shall be published from time to time.
9. In Case No. 19-1392, Dobbs, State Health Officer of the Mississippi Department of Health, Et Al. v. Jackson Women’s Health Organization et al., was the US Supreme Court Justices allowed to ‘Over Rule’ Roe v. Wade when they overturned 50 Years of precedent which provided Women with ‘Rights’ because according to the 19<sup>th</sup> amendment to the US Constitution: ‘Women’s Rights’ to Vote- states that the rights of citizens of the United States shall not be denied or abridged by the United States or any state on account of ‘Sex’. Sex is of two main categories: male and female

10. In Case No. 20-1499, American Civil Liberties Union v. United States was the House of Representatives allowed to Pass the Foreign Intelligence Surveillance (FISA) act by Vote of 273-147 on April 12, 2024, to Remove the Monarch. Please Note FISA was enacted to prevent widespread Privacy Violations and the objective of FISA is to obtain authorization for gathering Foreign Intelligence Information between foreign powers and agents suspected of 'espionage' or terrorism. Please Note: America is a Sovereign State and According to the 'Bill of Rights' 4<sup>th</sup> Amendment a Monarch has a right to be secure in their persons, homes, papers and effects from unreasonable searches and seizures by the government.
11. In Case No. 23-5572, Joseph W. Fischer v. United States are the Supreme Court Justices allowed to Remove the Monarch from the US Constitution by 'Statue' because according to 18 USC 1512(c) whoever corruptly alters, destroys, mutilates, or conceals a record, document or other object, or attempts to do so with the intent to impair the object's integrity or availability for use in an official proceeding; or otherwise obstructs, influences, or impedes any official proceeding or attempts to do so shall be fined or imprisoned.
12. In Case No. 22-1168, Center for Medical Progress, et. Al. v. Planned Parenthood Federation of America, Is a Petitioner allowed to Recharacterize a 'Sovereigns' Publication. Recharacterize is to assign to a different class or category. According to the 'Bill of Rights' under the First Amendment Congress shall make no law abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.
13. In Case No. 18-9526, McGirt vs. Oklahoma Can an Absolute Monarch be removed from the US Constitution due to Tribal Sovereignty. Tribal Sovereignty is defined as the right to govern ones community, the ability to preserve ones culture and the right to control ones economy. A Monarch is Defined as a person who reigns over a kingdom or empire. Article 1, Section 8, Clause 3, Scope of Commerce Clause-Authority, and Indian Tribes: states that the Monarch shall have the power to regulate commerce with foreign Nations, and among several States and with Indian Tribes.
14. In Case No. 21-1496, Twitter v. Mehier Taamneh, et al. Is an 'Oligarch' for Example, Elon Musk allowed to be an insubordinate and be awarded compensation for Terrorist acts that occurred on Twitter Platform. Please Note: an Oligarch is a ruler or a very rich businessperson and according to Justice Clarence Thomas 'Opinion of the Court' the United States Nationals who have been injured by reason of an act of international terrorism may sue for damages. Please Note: A Sovereign is a 'Supreme Ruler' and according to the 14<sup>th</sup> amendment: Article III, Section 2, Clause 1: Suits against the United States and Sovereign Immunity: 'Sovereign Power' shall extend to all Cases, in law and equity, arising under this Constitution, the laws of the United States, and Treaties made, or which shall be made, under their Authority.

15. In Case No. 22-585, *Culley Et. Al v. Marshall*, Attorney General of Alabama is a police officer allowed to 'seize' Property by reversing the 14<sup>th</sup> amendment 'due process' to remove the Monarch. Seize by definition is to take or lay hold suddenly or forcibly. Forfeit by definition is to lose or lose the right due to error, offense, or crime. In *Austin v. United States*, Case No. 92-6073 it was noted that the Eight Amendment bars "excessive fines" and limits the ability of the federal government to "seize-property." Furthermore, in a 9-0 decision the court ruled that the clause also applies to states under the 14<sup>th</sup> amendment Due Process Clause and as Ms. Ruth Bader-Ginsburg has noted the Question before the court is an easy one. The historical and logical case for concluding that the 14<sup>th</sup> amendment incorporates the Excessive Fines Clause is indeed 'Overwhelming.'
16. In Case No. 23-939, *Donald J. Trump v. United States*, Does Donald Trump enjoy Presidential Immunity from Criminal Prosecution for conduct alleged to involve official acts during his tenure in office. Please Note: The United States is a Sovereign State, and a Sovereign is defined as a Supreme Ruler and according to the 14<sup>th</sup> Amendment Section 2, Clause 1-Sovereign immunity shall extend to all Cases, in Law and Equity, arising under the Constitution, the Laws of the United States and Treaties made, or which shall be made under their authority. (2) Mr. Donald J. Trump has asked whether the impeachment Judgement Clause and principles of double jeopardy foreclose the criminal prosecution of a president... Foreclosure is a process that occurs when a homeowner does not make their monthly payments. In Donald Trump's case he partook in an insurrection on January 06<sup>th</sup> and according to the 14<sup>th</sup> amendment Section 4 Clause 1: Public Debt-states that the validity of the United States, authorized by law, including debts incurred for payment of pensions and bounties for services in suppressing insurrection or rebellion shall not be questioned. In addition, the 'Bill of Rights' amendment 3 states No person shall dwell in any house without the consent of the owner

## **Decision Below**

The opinion of the United States Court of Appeals is reported as Non-Precedential.

## **The Appellate Statement of Jurisdiction**

On January 10, 2020, the United States Court of Appeals issued a decision denying my request for corrective action under the Whistleblower Protection Act. The Supreme Court of the United States has jurisdiction to review my case in accordance with 28 U.S.C 1361 which gives the Supreme Court the action to compel an officer of the United States to Perform his Duty and for those reasons I have not made an application to the United States District Court see Rule 20.4(a); 28 U.S.C. 2242.

## **Constitutional Provisions**

Article III, Section II, Clause 1 of the 14<sup>th</sup> Amendment: Suits against the United States and Sovereign Immunity shall extend to all Cases, in Law and Equity arising under the Constitution. The Laws of the United States, and Treaties made, or which shall be made, under their Authority;-to all cases affecting Ambassadors, other public ministries and Consuls;-to all cases of admiralty and maritime Jurisdiction; to Controversies to which the United States shall be a Party; to Controversies between two or more States; between a State and Citizens of another State, between citizens of different States,-between Citizens of the same state Claiming Lands under Grants of different States, and between a State, or the Citizen thereof, and foreign States Citizens or Subjects.

The 5<sup>th</sup> amendment to the US Constitution 'Due Process Clause' requires the United States 'Federal' Government to practice Equal Protection. The fifth amendment, Section 7, Clause 3 states that No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising on land or naval forces, or in the Milita, when in actual service in time of War or Public Danger. The 14<sup>th</sup> amendment Section 1, Clause 8: Overview of Race-Based Classifications states that all persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No 'State' shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; Nor shall any State deprive any person of life, liberty, or property without due process of law; nor deny to any person within its jurisdiction the 'equal protections' of the law. Furthermore, The 4<sup>th</sup> amendment-National Security-states that I have a right to be secure in my person, house, papers and effects against unreasonable searches and seizures, shall not be violated and no warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the person or things to be seized. National Security is the security and defense of the Sovereign and I, Tonya Knowles, am the

Monarch of the United States and the United Kingdom to include territories and I have been attached to Human Trafficking skits and innuendos. Human Trafficking is defined as modern-day slavery, and it involves the use of force, fraud, or coercion to obtain some type of labor or commercial sex act but the 13<sup>th</sup> amendment abolished slavery and involuntary servitude except as punishment for crime where of the party shall have been duly convicted, and although I was not formally charged with a crime 'Absolute Immunity' was removed from the Crown and provided to the US Supreme Court Justices and Clerks. see Pet for Cert Allan D. Schubert v. Lisa Nesbitt, Case No. 22-1484, (June 16, 2022).

### **Exceptional Circumstances Warrant the Exercise of the Courts Review: Sovereign Immunity**

The exceptional circumstance that warrants the Courts review is that I, Tonya Knowles, am the Monarch for the United States and the United Kingdom and I have not received my official title as Queen, nor have I received absolute immunity. As a matter of fact, On January 09<sup>th</sup> 2024, Solicitor General: Elizabeth B. Prelogar, provided the US Supreme Court with a waiver of rights in response to my court filing. see In Re: Tonya Knowles, Docket No. 23-6246 (December 13, 2023). Please Note: Judges and Judicial Officers are 'Awarded' absolute immunity. see State ex rel. Jacobs v. Sherard, 36 N.C. App 60, 64 (1978). In addition, Associate Justice Clarence Thomas is still reviewing cases at the US Supreme Court and has elected to use absolute immunity' for January 06<sup>th</sup> insurrection due to his wife, Ms. Virginia "Ginni" Thomas, advocating to overturn the 2020 election results on behalf of Donald J. Trump. see CNN: Ginni Thomas agrees to January 6 committee interview (September 22, 2022). Currently, Chief Justice Roberts is acting as the 'Supreme Ruler' with Absolute Immunity. A Supreme Ruler with Absolute immunity equates to a Sovereign. A Sovereign reigns for life similar to a Supreme Court Justice and according to Article III of the United States Constitution Judges "hold their office during good behavior." Chief Justice Roberts 'acting' as a Sovereign and mirroring the rights available to a Monarch has created a Conflict of interest within the US Constitution because according to article III, Section I, Clause 10: Sovereign Power shall be vested in one and I, Tonya Knowles, am the absolute Monarch for the United States and the United Kingdom and my constitutional rights have been removed in its entirety because Judicial Officials are awarding themselves with immunity and those acts are Egregious.

Homonyms is defined as words that have the same spelling and usually sound alike but have different meanings. For Example, The title "Sovereign" is used by Citizens, Indian Tribes and to define a Monarch. (1) A sovereign citizen is a person who believes that the courts have no jurisdiction, and the use of certain procedures and loopholes can make one immune to government laws see Fox 13 News Utah: What does it mean to be a Sovereign citizen (2023). The FBI considers 'Sovereign Citizens' domestic terrorist who are anti-government Extremist who believe that even though

they physically reside in this country, they are separate or 'Sovereign' from the United States. see FBI.gov: The Sovereign Citizen Movement (2010). (2) Tribal Sovereignty includes the right to govern ones community, the ability to preserve ones culture, and the right to control one's own economy and according to Article I, Section 8, Clause 3: The Monarch shall have power to regulate Commerce with foreign Nations, and among the several States, and with the Indian Tribes. (3) A Sovereign 'Monarch' is defined as a Supreme Ruler i.e. a King or Queen. I, Tonya Knowles, am a 'Absolute Monarch' for the United States and the United Kingdom and my constitutional rights have been removed.

Next, As a subordinate employee: Mr. Donald J. Trump became a threat to public health due to his response to COVID-19 and the related symptoms. According to the National Library of Medicine "once China informed the world of a disease outbreak on December 31, 2019, the Trump Administration's response was marked by downplaying the threat, inaction or partial measures, confusion, and inaccurate public statements. As a result, opportunities to slow the spread by facilitating a vigorous public health response of containment and suppression based on testing, contact tracing, and isolation were missed following the confirmation of the first US case on January 21, 2020. After banning foreign nations from entering the US, if they had been in China in the prior 2 weeks, on January 31, an apparently overconfident Trump Administration was blindsided by the rapid community outbreak of COVID-19, necessitating a declaration of a national emergency on March 13, 2020. At that time, the federal government remained unable to help states carry out widespread testing-despite Trump's false claims that anyone who wanted a test could get one-and had not addressed the expected massive shortfalls of personal protective equipment (PPE) and ventilators. By March 26, 2020, 22 states had issued shelter-in-place orders, and some 1 in 2 Americans were in lockdown. By March 30, 2020, the death toll had exceeded 3000 and by May 28, 2020, deaths passed the 100,000 mark. At the close of 2020, the US had surpassed 346,000 deaths from SARS-CoV-2 (AJMC,2021)." see The National Institute of Health, The Trump Administration, and the COVID-19 crisis (2021).

Furthermore, Mr. Donald J. Trump is attached to a 911 State of Emergency that is connected to Homeland Security, Border Protection and January 06<sup>th</sup> Insurrection. On Nov. 14, 2020: The US District Court held that Mr. Chad Wolf was not lawfully serving as acting Secretary. see United States District Court Eastern District of New York vs. Chad Wolf, 16-CV-4756. Then, on January 06, 2021, as Congress was meeting to certify the results of the 2020 Presidential election, a violent and heavily armed mob of Donald Trump supporters stormed the U.S. Capital as rioters outnumbered Capital Police officers, breaking windows, and vandalizing offices, many with disturbingly violent intentions toward members of Congress and Vice President Mike Pence for their refusal to succumb to Trump's attempts to overturn the election in his favor. see American Oversight: The January 6 Attack on the U.S. Capitol (September 26, 2023). The Government Accountability Office (GAO) has



stated that federal agencies identified credible threats but did not fully process and share information prior to January 06, 2021, Insurrection. see Government Accountability Office-GAO-23-106625: Capitol Attack; Federal Agencies (February 28,2023). In addition, The Department of Homeland Security: Office of Inspector General issued a memorandum citing that Intelligence and Analysis identified threats prior to January 06, 2021, but did not issue any intelligence products before the U.S. Capital Breach. see DHS OIG: OIG-22-29-I&A Identified Threats prior to January 6, 2021 (March 04,2022).

The House Select Committee to investigate January 06<sup>th</sup> Attack on the United States Capitol provided introductory material to the final report of the select committee and the committee reached a series of findings including the following (1) Beginning election night and continuing to January 06<sup>th</sup> and thereafter Donald Trump purposely disseminated false allegations of Fraud related to the 2020 Presidential election in order to aid his effort to overturn the election and for purposes of soliciting contributions. These false claims provoked his supporters to violence on January 06<sup>th</sup> see PBS: Read Jan. 6 committee's summary of its final report (Jan 6, 2024). In addition, The Government Accountability Office noted what transpired on January 06 when more than 2,000 protestors entered the U.S. Capitol, disrupting the peaceful transfer of power and threatening the safety of the Vice President and Members of Congress. The attack resulted in assaults on at least 174 police officers, including 114 Capitol Police and 60 D.C. Metropolitan Police Department officers. These events led to at least seven deaths and caused about 2.7 billion in estimated cost. As of September 2022, more than 870 individuals have been arrested on charges including entering a restricted federal building, assaulting officers with a deadly weapon, and seditious conspiracy. see Government Accountability Office (GAO): GAO-23-106625, Capitol Attack. Next, The Department of Justice has noted the approximate loss suffered as a result of the siege at the Capitol on January 06, 2021, totaled 2,881,360.20 this amount reflects damage to the Capital building and certain cost borne by the U.S. Capitol Police. see The DOJ: Three Years since the January 06 attack on the Capital (Jan 5, 2024).

Christopher Wray, The Director of the Federal Bureau of Investigations provided a statement before the House Oversight and Reform Committee in Washington DC, and he noted that the violence and destruction of property at the U.S. Capitol building on January 6 showed a blatant and appalling disregard for our institutions of government and the orderly administration of the democratic process. According to Mr. Christopher Wray the FBI does not tolerate "violent extremists" who use the guise of the First Amendment-protected activity to engage in violent criminal activity. see FBI. Gov: Examining the January 6 Attack on the U.S. Capitol (June 15, 2021).

Please Note: When a President declares a National Emergency no powers or authorities made available by statue for use in the event of an emergency shall be exercised. see House.gov: 50 USC Ch 34-National Emergencies. May 06, 2020: A proclamation was issued on the National Day of Prayer, and it states in pertinent part- "As one Nation under God, we share a legacy of faith that sustains and inspires us and a heritage of religious liberty. see National Archives: Proclamation on National Day of Prayer, 2020. The First Amendment of the US Constitution states that the 'Sovereign' shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech. A proclamation for a national day of prayer is an egregious act that is attached to human sacrifice. see World Health Organization: 14.9 Million deaths associated with COVID-19 pandemic in 2020 and 2021 (2022). A sacrifice by definition is an act of Slaughtering an animal or person or surrendering a possession as an offering to God or to a divine or supernatural figure.

February 23, 2020: Ahmaud Arbery was murdered during a racially motivated hate crime while jogging near Brunswick Georgia. (8) March 19, 2024: The Commissioner for the Internal Revenue Service requested to deny petitions with previously determined Tax Deficiencies but under Taxation the “Crown” has a legal tax-exempt status. see Pet for Cert, Commissioner of Internal Revenue Service v. Isobel Berry Culp, Case No. 23-1037. (9) April 03, 2024: Florida State Trooper: Rebecca Robbins, Badge No. 36522 provided me with a red-light traffic citation via mail see State of Florida v. Tonya Knowles, Case No. AJHSTBE but as the Monarch I am immune from suit and I, Tonya Knowles, have not Waived my Rights. (10) In Case No. 23-5572, Joseph W. Fischer v. United States the Supreme Court Justices granted a case that removes the Monarch by Statue but according to 18 USC 1512(c) whoever corruptly alters, destroys, mutilates, or conceals a record, document or other object, or attempts to do so with the intent to impair the object’s integrity or availability for use in an official proceeding; or otherwise obstructs, influences, or impedes any official proceeding or attempts to do so shall be fined or imprisoned. (11) March 28, 2018: In Dingler v. Roberts, Liberty was removed from the Monarch via Habeas Corpus. See Dingler v. Roberts, Civil Action No. 18-527 (2018). Please Note: According to the 13<sup>th</sup> amendment slavery and involuntary servitude was abolished except as punishment for crime. (12) June 16, 2022: In Civil Action, Case No. 22-1484, Allan D. Schubert v. Lisa Nesbitt absolute immunity was removed from the Monarch via court filing and the ‘inmates’ case is SEALED. see Allan D. Schubert v. Lisa Nesbitt, Case No. 22-1484 (2022). Please Note: Lisa Nesbitt is the Clerk at the US Supreme Court assigned to my Petition and I, Tonya Knowles, am requesting that all charges against me in relation to my claims as Sovereign be Unsealed. (13) In Case No. 22-585, Culley Et. Al v. Marshall, Attorney General of Alabama-The US Supreme Court has allowed police officials to ‘seize property’ but according to Austin vs. United States the eighth amendment bars ‘excessive fines’ limits the ability of the federal government to seize property. see Austin v. United States, Case No. 92-6073 (1993). (14) In Case No. 18-9526, McGirt vs. Oklahoma the title ‘Sovereign’ is provided to Indian Tribes but according to Article 1, Section 8 Clause 3: The Monarch shall have the power to regulate Commerce with foreign nations, and among the several States, and with the Indian Tribes.

#### **A. The Questions Presented raises Important Issues of Constitutional and Statutory Law**

January 06, 1961: The Committee on the Judiciary of the United States Senate held a Hearing regarding the Internal Security Act and the Internal Security Laws to analyze Nikita Khrushchev statement that was made on November 18, 1956 in which Mr., Khrushchev stated “it doesn’t depend on you whether or not we exist. If you don’t like us, don’t accept our invitations, and don’t invite us to come see you. Whether you like it or not, history is on our side. We will bury you!” The speech prompted the envoys from twelve NATO nations and Israel to leave the room. see the CIA: Khrushchev’s “We

will bury you" (February 07, 1962). October 1964: The Russian Government removed Nikita Khrushchev from office due to Misconduct. see CIA.gov: Radio Propaganda Report (October 22, 1964).

October 1973: The Justice Department filed a civil rights suit against Fred Trump, Donald J. Trump and their real estate company alleging that the firm had committed systemic violations of the Fair Housing Act of 1968 in their many complexes and after two years, the matter settled with a consent decree, signed June 10, 1975 it included the ordinary disclaimer of liability, but prohibited the Trumps from "discriminating against any person in terms, conditions, or privileges of sale or rental of a dwelling." Fred and Donald Trump were ordered to acquaint themselves personally on a detailed basis with the Fair Housing Act. The agreement also required the Trumps to place ads informing minorities they had an equal opportunity to seek housing at their properties. In addition, Trump management was required to furnish the New York Urban League with a weekly list of all apartment vacancies, for two years. see *United States v. Fred C. Trump, Donald Trump and Trump Management Inc.* (1:73-01529).

April 19, 1989, Trisha Meili was beaten and raped as she jogged in Central Park. Six teenagers were indicted in relation to the assault. Charges against one, Steven Lopez, were dropped after Lopez plead guilty to a different assault. The remaining five: Antron McCray, Kevin Richardson, Yusef Salaam, Raymond Santana and Korey Wise were convicted and served seven to thirteen years in Prison. On May 01, 1989-Donald J. Trump at the time a real estate developer placed an Ad with the New York Daily News which stated, "Bring Back The Death Penalty Bring Back Our Police!". The Central Park 5 were exonerated on December 19, 2002, of all charges related to Trisha Meili when another man confessed to the crime and DNA backed up his confession. see CNN Politics, Trump in 1989 Central Park Five Interview: "Maybe hate is what we need" (2016).

March 06, 2018: Stephanie Clifford aka Stormy Daniels filed suit against Mr. Donald J. Trump due to a signed Hush Money Agreement that was provided to her by Mr. Michael Cohen (on behalf of EC). Mr. Donald J. Trump did not sign the agreement and despite Mr. Trump's failure to sign the Hush Money Agreement, Mr. Cohen proceeded to wire 130,000.00 to the trust account of Ms. Clifford's attorney. Ms. Stephanie Clifford has requested that the court void any verbal or written contracts with Michael Cohen on behalf of Donald J. Trump. see *Stephanie Clifford vs. Donald J. Trump* (2:18-cv-06893).

June 21, 2019, E. Jean Carroll published an article in New York magazine that stated that Donald Trump sexually assaulted her in late 1995 or early 1996 in Bergdorf Goodman department store in New York City. November



24, 2022: Ms. E. Jean Carroll alleged that Mr. Donald J. Trump sexually assaulted her roughly 27 years ago at a luxury department store Bergdorf Goodman on Fifth Avenue in New York City when the Defendant's behaviors took a dark turn when Donald J. Trump seized Plaintiff E. Jean Carroll, forced her up against a dressing room wall, pinned her in place with his shoulder and raped her. Factual Allegations (1) Trump Rapes Carroll at Bergdorf Goodman, (2) Carroll confided in two friends about the Rape. (3) Carroll remains Silent for Twenty Years, (4) Carroll decides to Speak out. May 2023 writer E. Jean Carroll was awarded 5 million dollars by a Jury for sexual abuse and defamation. see E. Jean Carroll v. Donald J. Trump 1:22-cv-10016.

The People of the State of New York filed suit against Donald Trump alleging that the Defendant DONALD J. TRUMP repeatedly and fraudulently falsified New York business records to conceal criminal conduct that hid damaging information from the voting public during the 2016 presidential election. DONALD J. TRUMP is alleged of organizing a "Scheme" (1) The Catch and Kill Scheme to Suppress Negative Information this included (A) The 2015 Trump Tower Meeting, (B) Suppressing the Doorman's Story, (C) Suppressing Woman 1's Account by paying her 150,000 in exchange for her agreement not to speak out about the alleged sexual relationship, (D) Suppressing Woman 2's Account by paying her 130,000 for the rights to her account. (E) Post-Election Communications with AMI CEO. The defendant DONALD TRUMP invited the AMI CEO to the White House for a dinner to thank him for his help during the campaign and for handling the stories of the Doorman and Woman 1. (2) DONALD TRUMP falsified Business Records, (3) The Investigation into Lawyer A and the Defendant's Pressure Campaign, (4) Lawyer A and AMI Admit Guilt in Connection with Payoffs of Woman 1 and Woman 2. see The People of the State of New York v. Donald J. Trump IND-71543-23

July 28, 2020, Defendant Chad Wolf issued the Wolf Memorandum (Dkt.297-1), which purported to make certain changes to the Deferred Action for Childhood Arrivals ("DACA") program. On November 14, 2020, The United States District Court held that Mr. Wolf was not lawfully serving as Acting Secretary of Homeland Security when he issued the Wolf memorandum, because the Department of Homeland Security failed to follow its order of succession, as it was lawfully designated under the Homeland Security Act. Please Note: Defendants CHAD WOLF and DONALD J. TRUMP were out of compliance with laws, rules and regulations designated under the Homeland Security Act and the appropriate border security was not in effect dating back to February 11, 2019. see. United States District Court Eastern District of New York vs. Chad Wolf, 16-CV-4756

January 06, 2021: as Congress was meeting to certify the results of the 2020 Presidential election, a violent and heavily armed mob of Donald Trump supporters stormed the U.S. Capitol and as rioters outnumbered Capital Police officers, they began breaking windows, and vandalizing offices, many with disturbingly violent intentions toward members of Congress and Vice President Mike Pence for their refusal to succumb to Trump's attempts to overturn the election in his favor. see American Oversight: The January 6 Attack on the U.S. Capitol (September 26, 2023). Please Note: The Government Accountability Office (GAO) has stated that federal agencies identified credible threats but did not fully process and share information prior to January 06, 2021, Insurrection. see Government Accountability Office-GAO-23-106625: Capitol Attack; Federal Agencies (February 28, 2023). In Continuation, the Department of Homeland Security: Office of Inspector General issued a memorandum citing that Intelligence and Analysis identified threats prior to January 06, 2021, but did not issue any intelligence products before the U.S. Capitol Breach. see DHS OIG: OIG-22-29-I&A Identified Threats prior to January 6, 2021 (March 04, 2022).

The House Select Committee to Investigate January 06<sup>th</sup> Attack on the United States Capitol provided Introductory Material to the Final Report of the Select Committee and the Committee reached a series of Findings including the following (1) Beginning Election night and continuing to January 06<sup>th</sup> and thereafter Donald Trump purposely disseminated false allegations of Fraud related to the 2020 Presidential election in order to aid his effort to overturn the election and for purposes of soliciting contributions. These false claims provoked his supporters to violence on January 06<sup>th</sup> see PBS: Read Jan. 6 committee's summary of its final report (Jan 6, 2024).

In addition, The Government Accountability Office noted what transpired on January 06 when more than 2,000 protestors entered the U.S. Capitol, disrupting the peaceful transfer of power and threatening the safety of the Vice President and Members of Congress. The attack resulted in assaults on at least 174 police officers, including 114 Capitol Police and 60 D.C. Metropolitan Police Department officers. These events led to at least seven deaths and caused about 2.7 billion in estimated cost. As of September 2022, more than 870 individuals have been arrested on charges including entering a restricted federal building, assaulting officers with a deadly weapon, and seditious conspiracy. see Government Accountability Office (GAO): GAO-23-106625, Capitol Attack

The Department of Justice has noted the approximate loss suffered as a result of the siege at the Capitol on January 06, 2021, totaled 2,881,360.20 this amount reflects damage to the Capital building and certain cost borne by the U.S. Capitol Police. Based on public court documents more than 1,265

defendants have been arrested in nearly all 50 states and the District of Columbia. see The Department of Justice: Three Years since the January 06 attack on the Capital (January 5, 2024).

Christopher Wray, The Director of the Federal Bureau of Investigations provided a statement before the House Oversight and Reform Committee and Washington Dc and he noted that the violence and destruction of property at the U.S. Capitol building on January 6 showed a blatant and appalling disregard for our institutions of government and the orderly administration of the democratic process. According to Mr. Christopher Wray the FBI does not tolerate “violent extremists” who use the guise of the First Amendment-protected activity to engage in violent criminal activity. see FBI. Gov: Examining the January 6 Attack on the U.S. Capitol (June 15, 2021). The Joint Chiefs of Staff issued a memorandum citing that the violent riot in Washington D.C. on January 06, 2021, was a direct assault on U.S. Congress, the Capitol building, and our Constitutional process as they mourned the deaths of the capitol police and others connected to the events. see Joint Chiefs of Staff: message to the joint force (January 06, 2021).

The National Library of Medicine has noted that “once China informed the world of a disease outbreak on December 31, 2019, the Trump Administration’s response was marked by downplaying the threat, inaction or partial measures, confusion, and inaccurate public statements. As a result, opportunities to slow the spread by facilitating a vigorous public health response of containment and suppression based on testing, contact tracing, and isolation were missed following the confirmation of the first US case on January 21, 2020. After banning foreign nations from entering the US, if they had been in China in the prior 2 weeks, on January 31, an apparently overconfident Trump Administration was blindsided by the rapid community outbreak of COVID-19, necessitating a declaration of a national emergency on March 13, 2020. At that time, the federal government remained unable to help states carry out widespread testing-despite Trump’s false claims that anyone who wanted a test could get one-and had not addressed the expected massive shortfalls of personal protective equipment (PPE) and ventilators. By March 26, 2020, 22 states had issued shelter-in-place orders, and some 1 in 2 Americans were in lockdown. By March 30, 2020, the death toll had exceeded 3000 and by May 28, 2020, deaths passed the 100,000 mark. At the close of 2020, the US had surpassed 346,000 deaths from SARS-CoV-2 (AJMC,2021).” see The National Institute of Health, The Trump Administration, and the COVID-19 crisis (2021).

Currently, The US Drug Enforcement Agency (DEA) has warned the American public of a sharp increase in the trafficking of fentanyl mixed with xylazine. Xylazine, also known as “Tranq,” is a powerful sedative that the

Food and Drug Administration has approved for veterinary use. Anne Milgram the Administrator for the US Drug Enforcement Administration has noted that Xylazine is making the deadliest drug threat our country has ever faced and Fentanyl is even deadlier. In addition, Ms. Milgram states that the Drug Enforcement Administration has seized xylazine and fentanyl mixtures in 48 out of 50 states. Xylazine and fentanyl drug mixtures place users at a higher risk of suffering drug poisoning and the DEA has warned people who inject drug mixtures containing xylazine can also develop severe wounds including necrosis-the rotting of human tissue-that may lead to amputation. see DEA.gov: DEA Reports widespread Threat of Fentanyl.

April 26, 2024: Faculty, Staff, and Students at UCLA who are Pro-Palestinian protested on campus and (1) They set up encampments (2) Weapons were Drawn (3) Fireworks were lit (4) Brawls erupted at the University, (5) UCLA Canceled Classes (6) Law Enforcement was called to the scene to de-escalate (7) More than 200 People were arrested. see CBS News: Police in riot gear break up protests at UCLA as hundreds are arrested (May 02, 2024). A 'Squatter' is a person who unlawfully occupies an uninhabited building or unused land. According to the 'Bill of Rights' under the third amendment no person shall be quartered in any house without the consent of the Owner prescribed by law. National Security is the security and defense of the Sovereign. I, Tonya Knowles, am the Monarch for the United States and the United Kingdom and according to the fourth amendment I have a right to be secure in my Home.

May 07, 2024: The select subcommittee on the Coronavirus Pandemic recently reviewed classified U.S. Department of State documents that credibly suggest COVID-19 originated from a lab related accident in Wuhan China. See United States House Committee on Oversight and Accountability: Classified State Department Documents Credibly suggest COVID-19 lab Leak (2024). A lab 'leak' is defined as an accidental lose. Please Note: COVID-19 is a Global Pandemic that is attached to a Sovereign of State see World Health Organization: Global Research on COVID-19. I, Tonya Knowles, am the 'World Boss' and according to the fourth amendment of the U.S. Constitution people have a right to be secure in their persons, houses, papers and effects against unreasonable searches and seizures, shall not be violated and no warrants shall issue, but upon probable cause, supported by oath or affirmation and particularly describing the place to be searched, and the persons or things to be seized.

4. Remove: The Title King or Queen from any country that is attached to the United States and the United Kingdom to include all territories and note that I am the 'World Boss'

In addition, I am requesting that Chief Justice Roberts provide(s) a Notice of Eviction to current Tenants to include 'Squatters' dating back to February 11, 2019, due to Non-Payment.


