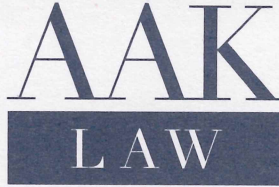

I am counsel for the Respondents, Deputies Rayl, Raven, Mirrle and Vawispowski. Petitioner filed his Petition for a Writ of Certiorari on April 27, 2024. According to the online docket and pursuant to Rule 15.3 of the Rules of the Supreme Court of the United States, a response is currently due on June 17, 2024. Pursuant to Supreme Court Rule 30.4, Respondents respectfully move for an extension of time for filing their response for twenty-eight (28) days until July 15, 2024.
