If forced to pay the docket fee as an incarcerated Pro-Se Petitioner, Raymond Laborde Correctional Center's Law library does not have the means for me to comply with this Honorable Court's requirements under 28 U.S.C.A., U.S.Sup.Ct. Rule 33 (1). Therefore I am respectfully requesting this Honorable Court to grant this motion to proceed in forma pauperis.


