STATEMENT OF THE CASE

On August 28, 2023 my documents were hand delivered to the United States Eleventh Circuit Court clerk, requesting a panel hearing in which she did receive verifying and stamping all documents. Later on August 29, 2023 I received a letter from the court clerk stating my documents are deficient due to me missing a Certificate of Compliance form after all documents were hand delivered verified and stamped. I couldn't understand after I verified everything with the clerk in person the day prior, but the letter stated I had 14 days from the date received to send in a Certificate of Compliance which was completed within the timeframe provided by the courts.

I received another letter on 02/21/2024 denying my panel rehearing due to me not requesting a "Stay of Mandate" along with the "Certificate of Compliance" form that was sent in which I wasn't aware I had to send in a "mandate to stay" form as well because the case wasn't denied. The response was "deficient". I called the court Clerk and spoke with Mr. Joseph Curusso and he stated I had 7 days to request a "Mandate to Stay" form, for the case not be denied, and the date the decision was made left me only 1 day to respond because the decision again was made on the 02/15/2024 and the letter I received by mail on 02/21/2021. I was able to file in a timely manner the following morning in person with the court clerk. I am requesting the court to follow up with this case. As I stated they never responded to the alleged complaints filed (Sexual harassment, retaliation, hostile work environment, discrimination etc. only the procedures and deficiencies of this entire were constantly acknowledged throughout this case knowing I wasn't able to obtain or offered any legal representation and lacking knowledge of legal terminology.
