

MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

Pursuant to Rule 39 of the Rules of the Supreme Court of the United States, Petitioner Deqwond Saquod Lewis, proceeding pro se, requests leave to file accompanying Petition for Writ of Certiorari to the United States Court of Appeals for the Fifth Circuit without payment of cost and to proceed in forma pauperis.
