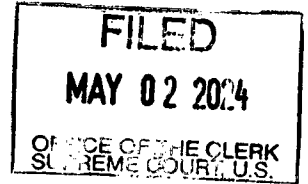

### QUESTION(S) PRESENTED

When Federal Bureau of Investigations violate constitutional rights to investigate (terrorism) illegal law enforcement (wrongful arrest, illegal search and seizure, imprisonment that was unlawful, assault, torture, illegal use of law enforcement technology, retaliation by Federal Government) in

James B. Jordan v. Federal Bureau of Investigation by collaborating with law enforcement (FBI) and also (FBI and various other law enforcement agencies around the globe) terrorizing James B. ## STATEMENT OF THE CASE

This case has been aptly described as the "Terrorism lawsuit of the Millennium!" As it comes to the court, the case presents various (two) exceptionally important questions concerning (the) FBI/Law Enforcement Terrorism towards James B. Jordan.

How are FBI/Law Enforcement (US Attorney, Federal Court Security, Federal Police, LAPD, LA County Sheriffs, Arkansas Police, Pima County Sheriffs, Jacksonville Police, Jonesboro LA Sheriffs, etc. All being illegally allowed to Terrorize (arrest, falsely imprison, beat, black ball, vandalize car of James for over 10 years - How can James be terminated from LA County with documentation, reasoning, never been written up, etc.

James life and liberty is continuously being taken, deprived of all constitutional rights, etc. And lower courts neglect the truth (wholly incredible as lower courts put it).

James is bleeding writing this statement of case since James was again terrorized by someone who intended to kill James. James is suffering mass harm, stabbed in face, ear cut off, stabbed in back of head, stitches, staples, busted wounds, etc.



This writ of Certiorari is an emergency writ. James has no computer access, no privacy due to Law Enforcement Terrorism so writ needs to be rapidly accelerated (view James district court cases in the interest of Justice)

James has included District Court of Appeals decisions giving James right to file in Supreme Court. James is not being treated lawfully. James FBI case was dismissed by Appeals court as frivolous. But James is legally imprisoned by FBI since James doesn't have free will, opportunity to live safe, work as a Social Worker, drive a car, constantly being assaulted, etc. Plus James has provided proof of arrest, complaints, and (cartoonings, vandalism reports filed with law enforcement), etc.

Again James request that Supreme Court Justices grant Writ of Certiorari due to terrorism. James has over 10 lawsuits against Law Enforcement. James personally filed 5 cases in District Court in Washington D.C. (approximately) 2002 located 333 6. Constitution Ave, District of Columbia.

James car was again vandalized in front of District Court in D.C. 2002 and James was rushed by D.C. Police in front, and car towed.

When is this terrorism going to end. James hitch hiked to District of Columbia District Court to file complaint at main FBI office (2002), Department of Justice, and District Court in Washington D.C. 333 E. Constitution Ave. James complaints, Court cases were neglected, dismissed. FBI Police threatened James and said "I know what's going on with you James!"

Then at Main US District Court (2002) James car was vandalized (parked directly across the street from court) and towed behind US District Court by D.C. Police. James is being terrorized and needs write to be accepted.

James is homeless in Washington D.C. and James has no reserves. James only worked for two weeks last year 2003 and made 2500.00 the entire year.

James can not receive any legal assistance (part of retaliation), since James is suing District Attorney, US Attorney who have all been attempting to send James to Jail for felony charges. Grant writ and pull District Court case to end terrorism.

James is in so much pain and needs to see a doctor, be compensated, etc.

Writ of Certiorari should contain issue of National Importance or Wide Application. (Law Enforcement Terrorism - worst crime in U.S.A)  
If it can be demonstrated that a decision affects a large number of people, for example a group of individuals that the law seeks to protect then the court should grant the petition for Writ.

The Supreme Court plays a very important role in constitutional system of government first, as the highest court in the land, it is the court of last resort for those looking for justice. Second, due to its power of judicial review, it plays an essential role in ensuring that each branch of government recognizes the limits of its own power. Supreme Court works on "equal justice under the law," which delineates the ultimate responsibility of the institution is the prevalence of justice and the rule of law for people without any discrimination.

James continues to be discriminated and at least by law enforcement. James has no criminal record, valid passport, a bachelors, and a Masters Degree so James can get any job James wants. But law enforcement continues to follow harass, (and threaten, assault) terrorize James in every state (also went to Mexico) or country that James attempts to live James life. Law Enforcement threatens James saying "you can run but you can't hide. We work all over the world, plus we contract with federal Border Patrol who uses same law enforcement technology. They can see you underground, behind walls or computer technology is the best we'll keep hacking you, phones, causing you mass harm." James says issue of National Importance. James life is in danger.

④ James passed background for Children Services in Minnesota and James began working for Children Services as a Social Worker. James did not know anyone since most family in Los Angeles were James grew up but James is suffering from terrorism, assault and is/was trying to live life as a US Citizen. But FBI continued to harass James harassing, GPS, terrorizing. All illegal acts, depriving James of life and liberty. James needs Supreme court to hear case (State of Emergency), James needs to have this Artificial Intelligence device removed by doctor. Every state, place James goes James is not able to see specialist, James Medical Insurance keeps being temporarily cancelled (Cyber fraud), or James is arrested and threatened, forced, coerced to leave hospital by law enforcement, etc.

2016-2017 James again attempted to live life as a Masters level Social Worker moving to Lincoln, Nebraska (check spelling) after James was hired by Children Services. After James began working as a Social Worker, James began being harassed and terrorized by FBI, and other law enforcement (forced to leave). 2017-2018 James moved to Hot Springs, Arkansas and next day James was arrested, jailed by police, assaulted and thrown outside jail. Terrorism went end for James Jordan.

James has drivers licenses in over 10 states. James is being illegally victimized. Terrorism, torture is illegal in the United States.

⑤  
2018 James moved to Oklahoma City, Oklahoma hired by Children Services as a Social Worker. James continued to be assaulted, terrorized by FBI. James moved to any city in Oklahoma (Norman) to get away from Oklahoma City where James was hired by a federal prison in Norman as a Case Manager. But James continued to be followed, harassed by FBI, and law enforcement in Oklahoma.

James was told by FBI that all Children Services, Prisons, Social Work jobs are usually at the federal Government level but anywhere James worked even McDonalds the FBI will know about and continue to harass me.

This was very scary for James because James is being retaliated against by Terrorism. James is very sick, as a result of illegal Artificial Intelligence Warfare/Conflict, trauma, etc.

James has been running from assault/terrorism by law enforcement since 2015 (years of arrest, illegal, County jails, prisons, etc) but not one conviction just illegal terrorism that's keeping James sick, no work, no justice, all cars vandalized, or towed away to keep James from being mobile (Social Work 75% car work).

2019 James moved to Las Vegas to attempt to live life. James was followed, threatened, impaled, harassed by FBI, and law enforcement.

⑥ In 2000 James moved to Louisiana (Jonesboro) and James was hired as a worker at a Juvenile Prison in Monroe, LA. The Director found out James had a Master's Degree and called James in office to promote to Assistant Director. James was informed that in order to be Assistant Director James had to be licensed as a Social Worker in Louisiana. The next day James drove to Baton Rouge, LA and applied for Social Work License. James received a letter from Board of Social Work in Baton Rouge with concerns of James long arrest history (no convictions). James wrote a statement and was awarded Social Work License by Board of Social Work in Baton Rouge. This is where all went bad, James thought that license meant a promotion. But instead James started being harassed by FBI in Monroe, LA (where FBI office located), James started being harassed, terrorized by 3 different Law Enforcement agencies that surrounded James residence (rented room from older white family in Jonesboro, LA) - for example, Ruston, LA Police started ticketing, detaining, and harassing James, ~~Alamogordo~~ Hodge Police started following, detaining and terrorizing James. Jonesboro Sheriffs (the worst) terrorized James, assaulting pulling over saying "you sued Sheriffs in LA huh. All us Sheriffs work together!" James can't be the first Artificial Intelligence Ear Implant, GPS, recipient. James needs emergent assistance from Supreme Court.

② A couple days after James was pulling up to home where James rented room. A man attempted to rob James in front of James residence. Jonesboro (Jackson Parish Police) arrested James from residence (even though homeowner white male) saw Sheriff's camera footage of encounter showing James did nothing. James due process was violated, no substation, no court 72 hours, or at all, no offered attorney. On October 2020 James was imprisoned at Jackson Parish Correctional Center for 2 felony charges, stuck (after assault by 2 arresting sheriffs) in single cell. James was not taken to court for almost a year, plus James was assaulted by Correction officers, inmates every day. Only after prison was closed and all inmates were transferred to another prison was (out of Jonesboro, LA) James allowed to go to court where judge dismissed all charges and released James same day. (James was prisoned December 2020 not October) September 21, 2021 (approximately) James was released with no felony record (not even processed, finger printed) terrorism continued after James was released from prison. For example, James was arrested by Hodge, LA Police who stated James had a traffic warrant (Head of Police Woman white lady lived next door to jail). James knew nothing of warrant and explain showing release paper with that James just got out of prison.

⑧ (White lady) Head of Jail came to jail in flip flops and  
rob said "look I'm the Governor of Hodge, LA, if you don't pay  
this ticket you're going to be jail here and now!" James called  
family who paid ticket over the phone and James was released.  
James attempted to get out of Jonesboro, then Ruston (on the way  
to Texas highway, etc) and was again arrested by Ruston, LA  
Police (officer was the same Italian guy who had been terrorizing  
me/James before James was imprisoned). Again this officer said  
"you are being arrested for a warrant, past due!" James could not  
believe it twice arrested in one day. James went to court and was  
told by Judge that officer did not file charges, no warrant dismissed,  
and James was released.

The next day James traveled through another town in Louisiana  
(Farmerville) trying to get away from Hodge, Jonesboro, Ruston, etc.  
who kept illegally terrorizing James.

Devil Terrorism, James was walking down the road and a police  
car, Farmerville Police pulled up and James couldn't believe it  
the Ruston Police (found out he is FBI) from Ruston, LA got out  
and said "hey James I just transferred to Farmerville Police  
and you're under arrest for showing me yourself."



① James could not believe it. How could this cop transfer in one day. plus a false felony arrest. James stayed in jail for a month (being assaulted, terrorized by Corrections officers every day). James went to court (virtual) and Judge said "case dismissed, officer didn't pursue charges on felony, time served."

FBI continued to violate James constitutional rights and deprive James of life and liberty.

After release from Farmerville jail James received a call from (what James thought was real) Juvenile Prison in Monroe, LA saying James had a check there. James was broke, car impounded by fake police (Italian FBI) so James made arrangements to get to Monroe. Not good, James was met by police in Monroe, LA who arrested James saying "you have a warrant!"

James can not believe that FBI, Law Enforcement (who callibrate) are depriving James of life and liberty. For example, James hasn't had a steady job since 2017 - plus this ear implant (ARTIFICIAL Intelligence) is going to kill James. James requested a Doctors order from US District Court but was illegally arrested by US Marshalls, and Federal Police in 2003, 2004. To make matters worst Chief Judge Phillip Gutierrez banned James from entering any US District Court Central in 2003, etc.

① Anyone can see that James rights are being violated.  
James is being terrorized by every law enforcement agency in  
the world. The Federal Bureau of Investigations, and law are  
torturing James with this artificial Intelligence (Impulsions,  
Heaving, Distortion, etc.). James has filed complaints in  
District Court Washington D.C. 2002 and Cases are dismissed,  
Filed in District Court California 2003 Case dismissed. District  
Court of California would not let me serve summons in any  
of my/James cases. James is being treated unlawfully.  
Since 2012 James has had over 50 vehicles impounded, vandalized.  
2003 May, June, September, November  
James was illegally arrested, assaulted by LA County Sheriff (as of 2003)  
James was illegally arrested by Federal Police 9/2003, 11/2003.  
11/2003 Case District Court sent failure to appear notice 11/2003  
but James is banned from federal court.  
9/2003 Federal Case Dismissed.

James is being terrorized and needs to see Doctor very badly,  
law enforcement/FBI are terrorizing James.

Justices hear my case to assist with James  
life. James is now in Washington D.C. with the help of  
church Non Profit paying way Help James B. London <sup>BSW</sup>

## REASONS FOR GRANTING THE PETITION

Terrorism is the worst crime in America.  
James is the subject of law enforcement terrorism  
Since 2012. That should be all the reason to grant  
the petition.

James arms, and entire body aches in extreme pain  
due (May 18, 2024) to being almost killed, stabbed and  
beat.

James has reported this (ALL) illegal acts to Lower Courts,  
Court of Appeals, etc. Now James pleads to the highest  
(Supreme Court) for judicial intervention James isn't going  
to be able to keep/continue to write/report illegal acts  
because James is soon to be DEAD!
