

### STATEMENT OF THE CASE

## REASONS FOR GRANTING THE PETITION

Ineffective assistances of all previous counsels, from pre-trial to appellate counsels, to investigate or adequately investigate, to gather evidence, to raise weight of the prosecution evidence being unable to meet the burden of proof and was contrary to the verdict, failure to object and preserve all appealable issues, failure to collect the seven letters written to the Petitioner while on pre-trial by the complainant, failure to raise the complainant previous false criminal accusations (HMC-51-CP-0038704-2009) against the Petitioner, failure to raise entrapment, failure to interview complainant and witnesses, dismissed all the charges and verdict with prejudice, grant a new trial, and all other reliefs deem necessary by this Court. Including newly discovered evidence, mental incompetency, and ~~etcetera~~.

Petitioner also request this Court to appoint him a counsel to adequately amend this Petition and represent him. Petitioner is a civil detainee currently in the Immigration & Customs Enforcement "ICE" Department of Homeland Security "DHS" civil detention custody since 8/10/2022 being subjected to indefinite detention, criminal convicts conditions of confinement, denial of access to the main general law library and criminal appeal legal materials and researches by

• both the DHS/ICE and GEO Group, Inc. employees.

Petitioner did not and can not attach any appendix photocopies or require photocopies because of the DHS/ICE and GEO Group, Inc. employees refusal to provide me access to photocopier, typewriter, criminal appeal legal materials, and etcetera. Petitioner is not a threat to national security but is being subjected to restraints via handcuffs/shackles as a civil detainee on criminal convicts policies/procedures/punishments. Any additional reliefs deem necessary by this Court.
