I am Lewis Ray Charles Altman these are the events on March 12th of 2014 and March 18 of 2014. On the 12th of March, Josh Turner came to my home where I reside at 2016 Jackson Street, Dubuque Iowa gave me \$100.00 bill for all of us to smoke dope on the back porch. I was smoking because of my condition and pain. I received the drugs from Perro Carroll who met us on the back porch and then he left us. We all smoked it together. I'm not sure of the correct spelling of his first name but recognize him if I were to see him.

Second event, March 18, 2014 during the daytime Josh Turner came to 2016 Jackson Street in Dubuque Iowa a second time. We were in the dining area. Josh gave me 50 bucks for drugs so that we all could smoke. I don't know where Josh met Perro Carroll to get drugs for me. Deon had nothing to do with Josh Turner and Perro Carroll because he went to go get the pipe for us to smoke.

When Deon was gone to get the pipe from the garage, Josh snatched the dope off my bed where I rest because I use the drugs for my condition and pain. Josh ran out the front with the drugs. Deon didn't have anything to do with the situation because the drugs was all for me. Deon only went to the garage to get the pipe out of the garage for me to smoke. I also know that Josh Turner is a frequent user known to be addicted to drugs in Dubuque Iowa.

I, Lewis Ray Charles Altman Jr., affirm these events are true, accurate and did occur on the above dates stated. Takeyshia Altman is my sister and is my Power of Attorney because I'm paralyzed. I can't go to court because I am paralyzed. I take medication and that I'm on twice a day.

I tried to talk to Deon's public defender, Attorney Ray Scheetz and I told him everything that's in this statement. He has not mentioned anything that's stated above which is the truth.
