

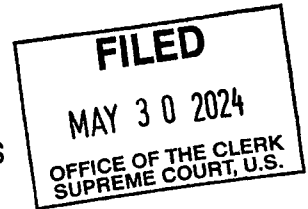

STATEMENT OF THE CASE

Mr. Michael T Faust used his two hands to grab me and threw me against the sofa. The sofa had wood dividing each seat. Mr. Michael T Faust caused me to hit my back and neck on the wood of the sofa and it damaged my neck.

Around March of 2012, Mr. Michael T Faust and I Maria M. Faust were arguing in the bedroom of my house that is located at 948 Edwin Dr. Virginia Beach, VA. Mr. Michael T. Faust stood in front of me quickly and then grabbed me by the neck with both hands, choking me so hard that I could not breathe. I could barely speak but I then found strength to whisper to Micheal and said "No No Michael, please". Mr. Michael T Faust then threw me very hard with his two hands against the base of the bed. Mr. Michael T Faust caused me to hit my head and neck very hard on the bed, since then I have been feeling a lot of pain in my back, especially on my neck area because he damaged my neck again.

On January 2012, Mr. Michael T Faust was very angry with me for no reason, he stood up from the sofa in the living room and quickly stood in front of my face and yelled very loudly " shut up, stupid bitch, I want to get a gun and blow your head off and I want to kill you".

On July 18th of 2012,
1010 Butternut St NW, Washington D.C
Is the address for the Military housing in Georgia Ave.

Mr. Faust got angry with me because I forgot to pay the cable bill and we didn't have TV service and phone service at home.

I went to the store that evening, and when I came back home Mr. Michael T. Faust was very angry. He started yelling at me and tried to have an argument with me.

I told Mr. Michael T. Faust that I do not want to talk to him. Mr. Michael T. Faust grabbed me with his two hands and threw me in front of the door, while yelling " get out of house you fucking bitch" .

Mr. Michael T. Faust slammed the door very hard behind me, and the glass door shattered. I was fearful for my life.

I had glass in my hair, shoes, and clothes. I called the police (Complaint #12100673)

In June 2012 in the afternoon, we were arguing (I don't remember what the reason was) I, Maria M. Faust asked Michael T. Faust about the box cutter and Michael T. Faust was holding a box

cutter in one of his hands and he asked me with a mocking smile if it was the one he was holding. He put the box cutter in front of my face, mocking me, and I was afraid for my life. I was scared many times that I would lose my life because of Michael T. Faust behaved and sometimes I couldn't even sleep. This occurred at 1010 Butternut St NW, Washington D.C Is the address for the Military housing in Georgia Ave.

Be aware that there are two marriage certificates.

1: Las Vegas Nevada, 2 of September of 1991

2: Virginia Beach, 05 of November of 1992

May 04 of 2012

The military moved us from Virginia Beach, VA to Washington D.C.

On July 14, of 2012

Mr. Michael T. Faust was violent and he broke the T.V cable box and the phone. This happened at 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave.

I received a letter on July, 12 of 2012

From the department of the NAVY, from the Commander Joint Base Anacostia Bolling.

Family Advocacy Program

The spouse emotional abuse by LCDR Michael T. Faust

On July 20 of 2012, Mr.Michael T. Faust arrived at the residence 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave. He was very violent, destroying the movers boxes and yelling, threatening me and I got scared for my life and called the police. The Metropolitan Police of Washington D.C. (Case # CCN 12101517, event #12101517). There are photographs of the destroyed boxes.

July 24 of 2012

Mr. Michael T. Faust, took out all the money from our joint bank account, from the Navy Federal. He left me with \$0 money.

July 25 and 26 of 2012

Mr. Michael T. Faust changed my password for Facebook, Gmail, canceled my credit cards and canceled my phone.

July 26 of 2012

Mr. Michael T. Faust, violated CPO (2012, CPO 002875) he sent our son to the residence 1010 Butternut St NW, Washington D.C. To take more documents, my jewelry, and properties. I called the Metropolitan Police of Washington D.C.(CNN 12104664). There are photographs of the boxes and luggage destroyed.

August 04 of 2012

Mr. Michael T. Faust sent our son to our residence at 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave. He sent our son to take more documents and destroy the moving boxes, the police report is CCN # 12109080.

August 05 of 2012

Mr. Micheal T. Faust sent our son to our residence 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave. He sent our son to take my car a FJ Toyota Cruiser.

August 2012

Mr. Michael T. Faust was very aggressive when he arrived to the Military housing at 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave. He was destroying moving boxes and taking more documents. I called the police because Mr. Michael T. Faust was yelling threatening words to me, I felt very afraid and terrified. Several police cars arrived and when they entered the house the police officers were happy to be looking around the mansion (Military housing). When the police officers were looking around very happy and not paying attention, Mr. Michael T. Faust pushed me into a corner of the hallway and Mr. Michael T. Faust threatened me that if I opened my mouth he would kill me. I was very terrified. I immediately went to look for one of the police officers and I explained to one of them what happened. The policeman was very arrogant and told me there was no body, no blood, there was no crime that had happened. I was very scared and crying. I was very afraid. The police officer told me with some arrogant words. He told me, you have to leave the house, Mr. Michael T. Faust can take whatever he wants , he's a commander, he served this country "you did not". The police officer spoke to me very aggressively. I left the house, I had nowhere to go, I was very terrified. "I did not find any police records on this day"

August 08 of 2012

I received a letter from Family Advocacy (Department of the Navy) to Homes - Brantly Chyne that I did not have money to buy food " SPOUSAL SUPPORT ISSUES".

1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave

August 10 of 2012

Mr. Michael T. Faust canceled the United States postal service, that was my residential address too, 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave.

August 20 of 2012

Mr. Michael T. Faust signed a contract agreement not to assault, threaten, harass or stalk Maria M. Faust or destroy my property and agreed to provide financial assistance. Mr. Michael T. Faust that he did not fulfill (comply) the contract with financial assistance. On June 18th of 2013 at the Superior Court of District of Columbia Civil case # 2013CA8166B and did not fulfill the contract ordered by the court. Mr. Michael T. Faust doesn't deposit the money in time in the Navy Federal Credit Union, when my rent is due or when I buy food. There were times when I didn't have anything to eat.

August 25 of 2012

Mr. Michael T. Faust and family arrived at the residence 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave. He was escorted by the Metropolitan Police of Washington D.C, with a moving truck. Mr. Michael T. Faust and family packed everything they wanted and left me abandoned in an empty house. I was crying, very terrified not knowing what to do, I felt no one could help me.

August 2012

I went to ask for food at the Red Cross inside the hospital, Walter Reed National Military hospital and a woman who was very arrogant told me that they only had food for the soldiers not for me. I looked for help everywhere and no one helped me.

September 09 of 2012

I received a letter from the Dear Fair and Military Service Center. Mr. Michael T. Faust left me without money, I didn't have money to pay my rent and I didn't have money to buy food and my request was denied. 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave

September 16 of 2012

On the work computer (NAVY) of Mr. Michael T. Faust, I found that he had the internet requested escorts (there are photographs of them). 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave

December 14 of 2012

I received a letter from the Family Advocacy program, that Mr. Michael T. Faust was trying to remove the SPOUSAL EMOTIONAL ABUSE of Maria M. Faust from his work record (Military) by LCDR Mr. Michael T. Faust. I also received a phone call from one of the investigators that Mr. Michael T. Faust researches the Navy Criminal Investigators.

I, Maria M. Faust, sent an email to Capt, Karen Newcob that I do not agree that they remove the record of SPOUSE ABUSE by Mr. Michael T. Faust. 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave.

December 20 of 2012

I received a letter from the lawyer Jeffery M. Lewis, Michael T. Faust's lawyer that I had to vacate 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave. This is when Michael T. Faust abandoned me (EVICTION INDICATED NOT LATER THAN December 31 of 2012).

December 20 of 2012

I received an email from Captain Karen Newcomb to have information where they are going to transfer my husband LCDR Mr. Michael T. Faust (to what duty station they are going to transfer him too). 1010 Butternut St NW, Washington D.C is the address for the Military housing in Georgia Ave.

December 07 of 2014

I stayed in a shelter Samaritan House in Virginia Beach, Overnight Housing Program because Mr. Michael T. Faust filed for a petition for divorce in Virginia Beach, VA. That I had to transfer to Virginia Beach, VA, I had no money and was very hungry, and I had no place to stay. There were times when I stayed in the shelter, whenever they had a room for me.

I'm Maria Mayela Faust. I have had a difficult life after my divorce I took the best care of my family for over 22 years. I did not go to school, I did not work except cleaning houses so that my children went to a private school and my husband finished university and helped him in his Military Career (NAVY) when he went out to sea around the world.

I was the father and mother of our children. When he divorced me, he took away my truck, my furniture, the boat, clothing and jewelry, documents, our house and My dog "Artica". I don't have a safe place to live, I have to stand in line in cold, rain, hot, weather to get free food. I'm surviving.

I had a lot of physical, verbal, and threatening SPOUSE ABUSE. I was very scared.

He left me abandoned, I ended up living in Washington D.C, with no job, no money, and no one to take care of me. Before I was forced to leave Military housing, it was empty which is located at Georgia Ave, Walter Reed (MILITARY HOUSING). When I finally got divorced, I ended up with big lawyer bills.

I have always depended on other people to assist me and advise me but unfortunately (they took advantage) they gave me bad advice.

What happened in court, no one of my lawyers tried very hard to change that I was pressured to sign the documents that I did not understand or were clear or that I agreed with.

That day I was stressed with no money, very tired, very hungry, I was staying at a shelter in Virginia Beach, I was crying a lot with alot of fear.

My lawyer said if I dont sign the documents, my children would testify against me for abusing my husband and I would lose unless I sign the documents.

I am not proficient in writing, speaking or reading English and less in a legal setting. Unfortunately I do not have much education, I am very embarrassed to tell the court. I need the court to help me and understand my side of the story. I hope the court considers my situation before it determines my fate.

Why has the court not taken into consideration this case of SPOUSAL ABUSE?

There is sufficient evidence and I want compensation, Fed.R.Civ. P.12 (b) (6), for the misconduct of Sr. Michael T Faust for SPOUSAL, PSYCHOLOGICAL, PHYSICAL ABUSE. INFIDELITY, and ABANDONMENT.

District of Columbia Court of Appeals made an error not taking my case.

I have a psychological trauma from the physical abuse by Sr. Michael T Faust and he damaged my neck resulting in permanent pain and after years the pain has increased. Due to this pain I have difficulty concentrating (I have an MRI CD for evidence). I suffered from SPOUSAL ABUSE for 2008,2009, 2010, 2011, and 2012 is when he abandoned me.

There should be more than sufficient evidence due to the photos and records from the police of the District of Columbia, and the infidelity found on his work computer (NAVY), about escort websites.

With the woman he is now, he was cheating on me.

I want you to be aware what Mr.Michael T. Faust did to me (he premeditated it).

There are several cases in the courts against Mr.Michael T. Faust for (breach of contracts) that the courts have ordered him to comply and he does not do it. I have had to pay 3 investigators to bring him to the courts, we can not find Mr.Michael T. Faust.

Mr.Michael T. Faust is violating the law and he is using the government for his own benefit.

I WANT COMPENSATION FOR THE DAMAGES AND PREJUDICES.

REASONS FOR GRANTING THE PETITION

I am Maria Mayela Faust, have been psychically and mentally abused and have been abandoned by Michael T Faust and he has committed adultery with the person he is now with.

The District of Columbia Court of Appeals has made an error in not taking my case. I want the honorable Supreme Court of The United States to be aware that I am one of the thousand women being abused in the military.

I hope that the court considers my situation before it determines my fate. My life is in your hands.

THANK GOD ALMIGHTY, I am here in life giving these documents to the honorable Supreme Courts of the United States,

Be aware that this is happening in the military, women like me suffering from spousal abuse and some have lost their lives. Mr. Michael T. Faust violated the law (SPOUSE ABUSE) and using the government.

Thank you, God, who is all powerful for my life and that I am here today to present my case.

There has been an error in not hearing my case, when I have submitted enough evidence.

I do not have legal aid because I do not have money for a lawyer.

The road was long and difficult with a lot of suffering to deliver these documents to the honorable Supreme Court of the United States.

I want Justice.

The petition for a writ of certiorari should be granted.
