TO THE HONORABLE JUDGES OF THE AFORESAID COURT:

Your Defendant, Maria Mayela Faust, respectfully represents unto the Court and makes the following statements under oath:

1. This Court entered a Final Decree of Divorce on October 9, 2015, incorporating the parties' Separation Agreement dated May 20, 2015. Pursuant to the Agreement, Paragraph 3(D)(iv), Husband shall maintain \$200,000 in life insurance payable to Wife until such time as Wife dies or remarries. Husband shall provide documentation of policy annually. Husband shall resume policy if Wife's future Husband or future Wife dies or divorce until such time as she marries again.

2. As of this date, Plaintiff has failed to provide Defendant with documentation of the life insurance policy.

3. This Court entered a Final Decree of Divorce on October 9, 2015, incorporating the parties' Separation Agreement dated May 20, 2015. Pursuant to the Agreement, Paragraph 3(E)(i), Husband shall be responsible for payment of the Keesler Joint Credit Card.

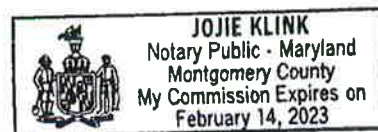




