3 THE COURT: People of the State of Michigan versus
4 Gustavo Galindez, file 21-54-FH.

5 Mr. Strong is here on behalf of the People.

6 Ms. Love is here with the Defendant.

7 Raise your right hand, sir.

8 Do you swear to tell the truth, the whole truth, and
9 nothing but the truth, so help you God, under penalty of
10 perjury?

11 THE DEFENDANT: Yes, ma'am.

12 THE COURT: Okay.

13 Today is the date and time for the pretrial. This
14 trial is scheduled a week from Monday, or July 11, 2022. I
15 received an e-mail this morning from Ms. Love indicating that
16 a resolution had, in fact, been reached and Mr. Strong
17 concurred. And they have told me that the Defendant would be
18 pleading no contest. The reason for the no contest plea would
19 be intoxication and the factual basis that he would not be
20 able to give.

21 The sentencing agreement is for nine years with the
22 Michigan Department of Corrections. Seven years on count one,
23 plus two years on count two, which is the felony firearm.
24 That would be the minimum. The maximum, meaning the statutory
25 maximum set by the Court, and I would set that at sentencing.

1 And then all the remaining counts will be eaten up by those
2 nine years the parties have agreed to.

3 There would be no charges against the Defendant
4 regarding fentanyl. All sentences would run concurrent with
5 the Ingham County case 22-0953-FY. And the Defendant could
6 remain out on bond until we came back for sentencing.

7 Is that your understanding of the agreement, Mr.
8 Strong?

9 MR. STRONG: It is, Your Honor, and just the last
10 clarification is that it is pleading no contest to all counts
11 as a habitual offender fourth within in the Information.

12 THE COURT: Thank you.

13 And is that your understanding, Ms. Love?

14 MS. LOVE: It is.

15 THE COURT: And most importantly, Mr. Galindez, is
16 that your understanding?

17 THE DEFENDANT: Yes, ma'am.

18 THE COURT: Have we had him sign his Advice of
19 Rights? We have, of course. Ms. Love is on it.

20 Now sir, you are charged in count one with the
21 delivery and manufacturing of methamphetamine which is a 20
22 year felony and/or \$25,000 fine. You would have license
23 sanctions if you get more than one year in prison.

24 Count two, felony firearm, that's a two year felony,
25 served consecutive with and preceding any term of imprisonment

1 THE COURT: -- they've been bringing some stuff up
2 for me to sign. Sir, I need you to go downstairs, in the
3 basement, go to the MDOC office. They're going to give you a
4 packet for you to fill out. Give them information and get it
5 back to them as soon as practical so they can prepare the
6 presentence report.

7 THE DEFENDANT: Yes, ma'am.

8 THE COURT: Once we get the draft of the presentence
9 report your attorney will get a copy and she's going to
10 contact you to come meet with her and go over that to make
11 sure it's accurate. Okay?

12 THE DEFENDANT: Yes, ma'am.

13 THE COURT: And then I will see you back here on
14 August 11th at 8:30. Okay?

15 THE DEFENDANT: Yes, ma'am. Thank you.

16 THE COURT: Anything else, Mr. Strong?

17 MR. STRONG: Just one thing, Your Honor, which I
18 spoke with Ms. Love about this, I'm sure she's communicated
19 it, but just for the purposes of the record, the Defendant,
20 obviously, part of our agreement was that he can remain out on
21 bond until sentencing. If, under the court rules, if there's
22 any misconduct on his part --

23 THE COURT: Yeah.

24 MR. STRONG: -- between now and sentencing the Judge
25 can exceed the sentencing agreement between us of nine years

1 and you don't have the right to withdraw your plea. So,
2 misconduct is very broadly defined. It's -- can be anything
3 like absconding, not complying with the PSI, new criminal
4 charges. Anything like that. So, I just want to make sure
5 that that's sure so six weeks, August 11th, no misconduct.

6 THE DEFENDANT: Yes, sir.

7 MR. STRONG: Otherwise the Judge can exceed the
8 plea.

1 allow him to withdraw his plea if he does commit misconduct.
2 The number one thing you got to do is show back up for
3 sentencing. The Defendant didn't do that. The only reason
4 he's here today is because he was arrested by the Fugitive
5 Task Force in Ingham County. And when he was arrested, as we
6 see from the case report, it's the same thing that his entire
7 criminal history is. Guns, drugs and stolen vehicles, stolen
8 property.

9 If this was a possession case, I wouldn't be asking
10 for this. If this was a retail fraud even, wouldn't be asking
11 for this. This case involves the Defendant having guns,
12 fleeing the police, sorry, him getting arrested and being here
13 today, involves having guns, having drugs, fleeing the police,
14 running a chop shop. It made the news. Why Ingham County
15 hasn't decided to issue charges for that, I can only imagine
16 that they're waiting to see what his other two cases are going
17 to resolve with as well as what happens here. Because while
18 he was on bond for this, before his plea, he also had the very
19 last offense in his -- in the PSI which is being charged with
20 the delivery/manufacture of methamphetamine,
21 delivery/manufacture of narcotic or cocaine, less than 50
22 grams. Dealing drugs, guns, running from the police.

23 The Defendant is a danger to society. We gave him
24 the benefit of a plea agreement. He threw that in our face.
25 He threw that in the Court's face. And went right back to the

1 certainly showing it in a very odd way because you are
2 continuing criminal behavior after you already know you're
3 going to prison for nine years and you do that.

4 The, the reality is, my responsibility has to be
5 also to look at protecting society from individuals who run
6 from the law, who run from law enforcement. That's scary.
7 Individuals that have guns and drugs and commit new acts while
8 they're waiting to be sentenced on other criminal activity.
9 So, I appreciate the advocacy of your attorney. And I don't
10 doubt right now your emotions are genuine and your comments
11 are genuine because you're looking at going away to prison for
12 a long time. But when you're not in the courtroom the
13 decisions you make and your actions are contrary to what you
14 state to me when you're standing there being nervous and
15 scared.

16 So, I have to look at the evidence in front of me,
17 look at your history, and say I don't know that there's a
18 strong possibility of rehabilitation. I also know that part
19 of the thing that I have to look at is deterrence in society.
20 To say to people, if you keep doing the same thing over and
21 over, that, that's dangerous. Dangerous to the public.
22 There's going to be a consequence to that. That has to be the
23 message that is sent. Right?

24 THE DEFENDANT: Yes, ma'am.

25 THE COURT: And the other thing that I have to do is

1 to say, and it's hard, to say is society -- how can we protect
2 society from the decisions that you keep making. And
3 obviously probation and terms and conditions don't work. And
4 at some point, I am left with the sad conclusion that the way
5 that I protect society is by placing you behind bars. And
6 that's where we're at.

7 And the Legislature has come up with guidelines and
8 they say here are guidelines that we think are appropriate for
9 someone who has repeated criminal activity and that criminal
10 activity, as said by Mr. Strong, we're not talking about
11 somebody just having person use and possession of drugs that
12 they're doing themselves. The things that you have done are
13 scary and they're dangerous. And the things that are in this
14 updated report that you did, while you were out, knowing you
15 were going to go to prison so you don't come back. And then
16 you do these types of things, or at least it's alleged you
17 did, I do know one fact, you wouldn't be here if you weren't
18 arrested.

19 I think the Prosecutor's request, sadly, is
20 reasonable. It is the sentence of this Court, on count one,
21 that the Defendant will be sentenced to 20 years -- what is
22 the rest of it, Mr. Strong?

23 MR. STRONG: Twenty years -- if the Court did 20 to
24 40 that would be appropriate.

25 THE COURT: Twenty to 40 years.

PRESENTENCE CASE REPORT

was observed leaving a residence the fugitive team was watching in a dark SUV, and when the defendant returned he had a trailer. The SUV and motorcycle were both determined to be stolen. Several additional vehicles were located and determined to have been reported stolen.

A police report was taken on 8/3/2022 by the Ingham County Sheriff's Department indicating the defendant entered a victim's shed and stole property. These allegations occurred in Delhi Township and no criminal case could be located in the 35th District Court regarding this report.

Regarding jail credit, the defendant is still pending arraignment on his Court issued bench warrant and jail credit should remain as listed in the initial PSI. The MDOC is also maintaining the original recommendation as listed in the PSI.
