



Petitioner filed a petition for a writ of habeas corpus and motion for discovery in the above-entitled matter. The Court considered the petition and motion, and it is


ORDERED that said petition and motion are denied as they do not meet the requirements to invoke this Court's original jurisdiction.

An Indictment was returned by the Minnehaha County Grand Jury on July 13, 2016, charging the defendant with the crimes of Count 1 Aggravated Assault on Law Enforcement Officer-Att. to Cause Serious Bodily Injury on or about June 29, 2016; Count 2 Aggravated Assault on Law Enforcement Officer-Resulting in Serious Bodily Injury on or about June 29, 2016; Count 3 Assault by Bodily Fluids by Juvenile Inmate on or about June 29, 2016. The defendant was arraigned upon the Indictment on July 18, 2016, Ryan Duffy appeared as counsel for Defendant; and, at the arraignment the defendant entered his plea of not guilty of the charges in the Indictment. Defendant with counsel, Ryan Duffy, returned to Court on August 28, 2017, the State appeared by Randy Sample, Deputy State's Attorney. The defendant thereafter changed his plea to guilty to Count 2 Aggravated Assault on Law Enforcement Officer-Resulting in Serious Bodily Injury (SDCL 22-18-1.05 and 22-18-1.1(4)) with sentencing continued to November 2, 2017, after completion of a presentence report.

Thereupon on November 2, 2017, the defendant was asked by the Court whether he had any legal cause why Judgment should not be pronounced against him. There being no cause, the Court pronounced the following Judgment and

S E N T E N C E

AS TO COUNT 2 AGGRAVATED ASSAULT ON LAW ENFORCEMENT OFFICER-RESULTING IN SERIOUS BODILY INJURY : JOGAAK DENG JOGAAK shall be imprisoned in the South Dakota State Penitentiary, located in Sioux Falls, County of Minnehaha, State of South Dakota for twenty five (25) years with twenty (20) years suspended, credit four hundred ninety (490) days served. The defendant shall pay \$104.00 court costs and \$280.00 restitution to victim Gavin Hill to be collected by the Board of Pardons and Paroles. Attorney fees shall be converted to a civil lien in favor of Minnehaha County. The defendant shall comply with all terms and conditions of parole and commit no violent offenses. The defendant was remanded back into the custody of the Minnehaha County Sheriff's Department for transport to the state penitentiary.

It is ordered that the defendant shall provide a DNA sample upon intake into the South Dakota State Penitentiary or the Minnehaha County Jail, pursuant to SDCL 23 – 5A – 5, provided the defendant has not previously done so at the time of arrest and booking for this matter.

It is ordered that Count 1, 3 charging JOGAAK DENG JOGAAK with Aggravated Assault on Law Enforcement-Attempts and Assault by Bodily Fluids be and hereby are dismissed.

There to be kept, fed and clothed according to the rules and discipline governing the South Dakota State Penitentiary.


