**Ex Parte Order for Emergency  
Appointment of Temporary Guardian**

The court considers a petition for the emergency appointment of a temporary guardian for BRADFORD MATTHEWS, JR, pursuant to Iowa Code section 633.569. The court finds that there is not sufficient time to file a petition and hold a hearing under Iowa Code section 633.552, that the appointment of a temporary guardian is necessary to avoid immediate or irreparable harm to BRADFORD MATTHEWS, JR, and that there is reason to believe that the basis for appointment of a guardian exists under Iowa Code section 633.552.

Lateshia Patillo is appointed as temporary guardian of BRADFORD MATTHEWS, JR to serve without bond.

**Limited Powers of the Temporary Guardian:**

The temporary guardian may exercise the limited powers below without prior court approval:

- Making decisions regarding the care, maintenance, health, education, welfare, and safety of BRADFORD MATTHEWS, JR except as otherwise limited by the Court.
- Establishing BRADFORD MATTHEWS, JR's permanent residence except as limited by Iowa Code section 633.635(3).
- Taking reasonable care of BRADFORD MATTHEWS, JR's clothing, furniture, vehicle, other personal effects, and companion animals, assistive animals, assistance animals, and service animals.
- Assisting BRADFORD MATTHEWS, JR in developing maximum self-reliance and independence.
- Consenting to and arranging for medical, dental, and other health care treatment and services for BRADFORD MATTHEWS, JR except as otherwise limited by Iowa Code section 633.635(3).
- Consenting to and arranging for other needed professional services for BRADFORD MATTHEWS, JR.
- Consenting to and arranging for appropriate training, educational, and vocational services for BRADFORD MATTHEWS, JR.
- Maintaining contact, including through regular visitation with BRADFORD MATTHEWS, JR if BRADFORD MATTHEWS, JR does not reside with the temporary guardian.
- Making reasonable efforts to identify and facilitate supportive relationships and interactions of BRADFORD MATTHEWS, JR with family members and significant other persons. The temporary guardian may place reasonable time, place, or manner restrictions on communication, visitation, or interaction between BRADFORD MATTHEWS, JR and another person except as otherwise limited by Iowa Code section 633.635(3).

The temporary guardian must obtain prior court approval before exercising any other powers.

**This order and emergency temporary appointment will automatically terminate on January 11, 2024.** BRADFORD MATTHEWS, JR may file a written request for a hearing on the appointment of a temporary guardian, which will be held no later than seven days after the written request is filed.

The clerk of court shall issue letters of appointment to the temporary guardian upon the filing of the temporary guardian's acceptance of appointment and court officer's oath.

Upon application to waive payment of court costs and review of the file, the court finds that court costs should be **waived** at this time. The guardian must notify the court immediately if the financial circumstances of BRADFORD MATTHEWS, JR or the estate change significantly.

**So ordered.**
