#### **LETTER ORDER**

RE: *Sui v. FedEx Ground Package Sys., Inc.*

Dear Mr. Sui and Counsel:

On December 22, 2022, this Court denied plaintiff Shaomin Sui's motion to reopen the case. ECF 65. On January 12, 2023, Mr. Sui filed a motion for reconsideration of that Order. ECF 76. He also filed a supplement and more than 2,600 pages of attachments. ECF 76-1 – 76- 11, 77, 77-1 – 77-7. He states that the voluminous attachments should have been a part of his February 3, 2020 amended complaint, ECF 16, and that his efforts compiling the attachments are "the reason [he] did not find the newly discovered evidence when [he] filed [his] claims." ECF 76, at 2. Plaintiff's motion for reconsideration of the December 22 Order is denied because, Mr. Sui still has not identified a meritorious defense or exceptional circumstances to "cross[] th[e]

initial threshold" for reconsideration, and he has not established any of the grounds for reconsideration in Rule 60(b). *See Wells Fargo Bank, N.A. v. AMH Roman Two NC, LLC*, 859 F.3d 295, 299 (4th Cir. 2017) (quoting *Dowell v. State Farm Fire & Cas. Auto. Ins. Co.*, 993 F.2d 46, 48 (4th Cir. 1993)); Fed. R. Civ. P. 60(b).

Although informal, this is an Order of the Court and shall be docketed as such. The Clerk shall send a copy of this letter to plaintiff and close the case.
