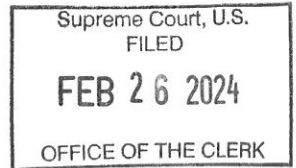

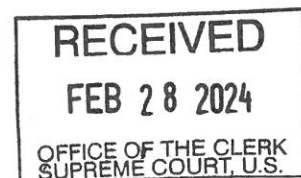

On Petition For Writ Of Certiorari to the United States Court Of Appeals for the Fourth Circuit

Motion for Leave from the Court To Expedite Consideration Of The Petition For A
Writ Of Certiorari, To Expedite Merits Briefing In The Event That The Court
Grants The Petition, And To Expedite Consideration Of This Motion

Pursuant to Supreme Court Rule 21, Dora L. Adkins, Petitioner respectfully
moves for expedited consideration of its petition for a writ of certiorari to the U.S.
Court of Appeals for the Fourth Circuit, filed on February 25, 2024, as well as
expedited consideration of this motion.

The Questions presented by the Petitioner in the petition for a writ of
certiorari in *Dora L. Adkins v. The Ritz Carlton Hotel Company, L.L.C.*, were filed
on February 19, 2024, are not complicated, but straight forward Questions, in that,
the Petitioner argues Clear Errors found in both the Fourth Circuit Court of Appeals'
Opinion and Order and the U. S. District Court for the Eastern District of Virginia's



Orders. Should the Court grant the petition for certiorari, the Petitioner further requests that the Court decide the case this Term. The Petitioner also respectfully requests expedited consideration of this motion.

STATEMENT

The Petitioner filed the petition for a writ of certiorari as unprecedented as one reason for granting the petition, in that, the Petitioner died 18-Times and/or experienced Death from alleged Food and Chemical Poisoning from 45-different food and chemical poisoning incidents filed in Complaints with the Court at the hands of other humans in a timeframe of 19-Years. Without *GOD's Devine Interventions* the Petitioner would not be alive, fairly Healthy, and able to file this Petition on Petitioner's behalf.
