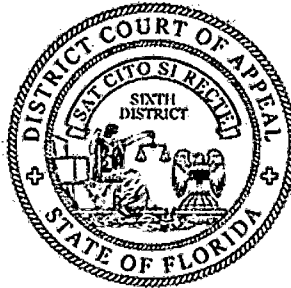

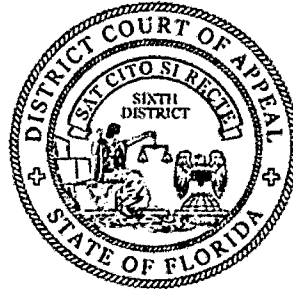


**ORDER SUSPENDING PETITIONER'S TIME-


