As per Supreme Court rule 22 – 4. I would like to renew the Application for a Stay to Chief Justice John G. Roberts.

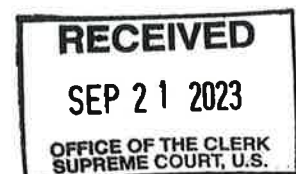

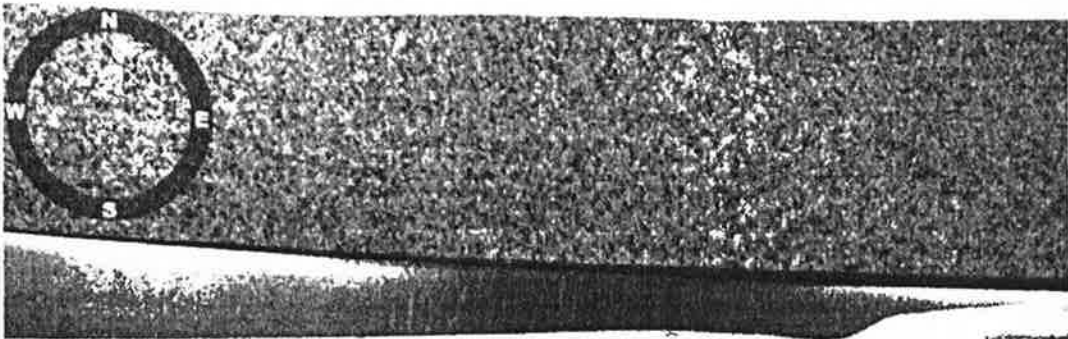
