Court of Appeals for the Ninth Circuit:

Under this Court's Rules 13.5, 22, 30, Petitioner David Wong respectfully requests that the time to file his Petition for Writ of Certiorari in this matter be extended for 60 days up to and including December 4, 2023. The Court of Appeals issued its memorandum on March 29, 2023 (Appendix A). It denied rehearing on July 7, 2023 (Appendix B). Absent an extension of time, the Petition for Writ of Certiorari would be due on October 5, 2023. Petitioner is filing this Application at least ten days before that date. See S. Ct. R 13.5. This Court would have jurisdiction over the judgment under 28 U.S.C. 1254(1). In support of this application, David Wong states as follows:

- 1. David Wong's mother is permanently disabled and now requires long term care for the past year, which David Wong is providing.
- 2. David Wong changed his life to take care of his mom: he now works a negligible amount per of hours month and is responsible for taking care of his mom around the clock. David Wong feeds her, gives her water to drink, helps her go to the bathroom, changes her diapers, and handles many other details that are too numerous to list here. He had hoped to find caregivers to help, but a number of setbacks occurred to his mom's caregivers: one of them had a mom who got into a car accident, and so that caregiver had to take care of her mom while another caregiver recently lost her father.

- 3. David Wong is grateful for the opportunity to take of his mom because it means she is still alive, but it also means taking care of numerous medical, psychological, financial, and other elder care issues.
- 4. This summer David Wong's mother went by ambulance to the hospital twice.

 Each time David Wong made the decision to call an ambulance. It was
 ridiculously stressful because David Wong's father died last year.
- 5. The aftermath of those hospital visits has resulted in several consultations with health care professionals, more blood and lab tests, etc. It is a neverending stream of work. These family responsibilities have made it impossible for David Wong to devote the time needed to carefully consider whether to file.
- 6. David Wong needs the extra time to consider the merits of a Petition for Certiorari.

Conclusion

For the foregoing reasons, Petitioner respectfully requests that the time to file the Petition for Writ of Certiorari be extended 60 days, up to and including December 4, 2023.
