I, WAYNE P. VANCE, BEING DULY SWORN DEPOSES AND SAYS THAT:

1. I AM THE PLAINTIFF-PETITIONER WHO IS CURRENTLY INCARCERATED AT ATTICA CORRECTIONAL FACILITY, 639 EXCHANGE STREET, P.O BOX 149, ATTICA, NEW YORK 14011.

2. I HAVE MADE THIS APPLICATION FOR AN EXTENSION OF TIME TO FILE MY PETITION FOR A WRIT OF CERTIORARI, APPENDICES, MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS, EXHIBITS AND OTHER DOCUMENTS AS A RESULT OF THE WRONGFUL ACTIONS OF THE DEFENDANTS-RESPONDENTS WHO HAVE BEEN PARTICIPATING IN THE DANGEROUS, VICIOUS, IMMORAL AND OPPRESSIVE ACTIVITIES UNDERLYING THE CLAIMS SET FORTH IN THIS CIVIL RIGHTS CASE. I AM ALSO SEEKING OTHER RELIEF FROM THIS COURT BECAUSE THE DEFENDANTS-RESPONDENTS HAS BEEN CAUSING ME TO HAVE PROBLEMS ACCESSING THE LAW LIBRARY ON A REGULAR BASIS; PROBLEMS GETTING LEGAL AND OTHER SUPPLIES; PROBLEMS ACCESSING OR USING A COMPUTER OR TYPEWRITER; PROBLEMS OBTAINING MY CIVIL APPEAL TRANSCRIPTS; PROBLEMS RECEIVING ASSISTANCE FROM FAMILY, FRIENDS AND OTHER PEOPLE; PROBLEMS PREPARING MY LEGAL PAPERS AND SUBMITTING THEM TO THIS COURT AND OTHER AGENCIES; PROBLEMS WITH MY HEALTH AND FUNCTIONALITY; PROBLEMS COMMUNICATING WITH PEOPLE ON A REGULAR BASIS; AND OTHER PROBLEMS AS DESCRIBED IN MY MOTION TO APPEAL, MEMORANDUM OF LAW, OVERSIZE APPEAL BRIEF, LETTERS AND OTHER LEGAL DOCUMENTS FILED IN THE U.S COURT OF APPEALS FOR THE 2ND CIRCUIT BEFORE THEY HAD ILLEGALLY DISMISSED MY APPEAL ON JULY 6, 2023. THE DEFENDANTS-RESPONDENTS HAS BEEN APPLYING SCIENCES AND USING ADVANCED TECHNOLOGY TO PREVENT ME FROM PREPARING MY LEGAL PAPERS ON A COMPUTER OR TYPEWRITER; EFFECT OR INTERFERE WITH MY WRITING AT TIMES; CONTROL MY STROKES OF THE PEN, THE BALL POINT AND INK DISCHARGE ON PAPERS; DELIBERATELY MESS UP THE TEXT OR QUALITY OF MY WORKS; CAUSE ME TO MAKE REDACTIONS, CORRECTIONS AND REWRITE DOCUMENTS TO THE POINT OF EXHAUSTION; DICTATE MY STYLES OF WRITING, THE SIZE OF LETTERS AND SPACING; PREVENT ME FROM WRITING FOR SUBSTANTIAL

PERIODS OF TIME; PROLONG MY LEGAL ASSIGNMENTS; AND CAUSE OTHER PROBLEMS. THE DEFENDANTS - RESPONDENTS HAS BEEN USING DIFFERENT METHODS TO CAUSE DELAYS, HINDERANCES AND OTHER PROBLEMS IN THE APPEAL PROCESS OF THIS CASE. THE U.S DISTRICT COURTS FOR THE NORTHERN DISTRICT OF NEW YORK, THE U.S COURT OF APPEALS FOR THE 2ND CIRCUIT AND STATE OF NEW YORK DEPARTMENT OF CORRECTIONS AND COMMUNITY SUPERVISION HAS REFUSED TO PROVIDE FOR ME TO RECEIVE MY CIVIL APPEAL TELEPHONE CONFERENCE TRANSCRIPTS DATED 12/9/21, 1/27/22, 5/24/22 AND 7/26/22 AFTER I HAD SHOWED AN INABILITY TO PAY OR GIVE SECURITY FOR FEES AND COSTS AS A UNREPRESENTED OPPRESSED INDIGENT LITIGANT WHO WAS ALLOWED TO PROCEED ON APPEAL IN FORMA PAUPERIS STATUS UNDER FEDERAL RULES OF CIVIL PROCEDURE RULE 24, 28 U.S.C.A. THE STATE OF NEW YORK DOCOS HAD ILLEGALLY DENIED ME ADVANCES FOR THE CIVIL APPEAL TRANSCRIPTS AND SUGGESTED THAT I GET A COURT ORDER AUTHORIZING THEM TO APPROVE THE LEGAL PHOTOCOPIES ADVANCES FOR ME TO RECEIVE THE TRANSCRIPTS. I NEED THE TELEPHONE CONFERENCES TRANSCRIPTS TO PLACE THEM IN MY APPENDIX AS CITED MATERIALS IN MY PETITION FOR A WRIT OF CERTIORARI SO IM REACHING OUT TO THIS U.S SUPREME COURT FOR YOUR HELP IN THIS MATTER AND OTHERS. THE U.S COURT OF APPEALS FOR THE 2ND CIRCUIT, U.S DISTRICT COURTS FOR THE NORTHERN DISTRICT OF NEW YORK AND STATE OF NEW YORK DOCOS HAS BEEN CONSPIRING WITH THE OTHER DEFENDANTS - RESPONDENTS WHO ARE APPLYING SCIENCES AND USING ADVANCED TECHNOLOGY TO CONTROL THE FUNCTIONALITY OF MY ORGANS, TISSUES AND NERVOUS SYSTEM TO CAUSE ME TO MALFUNCTION, HEALTH PROBLEMS, PAINS AND SUFFERING. THEY HAVE BEEN CONTROLLING MY NEURAL FUNCTIONS TO MAKE ME INACTIVE, UNABLE TO MOVE OR DO THINGS FOR SUBSTANTIAL PERIODS OF TIME WHILE I'M IN THE PROCESS OF TRYING TO PREPARE MY LEGAL PAPERS FOR THIS COURT AND OTHER PARTIES. THEY ARE BEING UNCOOPERATIVE, DISRUPTIVE, DISRESPECTFUL AND OPPRESSIVE. AS FOR ATTICA LAW LIBRARY OFFICERS AND OTHER STAFF, THEY HAVE BEEN ONLY ALLOWING ME TO ACCESS THE LAW LIBRARY ONCE A WEEK AND ON SOME OCCASIONS I'M NOT ALLOWED TO ACCESS THE LAW LIBRARY AT ALL. I HAVE BEEN HAVING TROUBLES USING THE LAW LIBRARY COMPUTERS AND GETTING NOTARIES, PHOTOCOPIES, PRINTOUTS, LEGAL MATERIALS AND SUPPLIES INCLUDING LARGE MANILLA ENVELOPES IN WHICH THEY KNOW THAT I REALLY NEED FOR MY LARGE FILINGS. I NEED THE EXTENSION OF TIME TO BE AT LEAST 60 DAYS OR MORE BECAUSE I HAVE A LOT OF WORK TO DO AND I'M OPERATING ON THE SET SCHEDULE OF THE OPPRESSIVE DEFENDANTS WHO ARE MAKING THINGS CHALLENGING, DIFFICULT AND IMPOSSIBLE. I WOULD LIKE FOR THIS COURT TO INTERVENE AND GRANT ME AN EXTENSION OF TIME SO THAT I'LL BE ABLE TO FINISHING CONDUCTING MY

LEGAL RESEARCH, FINISH MAKING PHOTOCOPIES, FIND A WAY TO OBTAIN MY CIVIL APPEAL TRANSCRIPTS AND GATHER SUPPLIES, FINISH PREPARING MY LEGAL PAPERS AND FIND A WAY TO DISTRIBUTE MY LEGAL PAPERS TO THIS COURT AND OTHER PARTIES. [SEE EXHIBITS 158 AND 159]

WHEREFORE, I RESPECTFULLY ASK THAT THIS COURT PLEASE GRANT ME AN EXTENSION OF TIME TO FILE MY PETITION FOR A WRIT OF CERTIORARI, APPENDICES, MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS, EXHIBITS AND OTHER DOCUMENTS WITHIN A UNDERSTANDABLE, RESPECTABLE OR GREAT TIME PERIOD.

WHEREFORE, I RESPECTFULLY ASK THAT THIS COURT INTERVENE BETWEEN PARTIES TO DETER OR PREVENT THE DEFENDANTS-RESPONDENTS FROM CONTINUING TO OBSTRUCT JUSTICE AND INTERFERE WITH CIVIL RIGHTS.

WHEREFORE, I RESPECTFULLY ASK THAT THIS COURT PLEASE PROVIDE FOR ME TO RECEIVE THE APPROPRIATE COVERS FOR MY PETITION AND APPENDICES BECAUSE I'M UNABLE TO OBTAIN ANY COVERS FROM THE NYS DOCCS OR ANY OTHER PLACE WHILE IN THE CARE AND CUSTODY OF THE UNCOOPERATIVE AND OPPRESSIVE DEFENDANTS-RESPONDENTS.

WHEREFORE, I RESPECTFULLY ASK THAT THIS COURT ENTER AN ORDER AUTHORIZING THE STATE OF NEW YORK DOCCS TO APPROVE ME FOR LEGAL PHOTOCOPIES ADVANCES FOR ME TO RECEIVE MY CIVIL APPEAL TELEPHONE CONFERENCES TRANSCRIPTS

3. FOR THE FOREGOING REASONS, THIS MOTION SHALL BE GRANTED IN ITS ENTIRETY AND SUCH OTHER AND FURTHER RELIEF AS THIS COURT DEEMS JUST AND PROPER.
