DECLARATION IN SUPPORT OF MOTION FOR EXTENTION OF TIME DUE TO INSTITUTIONAL SEARCH AND CURRENT MODIFIED LOCKDOWN

I, Raul Gardea Jr., am the Petitioner in the above-entitled case. In support of my Motion for Extention of Time is the Institution's P.S.R. 'Program Status Report' attached as Exhibit. A. The P.S.R. notifies the Staff and Inmate Population the Plan of Operation.

Petitioner would like to define the difference between a General Library User (GLU), and Primary Library User (PLU), found under the column Law Library in the P.S.R. GLU would be for general use. The P.S.R. only honors/recognizes PLU important which for this Institution only cocern's Inmate's that have a deadline of 30 days. Nothing else.

This Plan of Operation was initiated May 22, 2023 to cover all yards in the Institution each week per yard, i.e. (A,B,C,D) and an outside facility. Each yard has 5 buildings with the exception of C-yard which has 6. Thus the search was well over a month.

Currently, due to a death on this yard, this yard finds itself on a modified lockdown. Petitioner's C.O.A.'s denial found in Exhibit <u>B</u>, was filed May 12, 2023. Upon receiving the 9th Circuit's ruling VIA Postal Service, Petitioner has not yet been able to set foot in the Law Library to access all relavent Court Rules, proceedures, and available application's or detailed formating. Because of my inability to access the Law Library, Petitioner is attaching to the Exhibit's all original's.

Petitioner prays that this most Highest Honorable Court recognizes the mere fundamental importance just to be able to access the printer itself, which is only available to Inmate's at the Law Library for the necessaty to file not just the duplicates of ones original documentation's, but the quantity of duplicates for the parties involved as well. Petitoner is also hopefull that the Clerk's Office supplies a helpful "Guide for prospective indigent Petitioner's

for Writs of Certiorari".

If this Court is in need of a copy for proof in regards to Petitioner being granted to proceed In Forma Pauperis for the United States District Court, Central District of California, Petitioner is hopeful to have access the Law Library and duplicate Petitioner's original document's to reduce the posibility of never being able to recover the importance of Petitioner's personal original documents in a timely fashion due to any unforeseen unfortunte event.
