FOR AN EXTENSION OF TIME TO FILE  
A PETITION FOR A WRIT OF CERTIORARI

NOW COMES, Petitioner Armin Wand III, pro se, respectfully MOVES this Honorable Court for an order GRANTING an extension of time to file a Petition for a Writ of Certiorari, pursuant to Rule 30.2. In support of this application Wand states as follows:

1. After a three day jury trial a judgment was entered in favor of the Defendants on May 25, 2022.

2. Wand filed a notice of appeal on June 14, 2022.

3. June 16, 2023, the Seventh Circuit Affirmed the judgment to all Defendants except for Defendant Kramer, which the Seventh Circuit appointed counsel for further briefing with a new case number Case No. 23-22040.



4. Wand filed his petition for rehearing and suggestion for rehearing en banc on June 30,2023.

5. July 20,2023,The petition for rehearing and suggestion for rehearing en banc was denied.

6. The petition for writ of certiorari is due on October 18,2023.


7. Pursuant to Rule 30.2,An application to extend the time to file a petition for a writ of certiorari must be filed at least 10 days before the specified final filing date as computed under these Rules.

8. As an incarcerated party who is proceeding pro se they get limited time in the law library. Wand needs adequate time to research applicable cases from other Circuits and prepare a meaningful petition.

Wherefore,for the foregoing reasons the Petitioner Armin Wand III,respectfully request that this Honorable Court for an order granting his extension of time to file his petition for a writ of certiorari until December 27,2023.

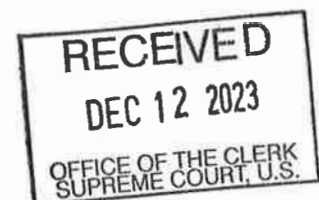
This is an acknowledgment to your October 26,2023, letter. Pursuant to Rule30.4 i am requesting that the application be submitted to Justice Brown-Jackson.

Pursuant to Rule 13.5,the date on which the United States Court of Appeals decided my case was June 16,2023. A timely petition for rehearing was denied by the United States Court of Appeals on the following date July 20,2023. An application for an extension of time to file a Petition for Writ of Certiorari was placed in the institution's internal mail system on October 2, 2023,therefore,pursuant to the mailbox rule the application was filed on that date. The Writ of Certiorari was due on October 18, 2023.

Pursuant to Rule 30.2 An application to extend the time to file a Petition for Writ of Certiorari must be filed at least 10 days before the specified filing date as computed under these; Rules if filed less than 10 days before the final date,such applications will not be granted except in the most extraordinary circumstances. You acknowledge receipt of my application on October 13,2023 and returned the application on October 26,2023. Pursuant to the mailbox rule my documents was filed the date they was placed in the institution's internal mail system which was October 2,2023,therefore,the application for an extension of time was filed 16 days before the final date. The jurisdiction of this Court is invoked under 28 U.S.C.§1254(1).

I am requesting that the entire judgment be reviewed.

As an inmate i get limited time in the library,in order to put a meaniful and adequate petition before the Court i need adequate time to research and prepare the petition for writ of certiorari and the interest of justice would not be served if i am denied the extension.
