

Please forward the extension of time request, pursuant to Rule 30.4,

The motion may be acted on by the Clerk in the first instance, and any party aggrieved by the Clerk's action may request that the motion be submitted to a Justice or to the Court.

to Justice Kagen and the Court for consideration Pro se litigant, Henry Gossage's timely petition for certiorari. Good cause exists for extending the time in which Henry Gossage can file this petition for a writ of certiorari. "For good cause, a Justice may extend the time to file a petition for a writ of certiorari for a period not exceeding 60 days." Sup. Ct. R. 13.5.

Henry Gossage's 60-day extension of time request was timely filed (USPS Priority Mailed on August 15 and corrected on August 28) for the petition of certiorari from the Washington State Supreme Court June 7, 2023 (due September 5, 2023), ORDER and June 26, 2023 (due September 24, 2023), Reconsideration Letter.

1. Henry Gossage timely mailed USPS Priority Mail and filed with this Court on August 15, 2023, a 60-day extension of time. The clerk returned this motion for correction on August 18, 2023. This application was filed more than ten days before the due date.

- 2. On August 28, 2023, Henry Gossage mailed USPS Priority Mail and complied with the Courts August 18, 2023, letter and refiled the August 15, 2023, request for a 60-day extension of time to submit this petition for writ of certiorari. This amended motion/application was filed more than ten days before the due date.
- 3. The August 15 and August 28 requests for extension of time were timely filed and in compliance with the Court.
- 4. Henry Gossage contacted and left many messages to the Court. These messages went unresponsive should be available to the Court.
- 5. On October 7, 2023, Henry Gossage's mailed USPS Priority Mail and filed Petition for Certiorari from the Washington State Supreme Courts June 5th (petition due date September 5, 2023) or June 26, 2023 (petition due date September 24, 2023) decisions.
- 6. The Court neither granted or denied Henry Gossage's timely request for a 60-day extension of time.
- 7. With Henry Gossage's timely filed 60-day extension of time, would extend the petition for certiorari filing date from November 5th or November 24, 2023.
- 8. Henry Gossage's petition for certiorari, with the extension of time is timely filed, regardless which date is used (June 7 or June 26).
- 9. On October 18, 2023, returned the documents as "out of time". However, Henry Gossage's extension of time request to file this petition is timely.

The Courts granting the original extension of time for pro se litigant should not be held to a higher standard for an "extension of time" than the attorney's practicing before the Court. *Haines v. Kerner*, 404 U.S. 519 (1972); *Estelle v. Gamble*, 429 U.S. 97, 106 (1976). This is clearly an important question for the court in reference to criteria standards for the pro se litigant requesting an

extension of time to file a petition for certiorari

- A. Pro se litigant had to research and prepare the petition to the Courts standards.
- B. Petitioner requested Reconsideration of the State Supreme Court Order. Even this Court permits reconsideration of its own decisions from the aggrieved party. The Washington State Supreme Court reconsideration rules conflict with this Court.
- C. Division II Washington Court of Appeals decision in this case is in direct conflict with the Washington State Supreme Court in *Optimer International v. Rp. Bellevue*, 170 Wn 2d.768 (2011) and Division I Washington Court of Appeals in *Optimer International v. Rp. Bellevue*, 151 Wash. App. 954 (2009).

D. This case brings to the forefront a pro se litigant fundamental Constitutional due process and equal protection of the law questions appearing in the

Washington State Court.

Petitioner presents Medical and as DAV Chapter #41 Service Officer and Sr.

Vice Commander obligations. On request, ongoing medical treatment 2-3 days per

week, VA PSHCS medical and community care appointments.
