TO THE HONORABLE ELENA KAGAN, ASSOCIATE JUSTICE OF THE SUPREME COURT OF THE UNITED STATES, AND CIRCUIT JUSTICE FOR THE UNITED STATES COURT OF APPEALS FOR THE NINTH CIRCUIT:

AT&T Services and AT&T Benefit Plan Investment Committee respectfully request a 30-day extension of time, to and including Monday, April 8, 2024, in which to file a petition for a writ of certiorari to the U.S. Court of Appeals for the Ninth Circuit.\* S. Ct. R. 13.5. Applicants previously filed an application seeking a 30-day extension, which Justice Kagan granted, extending the time to file a petition to and including Thursday, March 7, 2024. *AT&T Servs.*, *Inc.* v. *Bugielski*, No. 23A637 (Jan. 11, 2024).

- 1. An extension of time is necessary to permit counsel to prepare a petition that is comprehensive, concise, and helpful to the Court, given the press of other pending matters, including *Truck Insurance Exchange* v. *Kaiser Gypsum Co.*, No. 22-1079 (U.S.); *Grosso* v. *AT&T Pension Benefit Plan*, No. 22-1701 (2d Cir.); *A.B.* v. *Salesforce, Inc.*, No. 23-20604 (5th Cir.); *United Behavioral Health* v. *U.S. District Court*, No. 24-242 (9th Cir.); *Rooks* v. *Peoria Unified School District*, 2:23-cv-2028 (D. Ariz.); *M.D. ex rel. Stukenberg* v. *Abbott*, No. 2:11-cv-84 (S.D. Tex.); and *HouseCanary, Inc.* v. *Title Source, Inc.*, No. 23-0778 (Tex.).
- 2. Applicants are unaware of any party that would be prejudiced by a 30-day extension.
