

Before Rosenbaum, Grant, and Brasher, Circuit Judges. BY THE COURT:

Dexter Jackson, in the district court, moved for leave to proceed on appeal *in forma pauperis*. The district court denied the motion. However, the district court did not assess the \$505.00 appellate filing fee, as is required under the Prison Litigation Reform Act of 1995, 28 U.S.C. § 1915.

Because Jackson has consented to paying the filing fee, the only remaining issue is whether the appeal is frivolous. See 28 U.S.C. § 1915(e)(2)(B). This Court now finds the appeal is frivolous, DENIES leave to proceed, and DISMISSES the appeal. Jackson's motion for appointment of counsel is DENIED AS MOOT.
