9 Moreover, the current due date for S283090
10 would be May 14, 2024 and the proposed
11 extended due date would be Saturday
12 July 13th, 2024 (accordingly under case #
13 S282446 the present due date would be
14 March 13, 2024 and proposed extended due
15 date of May 12th, 2024).

16 These extension requests are made for
17 good cause given petitioner remains without
18 legal representation and permanently disabled
19 since December 22, 2015. Moreover, petitioner
20 remains a target of those who obstruct
21 justice and sponsor prostitution. In fact,
22 petitioner has been involved in two
23 different "Hit + Run" events on August 24, 2023
24 and October 7th, 2023, both of which were
25 reported to local Police (Santa Ana Police
26 and Costa Mesa Police). Petitioner
27 also is part of weekly Physical Therapy
28 and under care of 3 Medical Doctors

courts.

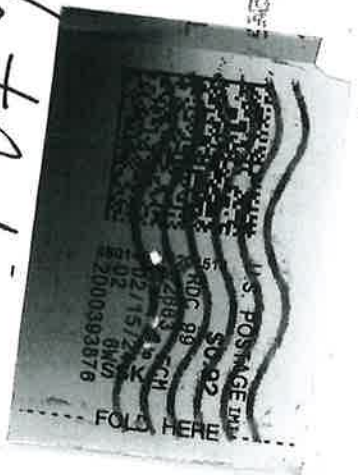
