Dear Judge Spence,

Lam in receipt of your March 27, 2024 736am email which indicated the following:

- 1. Motion Hearing will be held via Zoom with in-person option. This is being done without making a value judgement to my claims of safety concerns and financial constraints.
- 2. A Court reporter will be provided by the US Bank.
- 3. All proper matters before the Court will be addressed, including whether this current case actions are stayed due to Supreme Court proceeding in process.

Below are my responses:

First, please forgive my delayed reply.

Next, thank you Judge Spence, for permitting Zoom usage for the hearing.

Thirdly, I have four statements/questions I would like to make, please:

- *Since the Court declines to make a value judgement on my claims of safety concerns and financial constraints, how should my safety concerns be addressed?
- *Proper matters: My understanding of this is—as per the explanation provided to me during the Status Conference—proper matters are all documents, motions, etc filed through the Clerk of Court office. Does this mean Federal documents will also be taken into account? Also, since the Court has been presented with a mirage of evidence of suspected document tampering, partial treatment (delayed filing, misfiled documents, filing of document not submitted, etc), how will proper matters be determined before the hearing, to ensure impartial treatment and all properly submitted documents are equally addressed?
- *Despite my NY State residency, my request for pre-hearing review of the multiple filings of motion to change venue to Federal Jurisdiction is denied. Instead , this motion will be heard at the hearing, including but not limited to the motion to dismiss. Please correct any misunderstandings present.
- * I am terribly concerned that, excluding my motions to proceed informa pauperis and removal of guardian ad litem-that I recall--not one of my motions have been addressed by the Court; please correct me if I am wrong. However, in
 contrast, the Court approved many US Bank motions [move to inactive roster; move to active roster; meeting with the
 Court in which I was not present/made aware of; suspectedly given approval to acquire my home, etc] all without a
 hearing [that is, without a hearing I was informed of]. What are the requirements to get motions addressed informally
 and as expeditously as US Bank National?
