### APPLICATION FOR EXTENSION OF TIME TO FILE PETITION FOR CERTIORARI REVIEW

#### INTRODUCTION AND OPINIONS BELOW

The Petitioner is a federal prison inmate who is currently incarcerated in the United States Penitentiary in Tucson, Arizona. On February 8, 2024, the Eleventh Circuit Court of Appeals issued an unpublished opinion, 2024 WL 490839

RECEIVED MAY - 2 2024 (11th Cir. 2/8/2024), affirming the district court's denial of Petitioner's motion filed pursuant to 28 U.S.C. § 2255.

Petitioner had been represented by counsel in the district court and on appeal before the Eleventh Circuit however, petitioner, who has no legal training, is now proceeding *pro se.* 

Petitioner is currently in transit from one federal facility to another and does not have access to his legal documents and materials, as they were shipped by the BOP to the new facility to which he has now been designated. Despite Petitioner's best efforts it will not bepossible for him to complete the preparation of the petition in the time prescribed, and as such, Petitioner is requesting a sixty (60) day extension within which to submit the petition.

#### **JURISDICTION**

The judgment of the United States Court of Appeals for the Eleventh Circuit was entered on February 8, 2024. The jurisdiction of this Court to review the judgment of the Eleventh Circuit is conferred under Title 28 U.S.C. § 1254(1) and Supreme Court Rule 10.

WHEREFORE, the Petitioner moves this Court for a sixty (60) day extension of time to file a Petition for Certiorari Review.
