RULE 40'S MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS (AS A VETERAN) AND ON PAPER

To the Honorable Supreme Court of the United States.

Petitioner Maritza Ortiz, in forma pauperis (PRO SE), very respectfully, expresses and requests:

1. The petitioner asks for leave to file the forthcoming petition for a writ of certiorari on paper, without prepayment of costs or to proceed in forma pauperis, as a veteran. Petitioner has previously been granted leave to proceed in forma pauperis in the following court(s); Supreme Court of the United States. Maritza Ortiz v. Nydia Z. Jiménez-Sánchez, Number 15-1547 (Application Number 16A564), etc. This Honorable Supreme Court's Rule 40 states:

“...A veteran suing under any provision of law exempting veterans from the payment of fees or court costs may proceed without prepayment of fees or costs or furnishing security therefor and any file a motion for leave to proceed on papers prepared as required by Rule 33.2 The motion shall ask leave to proceed as a veteran and be accompanied by an affidavit or declaration setting out the moving party’s veteran status. A copy of the motion shall precede and be attached to each copy of the petition for a writ of certiorari...filed by the veteran...,” Rule 40, Veterans, Seamen, and Military Cases, Rules of the Supreme Court of the United States (2022).


WHEREFORE, we very respectfully request that this highest court of the land of Puerto Rico:
