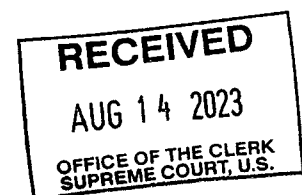

**MOTION TO DIRECT THE CLERK TO FILE THE PETITION**

1) Constance Wilson Andresen (Pro-se Petitioner) comes humbly before this court to request that the Motion will be considered by the Justices to direct the Clerk of the Court to file the Petition for a Writ of Certiorari, and its appendixes herein addressed in the attached letter from the court for the following reasons, which are given and sworn to under the penalties of perjury.

2) Attachments will be labeled and addressed as to their content and concerns for the Honorable Justices to address in this Motion as to the importance of this issue to all Americans and our Constitution.

3) Noting that Petitioner is Pro-se, that the attorney listed, John Piskora, Esq. is only for receiving mail, as in the lower cases, Defendants and their counsel were misdirecting mail that led to having to address that to the courts and the Post Master General of which is all part of the records of the Civil lower Cases of 2015-1651 and the US Federal District Court 1-20-cv-989.



4) Petitioner tried very hard to fully comply with all the Rules and manners of proper timely filings and was also noted that she did comply in all lower cases. Attached are the Docket cases of the last two cases of the US Federal District Case 1-20-cv-989 and the Civil Appeal case to the 3<sup>rd</sup> Circuit at Philadelphia PA (all also is online to review) to aid in ease of the Docketed filings to seek just one Day of Discovery.

5) Plaintiff in all lower cases was never electronic and filed always Pro-se by paper with all proper service to all parties of record and in compliance to the rules.

6) Petitioner in this now case before the SCOTUS is humbly before the court as for now 14 years, Discovery, Due Process, and Deposition, all DENIED in all former cases in the Civil Cases also shown in the attachment which was part of the Appendix of the Writ of Certiorari filed by Petitioner along with also having filed a Table of Contents,

Statutes and all that was required in the Rules of filing of the Petition to this court.

7) Also in the false criminal case (which all false charges of Forgery were Dismissed and expunged and current before the same Judge in Huntingdon who refused to recuse in the criminal case to remove #14 of the No Contest Plea. He was corrupted. Denied even finishing the Preliminary Hearing on August 8, 2018 in front of Magistrate Covert, with threats in the transcript and also no holding a proper Pre-Trial and again threats to silence Constance Wilson Andresen. All in the body of the cases below.

8) Attached is the issues that arose on the confusion, the extreme efforts by a Pro-se Petitioner, who is over the age of 62, and with one might say, battle fatigue in just wanted Discovery to be heard for one day and living daily with the injury and PTSD from the assault and attacks that remain ongoing.

9) Each piece shows the timing of the filing of the Writ, the tracking of the filing in an attempt to insure that the time to file was in order. Clearly with all shown in a

small town area where access to Federal Express shut down early, (4 PM) and even the local post office window to use was closed on July 31, 2023.

closed to meter the mail on July 31, 2023 as the time of shut down caused then Petitioner to have another party drive her to the next town of State College PA whereby the shipment of the original, 10 full sets, affidavit of service, and supply all the copies of all the lower court cases (even though they were online accessible) so that the Justices might have an ease of review along with Questions, Table of Contents with each page number appearing in the Writ per the Appendix marked (A, B,, C,, D, E, F) A list of Case law, and Statues and Federal Law that was applicable to the Writ of Certiorari.

10) Also a the calendar having holiday in May, two days in June, and the 4<sup>th</sup> of July in July, were mistaken to Petitioner. So Pettitioner was up for days catching up copying from home printer, with days of no sleep in order to attempt at what is the last available court to hear this on Discovery.

11) Sadly, my only sister died on May 22, 2019, just months after my beloved Father on February 9, 2019. I never saw my Father to say Goodbye due to ice storm and being driven to Mount Nittany Medical Center in State College PA. The saddest day of my life as he was awaiting to have his one day in court to save our family farm of 1911 that was stolen. I was falsely arrested on the first day of Discovery June 21, 2018 to Stay that first day of Interrogatories of the parties who sold a farm Ronald Detwiler that he never owned, filed a false title chain since September of 1977 into the Recorder's office and they all were covering this up. They charged me with stealing a farm (which I already owned). My leg is shown in the attached physical Injury caused by Trooper Thomas. In addition. My legal research assistant I was on the phone with had recorded the abuse of Trooper Thomas screaming, yelling, and he was asked to await outside by

my cousin as I was dressing. This assistant was a fellow usher at the National Cathedral and always took care in calling in on my Father. (I was giving him all the information as I had just moved my Father to a new care center Centre Crest in Bellefonte, PA on June 13, 2018) from Heartside Rehabilitation Skilled Nursing Care, State College, PA.


12) Assistant found deal on a wellness check on July 9, 2021 just days before he was appearing in person with that recording to be before Judge Ammerman's Hearing on July 27, 2021 on the legal fee award to the Defendants as it was only remanded for fees from the Appeal where Oral Argument was stopped the very day before it was granted. It is a clear pattern all documented and evidenced. This is the Civil Case 2015-1651 whereas Judge George Zanic recused himself and gave it to Judge Frederic Ammerman one county over but would not recuse himself from the bogus Criminal Case, which had same parties, same issue the theft of the farm. Three Motions were sought for Zanic to recuse himself. Ammerman merged the two cases by his own Order on July 11, 2018, and STAYED the Civil Case. I was illegally arrested on the first day of June 21, 2018 for the Interrogatories and Depositions of the Defendants where one sold a farm he did not own and the purchasers his cousins, bordering our farm of 42 acres as shown on the website [www.savethewilsonfarmof1911.com](http://www.savethewilsonfarmof1911.com) . All evidence of a Wilson Family Irrevocable Trust of April 19, 1977 was ignored and blocked. Only the two Trustees could sign being myself and/or at that time Martin R. Pollner, Esq. A well known lawyer who served in the Department of Justice, Interpol, as Assistant to the Treasury. Upon his death John Piskora of Loeb & Loeb replaced Martin R. Poller who at the time of his death was at Loeb & Loeb.

13) All my surgeries and medical records are in the record of the US District Federal case 1-20-cv-989, and all the witnesses to the attack were blocked from giving their depositions that were granted and Discovery stopped on the other 9 Depositions.

14) It is in the public interest and especially Elders and the Financial Abuse they experience as shown on my website created [www.savethewilsonfarmof1911.com](http://www.savethewilsonfarmof1911.com) that shows also my work to encourage Elders Day in Pennsylvania to become June 15.

15) All that is asked at this stage is for the Justices to Order the Clerk to file the Writ of Certiorari per the rules and consider that for 14 years I have been threatened abused, falsely arrested, harmed financially, emotionally, and physically. The local corruption is huge in the small town of Huntingdon PA and they are doing all in their unclean hands from the very lawyer first hired to represent my Father, he also was conflicted. The Judge Zanic same players that also had a lawyer Kimberly Kitchen in the same timeframe practicing law without a license for 10 years and I uncovered that doing my simple attempt to get Discovery.

16) I have included what I presumed should be given and hope it is helpful to the Justices. I am so appreciative of this opportunity to have the Writ of Certiorari to be Ordered. I have not yet received the box of the original and (10) copies but felt I wanted to forward this as soon as possible to the good Court of the Supreme Court of the United States of America. This is multiple cases of a pattern to block Discovery.
