17 **MOTION TO DIRECT THE CLERK TO FILE THE**
18 **PETITION FOR WRIT FOR CERTIORARI OUT OF TIME**

20 Petitioner, Jasper Crook, files this motion to direct the clerk to
21 file the petition for certiorari out of time.

23 In support of this Motion, Petitioner states as follows:

25 1. Petitioner is a pro se litigant.

2. District Court Judge James V. Selna, dismissed Petitioner's 42 U.S.C § 1983 action without acknowledging the merits of the case and for lack of court filing payment on February 17, 2022.
3. Petitioner then filed an appeal for injunctive relief with the Ninth Circuit Court of Appeals along with paying the required court filing fees.
4. Ninth Circuit Court Judges Owens and Bumatay denied non-felon Petitioner's motion for injunctive relief (return of firearms and ammunition) on June 14, 2022.
5. One year after Petitioner's case was dismissed by District Judge Selna, the case was forwarded to the Ninth Circuit Court of Appeals by Judge Selna. Petitioner was unaware his action had been reopened.
6. Ninth Circuit Court Judges Clifton, R. Nelson, and Bress again dismissed Petitioner's case on April 20, 2023 without the Petitioner's opportunity to brief the court on the constitutional requirement of "free justice and open courts".
7. It does not appear that the judiciary holds itself to the scrupulous punctuality that it demands of a pro se litigant.

CONCLUSION

For the aforementioned reasons, this Court should grant Petitioner leave to file this motion to direct the clerk to file the petition for writ of certiorari out of time.
