Comes this day Angela Dawn Miller, Pro se and moves this Honorable Court to allow her PETITION FOR A WRIT OF CERTIORARI to the SUPREME COURT OF THE UNITED STATES to be filed out-of-time. Petitioner understands the order was electronically filed October 24, 2023. However, Petitioner did not receive notice of the order at the facility via US Mail until November 2, 2023. 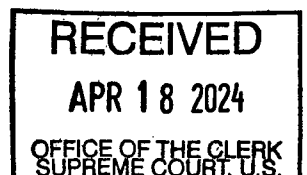
