I represent respondent Elizabeth M. Whitehorn in the above-captioned matter. On June 16, 2025, this Court directed respondents to file a response to the petition for a writ of *certiorari* by July 16, 2025. Pursuant to Supreme Court Rule 30.4, respondent Whitehorn respectfully requests a 30-day extension of time, to August 15, 2024, to file her response. Counsel for petitioner has authorized me to state that petitioner does not oppose this request.
