**Certificate Of Compliance And Word Count**

The Petition for a Writ of Certiorari (Petition) and Appendix For Petition for a Writ of Certiorari (Appendix) are prepared per Supreme Court Rules 14, 33, and 34.

Per Rule 33.1(h), this Petition and Appendix were “prepared under Rule 33.1” and are “accompanied by” this “certificate signed by the” “unrepresented party,” “stating that the brief complies with the word limitations”.

Per Rule 33.1(h), for Petition, “the number of words in the document” is 8,973.

Per Rule 33.1(g)(i), this Petition complies with the “9,000 words” limit.

Per Rule 33.1(h), “the person preparing the certificate” did “rely on the word count of the word-processing system of the document”.

Per Rule 33.1(h), “the word-processing system” was “set to include footnotes in the word count”.

Per Rule 33.1(d), the “word limits do not include the questions presented, the list of parties and the corporate disclosure statement, the table of contents, the table of cited authorities, the listing of counsel at the end of the document, or any appendix”. “Verbatim quotations required under Rule 14.1(f) and Rule 24.1(f), if set out in the text of a brief rather than in the appendix, are also excluded.”

Per Rule 33.1(h), this “certificate is signed by” “the unrepresented party” so it need not “contain a notarized affidavit or declaration in compliance with 28 USC §1746”.

Per Rule 33.1(h), this certificate accompanies “the document when it is presented to the Clerk for filing and” is “separate from it”.

Per Rule 33.1(c), Petition and Appendix are in “booklet-format document” and “produced on paper that is opaque, unglazed, and not less than 60 pounds in weight”.

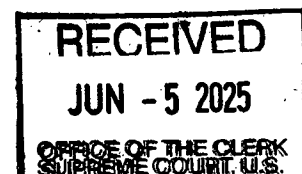
Per Rule 33.1(e), Petition and Appendix have “a suitable cover consisting of” 67-pound “weight paper in the color indicated on the chart in subparagraph 1(g) of this Rule”. “

Per Rule 33.1(g)(i), Petition and Appendix have a “white” cover.

Per Rule 33.1(e), Petition and Appendix have “adequate contrast between the printing and the color of the cover.”

Per Rule 33.1(e), a “separate appendix” “is filed” and “the color of its cover “ is “the same as the color of the document it supports”.

Per Rule 14.1(g)(ii), Appendix “material required by this sub-paragraph is voluminous,” so it is “presented in a separate volume” with the “appropriate {white} cover”, per Rule 33.1(e) and 33.1(g)(i).



Per Rule 33.1(c), Petition and Appendix have “margins of at least three-fourths of an inch on all sides”.

Per Rule 33.1(c), Petition and Appendix are “bound firmly in at least two places along the left margin” with saddle stitching, “so as to permit easy opening, and no part of the text” is “obscured by the binding”.

Per Rule 33.1(c), Petition and Appendix do not use “spiral, plastic, metal, or string bindings”.

Per Rule 33.1(a), Petition and Appendix are “prepared in a 6 1/8- by 9 1/4-inch booklet format”. The booklet sheets are 12.25” wide and 9.25” height when opened. When the booklet is folded and saddled stitched, the booklet-format is 6.125” x 9.25”.

Per Rule 33.1(b), the typeset is “Century family (e. g., Century Expanded, New Century Schoolbook, or Century Schoolbook)”.

Per Rule 33.1(b), the “type” is “12-point type”.

Per Rule 33.1(b), the “typeset” is “2-point or more leading between lines”.

Per Rule 33.1(b), “quotations in excess of 50 words” are “indented”.

Per Rule 33.1(b), the “typeset of footnotes” is “10-point type with 2-point or more leading between lines”.


Per Rule 33.1(f), for Petition and Appendix, “Forty copies of a booklet-format document” are submitted.

Per Rule 33.1(f), because petitioners are unrepresented parties, the Petition and Appendix have “not been submitted to the Court’s electronic filing system”. Therefore, “one unbound copy of the {Petition and the Appendix} document{s} on 8 1/2-by 11-inch paper” are “also” “submitted”.

Per Rule 38(a), “the fees charged by the Clerk” “for docketing a case on a petition for a writ of certiorari” of \$300.00 is attached.

Per 28 USC §1746, I declare under penalty of perjury that the foregoing is true and correct.
