## Application for Extension of Time to File Brief in Opposition

Pursuant to Rule 13.5, I, Wenbin Yang, respondent in *Yue v. Yang* (California Court of Appeal, No. A168295, Dec. 2, 2024), request via the Electronic Filing System a 30-day extension to file a Brief in Opposition, from July 17, 2025, to August 16, 2025.


### Case Background

Petitioner Dongxiao Yue's certiorari petition challenges the California Court of Appeal's December 2, 2024, judgment, alleging trial court violations of Fourteenth Amendment due process and equal protection, constituting structural errors. Yue claims evidence preclusion, biased comments ("not U.S.-trained lawyer," "wasting time"), and judicial advocacy and judgment for me (App. 35a–55a). The Court of Appeal rejected these, citing Yue's failure to raise constitutional objections (*Geftakys v. State Personnel Board*, 138 Cal.App.3d 844), missing first-day transcript (*Foust v. San Jose Construction Co., Inc.*, 198 Cal.App.4th 181), and insufficient evidence.

### Reasons for Extension

As a pro se respondent (Chinese-Canadian, no legal training), I need additional time due to:

- Case Complexity:** Yue's constitutional claims (due process, equal protection) cite complex precedents (e.g., *In re Murchison*, 349 U.S. 133), requiring research into the Court of Appeal's rebuttals (App. 35a–55a).
- Record Review:** The incomplete trial record (App. 42a) necessitates analyzing Appendix D (App. 24a–41a) to address Yue's allegations.
- Personal Circumstances:** Balancing work and recent health issues (a severe cold for about ten days, June 20-30, 2025) limits preparation time.
