The opinion of the U.S. Court of Appeals for the Fifth Circuit, dated June 6, 2024 is included in the Appendix (“App.”) at 1a. The final judgment and order of the U.S. District Court for the Western District of District of Texas, Austin Division, dated February 23, 2024, is included at App.3a, 5a.



JURISDICTION

The final opinion of the U.S. Court of Appeals for the Fifth Circuit was entered on June 6, 2024. (App.1a). The jurisdiction of this Court is invoked per 28 U.S.C. § 1254(1).



STATEMENT OF THE CASE

The CIA turned my life into a playground where the gangs' stalkers to continually stalked at me such that I remained under threats and harassed psychologically. CIA applied the inevitable major powers that stalled my life completely by implicating an issue that convinced the angry members of the public to subject me into a situation of damnation, horror, contempt and mockery for over 20 years.

With the CIA support to the enemy destruction's secret planned, Bor people started facing a series of unprecedented attacks since 2005, by unknown gunmen from the neighboring communities which finally led to uprooting of the entire community from their villages after the South Sudan independent. Now the remnant are living in the displaced centers and in the neighboring countries refugee camps.
