TO THE HONORABLE SONIA MARIA SOTOMAYOR, JUSTICE OF THE SUPREME COURT OF THE UNITED STATES AND CIRCUIT JUSTICE FOR THE SECOND CIRCUIT:

Pursuant to 28 U.S.C §2101 (c) and Rule 13.5 of the Rules of this Court, Petitioners John Garland, et al., pray for a 60-day extension of time to file their petition for certiorari in this Court to and including, July 5, 2024.

The summary order of the 2<sup>nd</sup> Circuit Court of Appeals entered on February 6, 2024, in Case No. 23-663. A copy of the Summary Order is enclosed. Petitioners' time to petition for certiorari in this Court expires May 6, 2024. This application is being filed more than 10 days before that date.

It was necessary for Petitioners to retain new legal counsel for a petition for certiorari. Petitioners, working with the support of a non-profit organization having limited resources, was unable to finalize arrangements with legal counsel for these purposes until April 26, 2024.
