INTEREST OF *AMICUS CURIAE*¹

The National Association of Parents, Inc. (“ParentsUSA”) is a secular nonpartisan 501(c)(3) nonprofit national organization with its offices located in Atlanta, Georgia. ParentsUSA exists to serve all legal parents; i.e., mothers and fathers, married or unmarried, biological or adoptive,² and their children throughout the United States. One of the missions of ParentsUSA is to preserve and support the parent-child relationship by protecting the constitutional rights of parents — as those rights have been recognized by this Court. SUMMARY OF ARGUMENTS

Petitioner more than adequately presented the legal issues before this Honorable Court and supported such arguments with citations of authority and argument to which ParentsUSA doing so would likely be redundant and add little additional citations and arguments for this Court to consider when determining whether to grant the *Petition for Writ of Certiorari*. Instead, ParentsUSA argues that the *Rooker-Feldman* doctrine should not stop lower federal courts

from exercising appellate jurisdiction over state judgments adverse to aggrieved parents if the fundamental constitutional rights of parents to decide for their children and to guide their upbringing are truly to be honored, as this Court time and time again has held including in *Troxel v. Granville*, 530 U.S. 57 (2000), a plurality decision.

Since 2000, courts and litigants have used *Troxel v. Granville* to support and expand or to detract and limit the fundamental constitutional rights of parents. Litigation has exploded nationwide as legislatures have expanded the circumstances under which nonparents can initiate or can intervene in cases concerning the legal and physical custody, visitation, decision-making authority, visitation (a less offensive word, yet still the taking of a child from a parent for a period of time), equitable caregiver, guardianship, and other terms utilized to disguise or to describe accurately what will happen to children or what the arrangement will be.

Government has expanded its intrusion into family life under the claim that doing so is necessary to protect children from harm. Protecting children from harm always *sounds* good. Unfortunately, any task or goal, as admirable and positive as it may sound, is at risk of abuse by those individuals empowered. Nothing could be more apparent than the current nationwide fervor generated over the-day-before-Halloween arrest caught on bodycam of a mother in Mineral Bluff, Georgia, population 370, whose 10-year-old home schooled son, days away from turning 11, had walked 9/10ths of a mile into the sleepy town in the middle of the day without her knowledge or consent. The arresting officer falsely proclaimed that it was

illegal for a 10-year-old to walk to the store. Contrast, the next day, on Halloween, children of all ages, some accompanied by a parent, many without a parent, dressed in costumes and knocking on strangers' and neighbor's doors in the dark, yet there were no reports of parents being arrested.³

Inclusion of this event is not gratuitous, but is to assist the Court in recognizing that, yes, indeed abuses of power takes place routinely against parents and their children, as is further developed herein, and the issues presented by Petitioner affect hundreds of thousands of parents each year. It simply cannot be denied that parents are aggrieved and they must be provided complete due process in courts unaffected by local politics and local community pressures and nuances; e.g., federal courts.

State and local law enforcement and social services case workers (DFCS, CPS, and other names of such government entities as they vary state to state) have enormous power, often wielded without judicial oversight such as when child "protective agencies" act warrantless. Even when warrants are obtained, all within the legal system are aware of the low bar to issuance of a warrant. Abuses of such powers occur. Legislatures and Agencies are slow to react, if they react at all, to curb such abuses. Litigation is the method by which aggrieved parents and their children can seek nonmonetary relief (and, in appropriate cases,

seek monetary compensation). Litigation is also how such future abuses are discouraged, which protects parents and their children other than the litigating parents.

Federal courts should be as receptive to the exercise of appellate jurisdiction for aggrieved families as they are for businesses and individuals in non-family related cases. Family cases, such as the one that prompted Petitioner to go to court, too often begin in a small jurisdiction in which the various parties and actors know one another, are related, classmates from an early age, and local politics impact outcomes. On appeal in state courts, the facts found at the trial court are generally not reviewed making state court appeals an empty promise of justice. The frequency with which aggrieved parents claim or cry “corruption” can be interpreted as the disappointed and losing party blaming someone or something other than the actual facts including their own behaviors *or* as indicating something is horribly wrong with the application of good intentions through humans some of whom hold less than honorable intentions. Just because a person holds a title with a government agency, there simply is no assurance that person is incapable of acting with evil intentions and due process requires aggrieved parents are afforded full review including by federal courts.

As set forth herein, below, ParentsUSA contends that the *Rooker-Feldman* doctrine should not stop lower federal courts from exercising appellate jurisdiction over state judgments adverse to aggrieved parents and Petitioner’s *Petition for Writ of Certiorari* should be granted with full briefing on the merits.

ARGUMENTS

This Honorable Court Should Grant The *Petition For Writ Of Certiorari* And, Upon Consideration On The Merits, Hold That The *Rooker-Feldman* Doctrine Should Not Stop Lower Federal Courts From Exercising Appellate Jurisdiction Over State Judgments Where The State Judgment Neither Awarded Nor Denied Damages, As Is Always The Situation Presented In State Court Actions Wherein The Rights Of Parents And Their Children Are At Issue.

A. FEDERAL COURTS SHOULD BE AS HOSPITABLE TO CHALLENGES BY INDIVIDUALS TO VIOLATIONS OF CONSTITUTIONAL RIGHTS AS TO CLAIMS AGAINST GOVERNMENT REGULATION.

Iniquitous: Grossly unfair and morally wrong⁴

What happens to parents and their children too often is iniquitous (this word is used purposely). Children ripped from parents, parents labeled and wronged. Relief not within reach. The continued denial of access to federal appellate jurisdiction also would be iniquitous.

Ever quotable, Justice Scalia shared a characteristically colorful insight in 2011 while testifying before the Senate Judiciary Committee:

⁴ “Something that is *iniquitous* is extremely immoral or wicked, such as an *iniquitous* political regime that assassinates its enemies. Use the adjective *iniquitous* to describe something that is truly bad, morally wrong, extremely wicked, or completely unfair. It’s a strong word — don’t use it lightly.” <https://www.vocabulary.com/dictionary/iniquitous>

[I]f you think that the Bill of Rights is what sets us apart, you are crazy. Every banana republic has a bill of rights.... [J]ust words on paper. What our Framers would have called a "parchment guarantee."... [T]he real key to the distinctiveness of America is the structure of our Government. One part of it... is the independence of the judiciary.... (1) A decade later, at Scalia's former academic home, University of Chicago Law Professor Aziz Z. Huq⁵ has set forth his own account of the relationship between constitutional structure, the judiciary, and individual liberty. In his latest work, *The Collapse of Constitutional Remedies* (*Collapse*)--which he describes as "a book about how and when we have remedies for constitutional wrongs," and "when and why we don't" (2)--Huq espouses the Scalia-esque notion that the Bill of Rights, without an institutional mechanism for effectuating its guarantees, is nothing more than ink on parchment.

But Huq parts ways with the late Justice when it comes to the role of governmental structure in securing individual freedom.

Huq asserts that America's constitutional architecture has faltered, leaving courts unreliable guardians of "We the People's" rights. Indeed, he begins his case before the book is even opened, with the cover depicting a building in shambles. This construction/destruction theme is reinforced in the pithy titles of the book's five chapters: Blueprint, Building, Remedies, Collapse, and Remains. At 160 pages, Collapse itself is slim. But don't let its concision fool you. Huq undertakes an ambitious historical inquiry into "why federal courts behave as they do" (3) and, based on this analysis, calls for reforms intended to address the modern judiciary's perceived failings.

Huq's starting point is uncontroversial enough: "The Constitution contains many... rights. None enforces itself. Without a remedy, a right has no practical value." (4) The consensus melts away, however, as Huq unveils his principal thesis: when it comes to righting constitutional wrongs, "[r]emedies are not doled out in an even-handed way." (5) To illustrate his point, Huq juxtaposes the treatment of two Supreme Court litigants in 2020. Victorious was Seila Law

LLC, a small California-based law firm, which persuaded the Court that restrictions on the President's authority to remove the Director of the Consumer Financial Protection Bureau (CFPB) violated the separation of powers. (6) Defeated was Alexander Baxter, a homeless arrestee whose case the Court declined to review, leaving intact a Sixth Circuit ruling that police officers who released a dog on the nonresisting Baxter were protected by qualified immunity. (7) That controversial doctrine--arguably "the main source of the right-remedy gap" in public law today (8)--shields police, among other officials, from damages liability unless they violate "clearly established" constitutional rights. (9) This is an exacting standard in practice. Qualified immunity, in its most robust iteration, has been described as protecting "all but the plainly incompetent or those who knowingly violate the law." (10)

According to Huq, the disparate outcomes in the Seila Law and Baxter cases evince a pattern: litigants who "bridle against government regulation tend to have an easy glide path into federal court," particularly when their complaints relate to the Constitution's "structural limits on the power of government," such as "separation of powers and federalism.... But when an individual challenges illegal violence... as a violation of constitutional rights," federal

courts are "less hospitable." (11) Huq cites a variety of legal rules, including qualified immunity, that purportedly exemplify this double standard. (12) Their combined effect, Huq argues, is that today, "most individual constitutional wrongs that reach a federal court yield no remedy"-and that "judicial action on constitutional questions deepens economic, social, and racial hierarchies."

B. THUS, FEDERAL COURT APPELLATE JURISDICTION SHOULD BE ACCESSIBLE.

Regrettably for Petitioner and for other parents similarly situated across the USA, social services workers, law enforcement, and, yes, even courts fail to follow this Court's long recognized constitutionally protected interest of parents to raise their children without undue state interference.

The fundamental liberty interest of natural parents in the care, custody, and management of their child does not evaporate simply because they have not been model parents or have lost [at least] temporary custody of their child to the State. Even when blood relationships are strained, parents retain a vital interest in preventing the irretrievable destruction of their family life. If anything, persons faced with forced dissolution of their parental rights have a more critical need for procedural protections than do those resisting state intervention into ongoing family affairs. When the State moves to destroy weakened familial bonds, it must provide the parents with fundamentally fair procedures.

Stanley v. Kramer, 455 U.S. 745, 753-754 (1982). See generally U.S. Const. amend. IX ("The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people."); U.S. Const. amend. XIV, § 1 ("... No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States"); Ga. Const. Art. 1, § 1, XXIX ("The enumeration of rights herein contained as part of this Constitution shall not be construed to deny to the people any inherent rights which they may have hitherto enjoyed.").

[W]hen [in the absence of compelling circumstances necessary to substitute its own preferences for the parent’s decision] state actors engage in this sort of Orwellian policymaking disguised as judging, is it any wonder that so many citizens feel as if the government does not speak for them or respect the private realm of family life.

In sum, I take this opportunity, yet again, to remind our trial courts that, in making any decision or taking any action that interferes with a parent-child relationship, our state statutes are subordinate to and must be construed in light of the fundamental rights recognized by the federal and Georgia constitutions []. As this Court has rightly recognized, “[t]he constitutional right of familial relations is not provided by government; it preexists government.” Indeed, this “cherished and sacrosanct right is not a gift from the

sovereign; it is our natural birthright. Fixed. Innate. Unalienable." Thus, regardless of a court's personal feelings or perception of a parent's fitness to care for or retain custody of his or her child, careful consideration of these bedrock constitutional principles and safeguards must remain central to each case without exception. And when this fails to occur, we will not hesitate to remind our trial courts of the solemn obligation they have to safeguard the parental rights of all Georgians.

Borgers v. Borgers, 347 Ga. App. 640, 820 S.E.2d 474, 482 (2018)(citations omitted)(CJ Dillard, specially concurring).

Nothing could be more "Orwellian policymaking disguised as judging" *Id.* at 482, than parents being adjudicated by nonelected or appointed administrative executive branch employees at the lowest level of child "welfare" services and by law enforcement, followed by state court juvenile court or state court hearings and trials at which constitutional rights are trampled, threats of removal of children coerce parents into "agreements" that are far from voluntary, and appellate relief at the state level is denied. The *Rooker-Feldman* doctrine should not stop lower federal courts from exercising appellate jurisdiction over state judgments where the state judgment neither awarded nor denied damages, as is always the situation presented in state court actions wherein the rights of parents and their children are at issue.

ParentsUSA presents the decision of the Supreme Court of Hawaii in *John Doe and Jane Doe*,

Petitioners-Appellants, v. John DOE and Jane Doe, Respondents-Appellees, 172 P.3d 1067 (Hi. 2007), as the most highly reasoned and thorough analysis of *Troxel v. Granville*, 530 U.S. 57 (2000) as part of that court's consideration of the constitutionality of HRS §571-46.3, Hawaii's grandparent visitation statute. The Hawaii Supreme Court discusses *each and every* opinion, the plurality opinion of Justice O'Connor joined by Chief Justice Rehnquist, Justice Ginsburg, and Justice Breyer, separate concurring opinions by Justice Souter and Justice Thomas, and separate dissenting opinions by Justice Stevens, Justice Scalia, and Justice Kennedy. ParentsUSA would do a disservice to this Honorable Court to convey the discussion and application of *Troxel* by the Hawaii Supreme Court. 172 P.3d at 1071-1075.

Only by this Court granting the *Petition for Writ of Certiorari* can the disparate opinions of the Circuit Courts of Appeal be reconciled and made consistent. The people deserve due process to include access to federal appellate jurisdiction without the artificial and not substantive roadblock of the *Rooker-Feldman* doctrine and, while doing so, *Troxel v. Granville* would benefit from a revisit.

C. With apologies to this Honorable Court, the horrific headline, only days ago, is only intended to convey that very bad things happen to parents and their children. No judgment is being made as to whether the police acted inappropriately, only that events such as this do happen. Perhaps the family will be pursued by child welfare services for failing to protect the child, perhaps other children of the surviving father will be taken into child welfare custody, for their *purported* safety. The range of actions law

enforcement and child welfare services can take is wide and parents often are without the knowledge, means, and strength to push back. When these matters go to state court or administrative hearings, appeals to higher state court are regularly denied. Occasionally, maybe more than occasionally, federal court appellate jurisdiction should be available to review meritorious claims of denial of due process and denial of other constitutional rights.

Just how pervasive is corruption or criminally negligent conduct by state actors? Certainly, aggrieved parents with adverse outcomes will readily contend corruption or criminal negligence was why their children were removed from their care and placed in foster care or their parental rights were terminated.

“Where there is smoke, there is fire.”

The roots of this phrase date back to ancient times, with its first recorded use dating all the way back to 43 B.C. That's over 2,000 years ago! But it truly gained popularity in the 16th century, and since then, it's become a common saying in the English language. Smoke, being the cloudy gray or black mixture of air and carbon that comes from something when it's burning, is most often directly related to fire that it's a natural assumption that if you see one the other is present.

In the literal sense, it's true that where there's fire, you'll likely see smoke. But when we use this phrase in everyday conversations, we're not talking about

actual smoke or actual flames. It's a metaphorical phrase. It's a way of saying that if there's any suspicion or evidence of something, there's a good chance it's true.

There are reports and studies that make the likelihood of "fire" a near certainty. See Appendix A, restated and incorporated herein by reference. The likelihood of "fire" appears nearly certain also based on the volume of Facebook pages and Facebook groups focused on corruption (allegedly) by child protective services (by whatever name), law enforcement, and family courts. There is a good chance many of the assertions by these parents are true and they should not be dismissed out of hand (as Petitioner and other parents allege state trial courts and appellate courts do). See Appendix B and Appendix C, restated and incorporated herein by reference.

When parents become litigants in state courts and do not obtain relief and appeals to state appellate courts fail to reverse, when the fundamental constitutional rights of parents are at issue, denying these parents access to our federal courts is the denial of due process. Indeed, each parent who goes to court with allegations of “intentional differential treatment without a rational basis” can be viewed as a “class of one” entitled to assert such a cause of action. *Willowbrook v. Olech*, 120 S.Ct. 1073, 1074, 528 U.S. 562, 564 (2000).

Based on the anecdotal evidence as provided within Appendix A, Appendix B, and Appendix C, incorporated herein by reference, the cases that are adjudicated at the state court level and affirmed on appeal and for which aggrieved parents desire to avail themselves of federal court appellate jurisdiction are likely to be a combination of intentional differential treatment without a rational basis and “vindictive action,” “illegitimate animus,” or “ill will” sufficient to transform such actions by aggrieved parents seeking relief into cases of constitutional rights under the Equal Protection Clause (in addition to cases of constitutional rights of parents). 120 S.Ct. at 1075, 528 U.S. at 565-566 (Justice Breyer, concurring in the result) *citing Esmail v. Macrane*, 53 F.3d 176 (CA7 1995) and *Willowbrook v. Olech*, 160 F.3d 386, 388 (CA7 1998).

CONCLUSION

For the foregoing reasons, *Amicus ParentsUSA* respectfully requests that this Court grant Petitioner’s *Petition for Writ of Certiorari*.

We examined groups by sociodemographic variables and the association with current smoking, obesity, and self-rated health.

Results Among adult respondents, 46% reported at least 1 childhood adversity. Reports of both household dysfunction and abuse were significantly lower for college graduates than for people with less education. For those with both abuse and household dysfunction, the odds of current smoking were 1.9 and for obesity were 1.3. Compared to people without childhood adversities, people who experienced childhood adversities more frequently reported having fair or poor general health status.

Conclusion Childhood adversities are common among Texas adults. People with childhood adversities are more likely to be socioeconomically disadvantaged, less educated, and have difficulties maintaining employment in adulthood compared to people with no adversities. Moreover, childhood adversities appear to be associated with health problems such as current smoking, obesity, and poor or fair general health among Texas adults.

Annotation

This guide presents a framework for system-level and cross-system strategic planning and implementation processes that support and facilitate trauma-informed systems change that will enable child-serving agencies and their partners to provide a multifaceted, multidisciplinary battery of evidence-based services for children and youth who have suffered trauma underlying their problem behaviors.

Abstract

In 2010, the federal Office of Juvenile Justice and Delinquency Prevention (OJJDP) supported the first federally sponsored efforts to bring together child-serving system partners to develop strategic plans designed to serve youth and families at risk for or impacted by violence and other adverse childhood experiences. Starting as a series of city, county, and Tribal demonstration projects and later as state-level

initiatives, these awards provided training and technical assistance to senior policymakers and other partners during their strategic planning and implementation periods.

Figure 2. Retraumatizing Practices across Service Systems

Service systems designed to help people who have experienced trauma can sometimes **re-traumatize** the people they serve. This results from recreating situations or experiences that mirror or replicate past trauma, causing survivors to experience a similar level of distress in the present (e.g., situations that leave people feeling helpless, vulnerable, and out of control).

Potentially retraumatizing practices in child-serving systems include:


- Use of force and coercion
- Harsh, punitive discipline practices
- Seclusion and restraint
- Rigid rules
- Lack of privacy and confidentiality
- Unsafe environments
- Being talked at or talked down to
- Abuse by staff at facilities
- Witnessing abuse towards others in the service environment
- Feeling trapped
- Using confusing language and terminology
- Disrespectful language and tone towards youth and families
- Policies and procedures that shame, devalue, disrespect, and otherwise disempower youth and families
- Youth and families having limited voice in decision-making about care
- Inadequate treatment interventions that do not address trauma-related needs
- Issues of bias, discrimination, and related disparities and disproportionality across systems

(Goldsmith, Martin, & Smith, 2014; Harris & Fallot, 2001; Jennings, n.d.; Prescott, Soares, Konnath, & Bassuk, 2008)

The current guide summarizes what was learned during their engagements with the most recent cohort of state-level teams. The envisioned multi-system trauma-informed collaborative (MSTIC) has the following four goals: 1) To increase the capacity of state child-serving systems to collaborate in identifying, screening, assessing, and treating youth exposed to violence; 2) To apply culturally competent, family-focused approaches and increase knowledge of evidence-

based policies, practices, and programs to improve service provision; 3) To improve the ability of state systems in identifying, implementing, and monitoring impacts of effective trauma-informed strategies to improve outcomes; and 4) To improve the capacity of systems to blend funding streams to sustain implementation of evidence-based, trauma-informed practices. The current guide offers a framework for achieving these goals. It promotes a staged process for launching a multi-system trauma-informed collaborative and support for the adoption of a cross-sector trauma-informed approach. 5 figures, 74 references, and appended action plans and samples.

Advance System and Cross-System Policies and Practices Through Legislative Action

A top priority for advocates should be to formulate recommendations for and evaluate the effects of

specific federal, state, and local legislation, regulations, and related actions to address ACEs and trauma. Advancing change will require educating legislators about ACEs, opportunities for funding, and relevant policy changes to prevent ACEs and mitigate their effects.

At the federal level, advocates and legislators should partner in efforts to formulate policy platforms, such as the Trauma-Informed Care for Children and Families Act (2017)—the first comprehensive piece of legislation introduced in Congress seeking to infuse brain science related to ACEs and child and youth health into government policies and programs. At the state and local level, they should advocate for specific trauma-informed policies in early childhood care and education centers, the child welfare and juvenile justice systems, and health care settings and with first responders. As discussed previously, their efforts should also include creating opportunities for cross-sector collaboration in policy development, advocacy, and implementation as well as funding model pilots and innovative approaches to build evidence and enable scaling of promising programs.

Promote Public Awareness

Public education directed from the highest levels of leadership is paramount. Awareness efforts should focus on a recognition that adverse child experiences and the resulting trauma impacts every community and are not isolated to certain populations. Coordinated education, awareness building, and training for health services providers, funders, parents and

families, and other child-serving sectors should establish a common language and personalized understanding about the science of ACEs and thriving as well as strategies for prevention and healing. In doing so, awareness should frame the work on ACEs and childhood trauma in a way that is uplifting and hopeful rather than fatalistic. In developing advocacy efforts, it will be important to ensure grassroots support. Campaigns from government institutions may be met with mistrust in some communities; thus, it will be essential to partner with local groups and actors to build trust and inspire change from within communities. Trauma-informed care initiatives in several states, including Wisconsin's *Foster Futures*, Tennessee's *Building Strong Brains (BSB)*, and Oregon's *Trauma Informed Oregon (TIO)*, as well as several city-based collaboratives in Kansas City, Philadelphia, and Walla Walla, have all included public awareness efforts that can provide guidance in this respect to other jurisdictions. <https://www.chapinhall.org/wp-content/uploads/PDF/Multi-System-Trauma-Informed-Care-MSTIC-Guide.pdf>

However, an appellate judge may order the case to be sent back to the trial court to be heard again from scratch in a plenary trial. in reference to a legislative session, it refers to being attended or meant to be attended by every member or delegate. Plenary authority refers to the complete power of a governing body. Plenary is also used to denote complete control in other circumstances, as in plenary authority over public funds, as opposed to limited authority over funds that are encumbered as collateral or by a legal claim. The plenary power of the U.S. Congress, or of other sovereign nations, allow them to pass laws, levy taxes, wage wars and hold in custody those who offend against their laws. For example, in immigration law, Congress, under the Plenary Power Doctrine, has the power to make immigration policy free from judicial review. This doctrine was established at the end of the nineteenth century, when the Supreme Court declared that Congress had "plenary power" to regulate immigration, Indian tribes, and newly acquired territories. The doctrine is

based on the concept that immigration is a question of national sovereignty, relating to a nation's right to define its own borders. Courts generally refrain from interfering in immigration matters. To date there have been no successful challenges to federal legislation that refuses admission to classes of non-citizens or removes resident aliens."
