Upon consideration of the documents filed by Daniel Scott Robinson (Robinson) on January 2, 2024, and the record, Hawai'i Revised Statutes (HRS) § 602-58 (2016) allows a transfer of an appeal within the jurisdiction of the Intermediate Court of Appeals (ICA) to this court. For this to possibly happen, the appeal must first be filed in the ICA. A record on appeal is then filed in the ICA case following the filing of the notice of appeal.
