

The petitioner asks leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.



MOTION FOR APPEAL

NOW INTO COURT, through undersigned counsel, comes TRE'VEON DEMARCUS ANDERSON, defendant in the above numbered and titled prosecution who files a Motion for Appeal for the following reasons, to-wit

1

On April 20, 2022, after a jury trial, Mr Anderson was found guilty as charged of Second-Degree Murder, in violation of La RS 14 30 1, and Conspiracy to Commit Second Degree Murder, in violation of La RS 14 30 1

2

On May 31, 2022, defendant filed a *Motion for New Trial* and a *Post Judgment Verdict of Acquittal* in open court. Both *Motion's* were denied and as to count one, Second-Degree Murder, defendant was sentenced to life imprisonment at hard labor without the benefit of probation, parole or suspension of sentence. As to count two, Conspiracy to Commit Second Degree Murder, defendant was sentenced to confinement at hard labor for a period of thirty (30) years to run consecutively with any other sentence

Mr Anderson moves the Court to allow him to file an appeal in the matter of State of Louisiana vs Tre'Veon Demarcus Anderson, Docket Number 388277, First Judicial District Court, Caddo Parish, Louisiana

Mr Anderson requests that the Louisiana Appellate Project be appointed to handle said appeal

Mr Anderson further requests that this Court issue an order requiring that the State's Designation of Record be filed, that the court transcripts be made and filed, and that the
