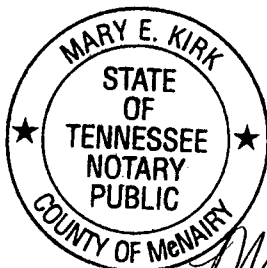

**Hospital Course:**

Per ED H&P, "Rona Adeoye is a 37 yo F with pmh of DM and HTN who presents s/p MVC. Per report patient was found outside of the vehicle, unclear if unrestrained or self extricated. Evaluated at OSH. Given 2L of crystalloid for hypotension. Transferred to VUMC for further evaluation and management. On arrival GCS 11 (2/4/5), airway patent, IV access inadequate. Unable to auscultate initial blood pressure; however, DP pulse intact. Given mechanism and known OSH hypotension 1 unit whole blood ordered. Additional IV access obtained with ultrasound guidance. SBP 90-100 via L forearm. CXR/pelvic xray negative. FAST indeterminate. Secondary survey significant for R humerus deformity. Placed in splint. Patient had an episode of emesis requiring zofran during evaluation in trauma bay. Transferred to CT scan for further evaluation." The patient was admitted to Vanderbilt, resuscitated per the trauma protocol and admitted to the trauma service for further evaluation, consultation, and pain control. A CT traumagram show the above-mentioned injuries.

Due to concern for post-concussive symptoms with somnolence and confusion on admission, SLP was consulted and she has been followed with serial neurological examinations and is stable. The patient's cognitive function was evaluated by the speech pathologist and the patient has improvements in cognitive communicative functions and an improved Rancho Level 7. Her right breast laceration was repaired at the outside hospital and she received local wound care with xeroform and bacitracin. Her manubrial fracture with a small mediastinal hematoma and rib fractures have been managed with aggressive pulmonary toilet and pain control. At present, the patient is stable on room air. She underwent a diagnostic exploratory laparotomy which was negative for a bowel injury but her small peritoneal tear in her diaphragm was repaired. Her grade 2 spleen laceration and liver laceration have been monitored through serial labs and abdominal exams which are stable. The orthopaedic service was consulted for the patient's right humerus fracture. She underwent operative fixation on 3/9/2024. The patient has been educated to follow weight bearing restrictions (NWB RUE). Please refer to the orthopaedic service operative reports for further information. She refused Lovenox for DVT prophylaxis during her hospitalization.

The patient has been advanced to a regular diet and is tolerating it well. Pain is controlled with oral medications. PT/OT evaluated the patient and recommend IPR, unfortunately, Ms. Adeoya does not have health insurance benefits to go to a facility for inpatient rehab or skilled nursing facility in TN, her benefits are GA Medicaid and Ms. Adeoya declined placement in GA because she has not been living in that state for months. The patient will discharge to home today with scripts for OPPT/OT. She was made aware of the medical equipment recommended by our physical therapists and occupational therapists, they have a shower chair at home and we supplied her with a rolling walker. We discussed there will be follow-up requested for a trauma clinic and the orthopedic clinic appointment. Erin (Social Work) supplied her with a free PT/OT clinic option on Friday in Nashville and I recommended bundling appointments due to distance from Vanderbilt along with the free PT/OT. The patient is cleared from a trauma standpoint to discharge today. All follow-up appointments have been requested. Please see medical records for further details of this hospitalization. The CSMD has been reviewed for this patient. I discussed with patient fiance that should she have ongoing pain, there are over-the-counter lidocaine patches that can be helpful for rib fractures as well as tylenol and
