PETITION FOR REHEARING

A motion to recall runs squarely against the policy that judicial decisions, once made, are final. Allowing repeated challenges to the decisions of a court erodes faith in the judicial system. Finally, allowing repeated hearings of the same dispute wastes judicial resources. To say that courts exist to resolve disputes tells only half the story, for courts exist to resolve disputes correctly. Denying relief to meritorious litigants is unfair, especially when the denial stems from a court-made policy of finality rather than from substantive law. Allowing manifestly unjust results to stand uncorrected also erodes public faith in the judicial process.

Petitioner Forrest Hammond respectfully petitions for rehearing of this Court's October 4, 2024, Order denying his petition for a writ of certiorari.

REASONS FOR GRANTING REHEARING

Rule 44.2 authorizes a petition for rehearing based on intervening circumstances of a substantial . . . effect, to wit, in this case a fraud committed on the court; the denial of judicial review; and the suspension of habeas corpus after federal jurisdiction is attached.

From its earliest days, the United States has been a nation of faith. During the War of 1812, as the morning light revealed that the battle torn American flag still flew above Fort McHenry, Francis Scott Key penned, "And this be our motto: 'In God is our trust!' This Court ruled that placing "In God is our trust" on currency did not constitute an establishment of religion, nor did it favor any particular religion, nor did it either encourage or suppress religious belief.

The following is a more comprehensive elucidation of this case that discloses the sovereign rule of Yahweh in the kingdom of men. Whether it is believed or not,

it is so anyhow. Petitioner is physically and spiritually free because of One man, to wit: Dr. Henry Clifford Kinley.

Dr. Henry Clifford Kinley is the author the book "ELOHIM The ARCHETYPE (original) PATTERN of the UNIVERSE" copyrighted 1961 and 1969 – INSTITUTE OF DIVINE METAPHYSICAL RESEARCH, written and composed of four volumes, entitled:

1. ELOHIM THE ARCHETYPE (ORIGINAL) PATTERN OF THE UNIVERSE
2. THE PROPHETIC BIRTH AND MISSION OF JOHN THE BAPTIS AND YAHSHUA THE MESSIAH
3. WHOSE BUILDER AND MAKER IS ELOHIM
4. THE MYSTERY OF YAHWEH, THE MYSTERY OF INIQUITY, AND THE MARK OF THE BEAST – Revelation 10:7, Ephesians 3:3-5, Revelation 17:5, 2 Thessalonians 2:7.

The sum total of these written volumes, expresses Dr. Kinley's true revealed "UNDERSTANDING" of Yahweh-Elohim and the Creation as it is recorded in the Holy Bible, and in reference to Yahshua the Messiah, the true "SON OF YAHWEH," and Satan, or the Anti-Messiah, the true 'SON OF PERDITION.' Yet, this understanding is not of his own private and independently conceived imagination.

On June 6, 1931, at 1008 Park Avenue, Springfield, Ohio, at nine o'clock in the morning, Dr. Kinley was caused to behold a great stupendous Divine Panoramic Vision, and on the same day he also in turn received the Divine Revelation of Spiritual meaning of the Vision from Yahweh. At first, he sat down with a paper tablet and pencils and attempted to put into writing that which he had seen and heard in the

vision, but very shortly he abandoned his efforts realizing that it was too much of a job for him along to tackle. He did, however, manage to have charts drawn of the vision, being aided by his son, R.P. Kinley, and other enlightened students, and these charts have been of invaluable assistance in the edification of a fairly large number of people. These pictorial illustrations have also put to silence those who would say that Dr. Kinley did not have a vision, for if one examines and understands the simplicity of these charts, he cannot help but come to a profound knowledge of Yahweh and His Purpose and Plan. Furthermore, these charts have been in the Universities, Colleges, Seminaries and virtually all over the world, and there has been no one to date that has been able to refute this work.

It is the simplified Panoramic Vision and Revelation of the Divine Pattern of the Universe, given to Dr. Kinley by Yahweh-Elohim, which he has expounded upon, through charts and writings to his associates which in turn has qualified them to detect, identify, and to prove the existence of Yahweh, and the Satanic Mystery of Iniquity, and to trace the Mark of the Beast from its origin to its final conclusion, the Lake of Fire.

As heretofore stated, the REVELATION of the ARCHETYPAL PATTERN OF THE UNIVERSE embraces the EXISTENCE OF YAHWEH, HIS UNIVERSAL SPIRIT LAW and ETERNAL PURPOSE through the Dispensations and Ages. Comparatively speaking, this is a new Divine, Philosophical, Scientific, Spiritual, Scriptural and Revolutionary "interpretation" of the Holy Bible. It is supported by a definite DIVINE PATTERN and PLAN "descriptively" stipulated in the Scriptures of

the Holy Bible itself (Exodus 25:40; Hebrew 8:5; I Chronicles 28:19; John 2:19-21). This interpretation is discretely confirmed in every polytechnical detailed manner by the UNIVERSAL CREATION OF ELOHIM, both corporeal and incorporeal, visible and invisible (Roman 1:19-20). Moreover, Dr. Kinley firmly BELIEVED that this Vision and Revelation is to be regarded as ONE of the greatest and most astounding of PANORAMIC VISIONS and REVELATIONS ever given to mankind since the CREATION of the material or stellar parts of the Universe.

A profound KNOWLEDGE and UNDERSTANDING of this Divine Panoramic Vision, operating first in the realm of Eternity and thereafter through the Dispensation and Ages, by Universal Spirit Law, ABSOLUTELY ABOLISHES ALL practiced forms and classifications of SUPERSTITITIONS, WILLFUL IGNORANCE, SATANIC (or false) DOCTRINES or ERRONEOUS RELIGIOUS CONCEPTS, man-made traditions and customs, so-called Atheism, Agnosticism, Skepticism, Witchcraft and Idolatry and all types of previously established, fulfilled and abolished carnal ordinances which were under the Old Covenant with Israel. Further, this teaching INVESTIGATES the cosmographical structure of the Universe and the unexplained so-called Law of Nature, which in REALITY, is Universal Spirit Law, the power latent in man, and teaches mankind of his INSEPARABLE relationship with Yahweh-Elohim and to have implicit “FAITH” in Yahweh-Elohim and worship Him in SPIRIT and in TRUTH (John 4:24, KJV); as Yahweh-Elohim had originally intended, according to His Eternal Purpose (Ephesians 1:9-12, KJV).

There is no one that is going to Heaven or Hell in a physical body, as flesh and blood does not inherit the Kingdom of Yahweh (I Corinthians 15:50). As of now, we are supposed to have Yahshua the Messiah who is a Quickening Eternal Spirit abiding in these mortal bodies and it is His Eternal Spirit that will change our vile, physical body into a glorious Spiritual body as Yahshua the Messiah who only at this time has an Immortal Spiritual Body (Philippians 3:20-21; I Timothy 6:16). Even those who have passed on have not obtained this glorious body, but are waiting for that moment when they shall be changed right along with us (Revelation 6:9; Hebrews 11:39-40).

One more thing needs to be understood and that is that Yahweh is mercifully saving a few more soul right in the closing prophetic moments of this age – not a great number, but a remnant, and we have seen this manifested as new souls are being added unto the Spiritual Body or Congregation of Yahshua the Messiah everyday.

Since it is Yahweh who is saving these souls through His Son, Yahshua the Messiah, He is opening up their understanding right now, and it does not take them a long time to comprehend the Truth as it did some of us older ones. Nevertheless, whether we come to an understanding over night or over a long period of time, all praises and glory and honor belong to our Heavenly Father, Yahweh, for his blessings.

It cannot be reiterated too strongly how vitally important it is for one, the reader, and the writer, to KNOW and REALIZE what the SCRIPTURES ARE. The Scriptures are (excusing mistranslations and interpolations) the ORIGINAL INSPIRED WRITINGS, written by Moses and the Prophets by the Power of the Paternal Yahweh-Elohim to manifest Himself, THE CREATION and HIS PURPOSE, through VISIONS and REVELATIONS (see illustration of the Vision) before the Virgin birth of Yahshua the Messiah. Moses and the Prophet told what they SAW and HEARD Elohim SAY and DO in their Visions by means of writings; these divinely inspired writing are called THE SCRIPTURES (JOHN 5:39). Six months after Petitioner's release, he attended his first class at a new branch of the Institute of Divine Metaphysical Research in Baton Rouge, Louisiana on July 30, 1980, just after coming within one fight of qualifying for the 1980 summer Olympic Boxing Games. President Jimmy Carter boycotted the United States' participation in the Russian Olympic games because of the Soviet invasion of Afghanistan. However, in 2008, Dr. Kinley, Yahweh, that Eternal Spirit Being, told Petitioner he should write a book. That book was published in May – 2012, by Pelican Publishing Company, Gretna, Louisiana. The book details how Petitioner got in trouble; how he went to prison; how he got out of prison; and how he got out of trouble despite being charged with a high-profile black on white murder case in the Deep-South. During the administration of justice, the Petitioner suffered brutal attacks and assaults from white sheriff deputies and set-up to look like a "Rat" to be killed in the parish prison by thugs. He was hospitalized with multiple stab wounds, contusions, and concussions. Petitioner incompetent to go to trial or enter a plea after recently having stitches removed from all over his body. He was denied a jury trial. He was sentenced to life in prison without the trial judge calling upon him to enter a plea. Petitioner never entered a *PLEA OF GUILTY* and placed on Death-Row by a Louisiana Natural Life Imprisonment Sentence imposed on October 15, 1973. He was committed on November 8, 1973 to the largest and bloodiest prison in the United States of America – Louisiana State Penitentiary at Angola, Louisiana, a place named after Angola Africa, the country that Louisiana's African

Slaves were captured in originally and brought to America from during the 1500 AD thru 1800 AD Transatlantic Slave Trade.

Regret: A regret is when you wish you had not done something and you can't go back and change what you did. You feel bad in your Soul; a feeling of sadness or disappointment. You feel sorry because you have caused or loss something dear and valuable that's been taken away. You don't have it any more. You can't go back and change what you did that caused you to lose it. Something you have done, or not done, and you cannot change the outcome, and you wish you had never done what you have did, but now it is too late to change your mind because you have already committed the act, and now you have to live with the consequences of Your decision that You made and continue in the Mental, Psychological, or Spiritual State You are in for Eternity because you opposed and was disobedient to the still small voice speaking in your conscience. You refuse to let your conscience be your guide and choose to ignore the voice and remain ignorant and suffer regret.

YAHWEH is not a *Fantastic Tale of Ideology* and speaks in a still small voice.

There is a Reality that all Human Beings have in common. Every time Human Beings fail to OBEY the categorical command heard in their conscience, they suffer a regret that ranges from Mild to Severe. The most common universal human

response to that situation is to utter the expression "Dog-Gone-It! SOMETHING TOLD ME NOT TO DO THAT!"

Failure to obey what is commanded of You is due to You believing You are "thinking," not realizing the still-small-VOICE You hear in Your conscience originates and generated from the realm of Eternity and is received by You abiding in a measured span of TIME that is existing within Eternity. This is not a fantastic tale of ideology. *Yahweh speaks in a still small voice.*

Taken into consideration that Petitioner and his father were honest, truthful and cooperative with Baton Rouge Police Detectives investigating the murder/attempt armed robbery of Middleton Drugstore. The detectives swore to God to tell the truth, but got on the witness stand and told multiple lies under oath during a motion to suppress hearing testifying they never promised petitioner or his father that his son would still be able to graduate high school and go to college on a Southern Illinois University athletic scholarship if the 17-year old senior gave a recorded statement.

Yahweh, according to his Divine Purpose, stepped in and intervened. He caused Petitioner to treat Angola Penitentiary as a dangerous college campus and delivered him out of the mouth of the great Louisiana Lion allowing him to only spend five years and three months in "Angola Penitentiary." While there, Yahweh navigated Petitioner to obtained his high school GED Diploma on October 11, 1976, and then transferred him to the Louisiana Governor's Mansion on February 16,

In the movie "Gladiator," Maximus (played by Russell Crowe) says to his Roman soldiers before battle, "*Brothers, what we do in life, echoes in eternity.*" That statement signifies our actions in the physical life we live will have lasting consequences. The statement conveys a sense of purpose and importance to their actions, suggesting that their acts and deeds will have a lasting impact *beyond* their physical lives. This line is directly inspired by the writings of Roman Emperor Marcus Aurelius, who often reflected on the idea of living a meaningful life with an awareness of one's mortality.

Yahweh-Elohim's Anthropomorphic Spirit-Embodiment is Spirit Law and the Vision that just actually *got-in* Dr. Henry Clifford Kinley on June 6, 1931. Moses describes this Spirit-Embodiment at Exodus 24:9-10. The Spirit Law is what was made flesh first as the first man Adam (see 1st Corinthians 15:45-48 & Romans 5:14), then the two tables of stone on which the "Ten Commandment Law" was written on with the finger of Elohim at Exodus 31:18. Thirdly, when Yahshua the Messiah was manifested through the loins of the virgin Mary (See John 1:1-5, 10th & 14th verses). The so-called "Ten Commandment Law" was the physical representation of Spirit Law or Yahweh-Elohim. 8, as Yahshua, also called Emmanuel⁴ fulfilling the principle that “God” or Elohim manifested in the flesh as he did as Adam and walked the earth plane in the physical bodies of the Old Testament Prophets. See the book of Joshua 24th Chapter, verses 1 thru 6. The declarations of being ‘God made flesh’ caused Emmanuel (erroneously called Jesus Christ) to be crucified due to the ignorance of mankind at that time and to date. There is no alphabet in the Hebrew language that makes the sound of the English letter “J.” All the Biblical names that are spelled with the letter “J” are false. Etymological research proves that they all originally began to be spelled and pronounced with the sound made by the letter “Y.” Yahshua is the correct name the Angel Gabriel delivered to Mary to call the Son.

The Pledge of Allegiance¹ that Petitioner was taught at Zion City Elementary School in 1961 includes the phrase "**One Nation under God**², **indivisible, with liberty and justice for all.**" Petitioner realizes that the values of the American conscience has been reduced so that his grandchildren today can turn on the TV at home and see **two grown men tongue-kissing**. In Malachi, Chapter 3, verse 6, it reads "For I am Yahweh, I change not; therefore ye sons of Jacob are not consumed."

Therefore, the law clerk screening this case needs to take another look and follow his or her conscience. Petitioner has presented all of the necessary specific, relevant, pertinent, and applicable case facts and law that there is, to the Court. There is nothing left but for Petitioner to preach to the Court. Maybe the Supreme Court will hear the Word of Yahweh. Yahweh is not a fantastic tale of ideology.
