ORDER

Before: FERNANDEZ, NGUYEN, and OWENS, Circuit Judges.

The district court dismissed this action as frivolous and revoked appellant's in forma pauperis status. *See* 28 U.S.C. § 1915(e). On August 1, 2023, this court ordered appellant to explain in writing why this appeal should not be dismissed as frivolous. *See* 28 U.S.C. § 1915(e)(2) (court shall dismiss case at any time, if court determines it is frivolous or malicious).

Upon a review of the record and the response to the court's August 1, 2023 order, we conclude that this appeal is frivolous. We therefore deny appellant's motions to proceed in forma pauperis (Docket Entry Nos. 2 and 4) and dismiss this appeal as frivolous, pursuant to 28 U.S.C. § 1915(e)(2).

No further filings will be entertained in this closed case.

**PROCEEDINGS (IN CHAMBERS): ORDER REVOKING IFP STATUS**

On its own motion, the Court **VACATES** its order granting Plaintiff's IFP status (Dkt. 4) and **REVOKE**s Plaintiff's IFP status. Plaintiff's Complaint seeks, among other things, a claim for religious discrimination because "some passengers in Greyhound Station did not believe in God." Complaint (Dkt. 1) at 13. Plaintiff does not state colorable claims for constitutional violations. Accordingly, the Court **DISMISSES WITHOUT PREJUDICE** this action as frivolous, pursuant to 28 U.S.C. § 1915(e).
