



ORDER

Before **HOLMES**, Chief Circuit Judge.

Attorney Ariel K. Taylor has filed a motion to withdraw as appointed counsel for Appellant Jason Dittmer. The motion to withdraw is GRANTED.

The district court has made the requisite finding of eligibility for appointment of counsel pursuant to 18 U.S.C. § 3006A, and the Office of the Federal Public Defender for the Districts of Colorado and Wyoming¹ (“Colorado FPD”) is appointed as counsel for Appellant Dittmer. Pursuant to § 3006A, Mr. Taylor is appointed *nunc pro tunc* to the date the notice of appeal was filed, and that appointment ends with the entry of this appointment order.

Within ten days from the date of this order, Mr. Taylor shall transmit to the Colorado FPD copies of all documents in his possession that are pertinent to this appeal and not otherwise available via PACER and/or CM/ECF.

Within ten days, the Colorado FPD shall file an entry of appearance in this appeal.

Within 20 days, the Colorado FPD shall file a designation of record and a transcript order form or notice that no transcript is necessary in the U.S. District Court for the District of Utah, with copies filed in this court. Thereafter, the district court clerk will prepare the record on appeal and transmit it to this court for filing.

Appellant's opening brief shall be due 40 days from the date the record on appeal is filed in this court. *See* Fed. R. App. P. 31(a)(1); 10th Cir. R. 11.2(A).

The Clerk's Office shall transmit a copy of this order to the district court clerk. Mr. Taylor shall transmit a copy of this order to Appellant Dittmer forthwith.
